

Resolution No. 141 -2020

A RESOLUTION by the Board of County Commissioners of Kitsap County, Washington, approving the spending plan for the Kitsap County Stadium Fund (Hotel/Motel taxes) for the year 2020.

WHEREAS, Kitsap County Ordinance 70-A-1998 (the ordinance) authorizes a 4.0% Lodging Tax to be levied upon the sale of or charge made for the furnishing of lodging within the boundaries of Kitsap County; and

WHEREAS, the ordinance provides for important support for tourism and the performing arts within Kitsap County; and

WHEREAS, the Lodging Tax Advisory Committee met on August 27, 2020 and has made its recommendations to the Board of Commissioners.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Kitsap County, Washington, that the 2020 proceeds from the collection of the lodging tax be distributed as follows:
