**Agenda Item Title:** Contract KC-134-20, Amendment B between Kitsap County, as the Administrative Entity for the Salish Behavioral Health Administrative Services Organization, and Olympic Community Action Programs, to extend the end date for HARPS SABG support funding and replace attachments.

**Recommended Action:** Move that the Board execute Contract KC-134-20, Amendment B with Olympic Community Action Programs.

### **Summary:**

This subcontract amendment with Olympic Community Action Programs (OlyCAP) extends the end date for HARPS SABG support funds to residents of Jefferson County who meet qualifications for HARPS as described in the statements of work. The contract term remains January 1, 2020 – June 30, 2021.

- Contract Amount remains unchanged at \$103,043.
- Contract end date is unchanged at January 1, 2020 to June 30, 2021.
  - Contract period for HARPS SABG support fund end date is extended from September 30, 2020 to June 30, 2021.
- Attachment B-5: SABG Support Funding is deleted and replaced as attached.
- Attachment C: Budget is deleted entirely and replaced as attached.

Funds are provided for Housing and Recovery through Peer Supports (HARPS). HARPS is a housing support program providing support services to assist with accessing and maintaining safe and supportive housing. The services are targeted toward individuals who have recently been inpatient or at risk of inpatient for mental health or substance use treatment. HARPS offer supportive services, as well as financial subsidies, to assist with access to/maintenance of housing for individuals in Jefferson, Clallam, and Kitsap Counties.

Kitsap County is the administrative entity for the SBHASO, which contracts with HCA to provide public behavioral health services in Kitsap, Jefferson, and Clallam Counties. The state and block grant funding in this contract is prioritized to pay for crisis services, inpatient services and residential services. Funds that remain after those priorities are met are to be used to provide outpatient services to the non-Medicaid population.

# CONTRACT AMENDMENT B

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBH-ASO", and Olympic Community Action Programs hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-134-20, executed on March 2, 2020, and amended on August 10, 2020, shall be amended as follows:

- Page 1 shall be amended as follows:
  - Contract Amount remains the same at \$103,043.
  - Contract end date for SABG support funding is extended from July 1, 2020 to June 30, 2021. New contract period for SABG support funding is July 1, 2020 to June 30, 2021.
  - Attachment B-5: HARPS SABG Statement of Work is deleted and replaced as attached.
  - 1. **Attachment C: Budget** is deleted entirely and replaced as attached.

### SABG Support Funds

7/1/20-6/30/21 funding remains the same at \$2,500

2. If this Contract Amendment extends the expiration date of the Contract, then the Contractor shall provide an updated certificate of insurance evidencing that any required insurance coverages are in effect through the new contract expiration date. The Contractor shall submit the certificate of insurance to:

Upon receipt, the Human Services Department will ensure submission of all insurance documentation to the Risk Management Division, Kitsap County Department of Administrative Services.

 Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect. This amendment shall be effective July 1, 2020.

# SOW Services for HARPS Substance Abuse Block Grant

### Revised March 3, 2021

1. Statement of Work. The Contractor must provide recovery supports to individuals who meet HARPS eligibility and have a substance use disorder. Recovery supports are provided to support access to treatment services. Contractors will consider priority populations listed in 2 below. Recovery supports will be provided as listed in items 3 and 4 below.

# 2. HARPS Priority Populations

- a. Pregnant women and women with dependent children
- b. Intravenous drug users
- c. Tuberculosis services
- d. Early intervention services for HIV/AIDS
- e. Primary prevention services

### 3. Basic Needs

- a. Food gift cards in small amounts for use before/after treatment appointments or prevention activities
- b. Minutes on phones if being used for telehealth appointments related to treatment or prevention activities

### 4. Transportation

- a. Bus Passes, Ferry Passes, Light Rail Passes, ORCA Cards in order to attend treatment or prevention activities
- b. Gas voucher small amounts only in order to attend treatment or prevention activities
