- Richard Becker, Veteran Programs Coordinator with Kitsap County Department of Human Services, provided an overview of the programs and services available to veterans in Kitsap County. Richard went into detail on each of the major activities supported by the Veterans Advisory Board. These Include:

 - Unforgotten Run to Tahoma
 - Spring and Fall Stand Downs
 - Veterans Garden
 - Operation Green Light

Richard also provided information on a pilot project to host a Veteran's Resource Center, which is in partnership with Olympic College and co-located with the college Military and Veteran Programs office. It's a place for all veterans to receive information about their benefits and apply for access to the Veterans Assistance Fund. Eviction Prevention and Rent assistance continues to dominate VAF expenditures.

This included several site visits to other community centers in Kitsap County, as well as looking at several vacant buildings in the Silverdale area.
