#### **PUBLIC COMMENT**

• Erin read Joey Chapman's email that he forwarded from Commissioner Gelder regarding Traffic on Augusta:

We collected traffic data on Augusta Avenue south of Geneva Street and south Center Street. We also collected data on Suquamish Way west of Augusta Avenue. The data showed average daily traffic volumes ranging from 5168 to 5262 vehicles with the 85<sup>th</sup> percentile speeds ranging from 29.0 to 30. 2 mph. The percentage of traffic traveling 10 mph or greater over the posted speed limits ranged from 7.8% to 15.4%.

Suquamish Way from Division Street to Augusta Avenue is classified as a minor arterial. Augusta Avenue is also classified as a minor arterial. The use of speed humps on these roads would not be supported by the current Kitsap County Road Standards Chapter 9 – Neighborhood Traffic Calming Program due to their classifications, the percentage of vehicles traveling 10 mph over the posted speed limits, and their reported traffic volumes. As you know, there currently are two speed radar signs; one on Suquamish Way west of Division Street and on Augusta Avenue south of James Street to remind motorists entering town of the reduction in the posted speeds. In addition there are 20 MPH pavement markings on Augusta Avenue in the core downtown area in both directions.

As we get closer to designing the projects in Suquamish noted previously, we'll be able to do more outreach to the community via the Suquamish Community Advisory Council.

- Brynn shared that Commissioner Gelder is aware of the increased traffic around the schools; the issue should be revisited this fall during the TIP period.
- Ace recently spoke to the fire department about traffic-calming devices and the impact they can have on firefighting equipment.
- Ed inquired about having Public Works come to a SCAC Meeting to share information about the stormwater project as it is going to have a significant impact to the community. Brynn said that plans are in the works.
- Ace asked that since there is no longer a media blotter published in the newspaper how can the community be in the know? Could Kitsap County Sheriff and Suquamish PD be on a future meeting agenda?
- Kurt is also interested in knowing more about the status of MOU with the County/Suquamish Police Department.

The meeting adjourned at 7:58 p.m. The next meeting is on April 6, 2023.
