Nick Martin, Senior Maintenance & Operations Manager for Kitsap Public Works, spoke on the \$300,000,000 that will be needed over the next 6 years for sewer infrastructure. Much of this will go toward upgrading the Central Kitsap Treatment Plant, where sewage and septic waste is treated. This will necessitate a rate increase.
