To improve quality of life by preserving natural habitats in the Miller Bay watershed


# Our Goals

**Stewardship:** promote "active" environmental stewardship within our community.

**Preservation:** target properties for preservation and restoration. Assist in acquisitions.

Outreach: inspire a conservation ethic through information, education and opportunities for engagement.

**Collaboration:** foster a network of community organizations supporting conservation efforts.



# Our History

**1989** Miller Bay Citizens Action Group founded, and successfully protects "Rural Residential" zoning.

**1994 – 97** MBCAG supports Indianola Land Trust, 81 acres of forest & wetlands protected.

**2001** MBCAG changes its name to **Friends of Miller Bay** (FOMB).

**2002 – 07** FOMB raises \$273,000 to buy 18 aces creating the Cowling Creek Forest Preserve.

**2019** FOMB partners with Great Peninsula Conservancy to raise \$150,000 to buy 13 acres creating Miller Bay Preserve.

**2023** FOMB partners with GPC raising \$160,000 to protect Forest Above the Bay.

2024 FOMB becomes a 501(c)(3) public charity.

**2021 – 25** FOMB raises \$22,700 and works with Puget Sound Restoration Fund to restore native Olympia Oysters to Miller Bay.

2025 FOMB spearheads a DNR Trust Land Transfer proposal to protect 40 acres of forest.

#### **Trust Land Transfer**

Is a program designed to transfer lands that provide important ecological values or public benefits but don't produce enough revenue to support schools and critical local services. DNR transfers these lands to public agencies for conservation or recreation purposes.

#### Criteria:

- Community support
- Ecological value
- Economic value
- Public benefit
- Tribal support

#### Critical dates:

Sept 22, 2025 - Community Letters of Support to FOMB

Sept 30, 2025 - Application April 1, 2026 - Final Letters

Summer 2026 - DNR Review

Spring 2027 – Prioritization

Winter 2027 - Transfer

#### Why now?


- Scheduled for timber sale in 2029
- Protect from future development
- Expand Miller Bay Preserve to 56+ acres



# **Help Preserve 40 Acres!**

Department of Natural Resources Trust Land Transfer Proposal

Located near the corner of Miller Bay and Gunderson Roads, this parcel borders the 13-acre Miller Bay Preserve and 3.5-acre Kawahara Preserve, both owned and managed by GPC. This upland forest (approx. 50 years old) has two creeks that drain into Miller Bay, and is an important wildlife corridor for deer, black bear, coyote, and river otter making their way to 1,575 feet of protected shoreline on Miller Bay.



#### Preservation Benefits:

- Connects diverse habitats
- Protects wildlife corridor
- Saves a year-round fish bearing creek
- Protects creek channels untouched by past logging
- Provides critical habitat for chinook and steelhead


