Organization Reports:

- Kiwanis (Malin): we are hosting a Halloween Carnival at the Village Green Community Center on Oct. 31st 5-7pm. Dana Goodfellow is coordinating the event.
- Rotary Club (Gilbreath): is gathering food and funds for local food banks out of the Firehouse Theater in partnership with Sharenet. Plans to have "Order Bomb" every other week to support local restaurants.
- Port of Kingston (Heacock): there is a study underway looking at future development. We have a permit application into Kitsap County for a zoning change.

- Transportation Committee (Wolotira): The big issue the Committee is dealing with right now is the ferry worker shortage and the resulting cancelled sailings. - White Horse Neighborhood (Hutchinson): has a tremendous amount of deforestation going on with the Arborwood development.
- Gamblewood Neighborhood (Berglund): Cougar sightings have been happening. Suggests we spread the word to be both cougar and bear aware in the region. Initial Public Comments:

- Joe Lubischer: Started to make a statement about the NKHP STO issue. Beth asked him to hold that comment for the New Business agenda item.
- Nick Laurion: There have been sexual assault accusations in the NKSD schools and there have been walkouts in protest of the perceived lack of response from the leadership.

Special Orders & Unfinished Business:

- Proposal to amend the name of KCAC from Kingston Citizens Advisory Council to Kingston Community Advisory Council to be more inclusive. *Motion from Beth to Approve the Red Line*

which will be submitted to the Commissioners for approval. Nicholas seconded. All ayes, motion passed.

New Business:

- Waste Management Service Issues. WM stopped picking up recycling every other week and moved to one time a month because of driver shortages. Customers are paying the same for what was 2X a month pickup and now is 1X a month. More transparency would be helpful. Could the County change the county Solid Waste Management Plan (SWMP) so curbside waste service is separate from recycling.

 - Jennifer Haro offered the following context. The curbside service contract with WM is managed by [Washington Utilities and Transportation Commission \(UTC\)](#) not Kitsap County. Recycling does not bring in money since China's Green Fence began. WM is guaranteed a profit by the State under their type of license. If people are allowed to stop their recycling pick-up, WM may not be able to provide curbside recycling to anybody.
 - Beth Berglund suggested people who are concerned about the service issues and the SWMP consider Kitsap Solid Waste Advisory Committee. Unincorporated North District communities have a representative on SWAC. Those Committee meetings are open to the public, held once a month. Link to SWAC:

- Proposed Resolution by KPTOS re: the scope of the Sound-to-Olympics trail study.
 - Commissioner Gelder's office suggested we use a letter format rather than a resolution.
 - Mark Libby: provided a background summary on the feasibility study proposal scope in Kitsap County's RFP. The concern is that the scope was limited to ONLY looking at routes through the park (from West Kingston Road to NKHP).
 - Joe Lubischer: the NKHP Stewardship group supports the letter and supports looking at all the feasible options. He still has process/procedural concerns.

All ayes, motion passed.*
