Opening Items

Meeting called to order: 6:30 p.m.

Land Acknowledgement:

We would like to begin by acknowledging that the land on which we gather is within the ancestral territory of the "People of Clear Salt Water" (Suquamish People). Expert fishermen, canoe builders and basket weavers, the Suquamish live in harmony with the lands and waterways along Washington's Central Salish Sea as they have for thousands of years. Here, the Suquamish live and protect the land and waters of their ancestors for future generations as promised by the Point Elliott Treaty of 1855. "Every part of this soil is sacred in the estimation of my people. Every hillside, every valley, every plain and grove, has been hallowed by some sad or happy event in days long vanished." Chief Seattle 1854.

APPROVAL OF MINUTES:

January 2023 Minutes

Tom motioned to approve the minutes and Carol seconded. The minutes were approved unanimously.

UPDATE ON 2023 WORKPLAN:

- Tom motioned to approve the workplan as discussed in the January 2023 minutes. Laurie seconded. The workplan was approved unanimously. Laurie and Martha will provide the updated (not redlined) document.
- Community Clean-up is confirmed April 22, 2023 9 a.m. to 1 p.m. Meet at the United Church of Christ on Division for supplies and street assignments.
- At an upcoming SCAC meeting, Kitsap Public Utility District will give a
 presentation on a fiber line (they presented earlier to Kingston), and a Widme
 neighbor will share about the experience

RENEW BYLAWS FOR 2023

Brenda requested amending the bylaws to add two extra dedicated seats to be filled by Suguamish Tribe members.

The bylaw discussion is tabled until the next meeting to allow for discussion with Commissioner Gelder.

KITSAP COMPREHENSIVE PLAN - SUQUAMISH SUBAREA PLAN

Subcommittee presentation

Martha and Tom presented the subcommittee's recommended plan

Q&A from the public

• The Shakeris shared their firsthand experience with trying to build an ADU. Went through the process with the county, put in for a permit, seemed like things were going OK. Moved forward with about \$10,000 worth of work, and then was told by the county that is was a non-conforming space and put in

- roadblocks. They suggest taking away roadblocks to make it easier to build ADUs.
- Ed wondered how much the county enforces its requirement fo conditional use permits on vacation rentals (such as those offered through Air BNB, VRBO). Concerned these properties take away long-term rental space.
- There are a lot of beautiful roads here but no place to walk!
- Jennifer Sutton (email comment): "The Suquamish LAMIRD is not a rural area . . . the LAMIRD is surrounded by rural and Tribal lands, but the LAMIRD area itself (the only reason that there even is a subarea plan) is not rural. The county's rural lands start at one unit per 5 acre zoning."

Discussion and vote on Subcommittee's recommendation

- Tom made a motion to approve the Suquamish Subarea Plan, and Martha seconded the motion
 - Brynn made a motion to amend the vision statement that the intent of
 the recommendations is to be interpreted and in alignment with the
 Suquamish Tribe's development plan. Laurie seconded the motion. Brynn
 stated this is a patchwork reservation, and she doesn't want the fee
 areas to be developed in a way that undermines the tribe.
 Four were in favor (Brynn, Laurie, Brenda, Carol), one opposed (Tom) and
 two abstained because they wanted more information on the possible
 implications (Martha and Erin); the motion carried.
 - Laurie made a motion to change the title to include "Of the Kitsap County Comprehensive Plan" to help delineate that the plan includes recommendations specific to the Suquamish community as well as recommendations county-wide. Martha seconded. All were in favor and the motion passed.
 - Carol recommends clarifying Angeline Ave S.**N.E**.
- Martha moved to approve the plan (with the discussed revisions above). Tom seconded. All approved.
