About The NCS™

The National Community Survey™ (The NCS™) report is about the “livability” of Kitsap County. A livable community is a place that is not simply habitable, but that is desirable. It is not only where people do live, but where they want to live. The NCS was developed by the experts from National Research Center at Polco in partnership with the International City/County Management Association (ICMA) and has been administered in hundreds of communities across the United States.



Great communities are partnerships of the government, private sector, community-based organizations and residents, all geographically connected. The NCS focuses on the livability of Kitsap County by categorizing survey questions into the ten main “facets” of community livability shown below, in addition to ratings for quality of life and local governance. These facets have been identified through years of extensive survey research as those that are most impactful to residents’ quality of life.

- Economy
- Mobility
- Community Design
- Utilities
- Safety
- Natural Environment
- Parks and Recreation
- Health and Wellness
- Education, Arts, and Culture
- Inclusivity and Engagement



The report provides the opinions of a representative sample of 719 residents of Kitsap County collected from July 28th, 2025 to September 8th, 2025. The margin of error around any reported percentage is 3.9% for all respondents and the response rate for the 2025 survey was 19%. Survey results were weighted so that the demographic profile of respondents was representative of the demographic profile of adults in Kitsap County.

Reporting Results

For the most part, the percentages presented in this report represent the “percent positive.” Most commonly, the percent positive is the combination of the top two most positive response options (excellent/good, very safe/somewhat safe, etc.). On many of the questions in the survey, respondents may answer “don’t know.” The proportion of respondents giving a “don’t know” response is shown in the full set of responses included in the “Complete Data” section; however, these responses have been removed from the analyses presented in the main body of the report. Therefore, the tables and graphs display the responses from respondents who had an opinion about a specific item.

Benchmark Comparisons

Polco’s database of comparative resident opinion is comprised of resident perspectives gathered in surveys from over 400 communities whose residents evaluated the same kinds of topics on The NCS. The comparison evaluations include surveys from the past five years. If a jurisdiction has conducted multiple efforts in the past five years, only the most recent survey is included in the benchmark database. Polco adds the latest results quickly upon survey completion, keeping the benchmark data fresh and relevant. The communities in the database represent a wide geographic and population range.

In each tab, Kitsap County’s results are noted as being “higher” than the benchmark, “lower” than the benchmark, or “similar” to the benchmark. Being rated as “higher” or “lower” than the benchmark means that Kitsap County’s average rating for a particular item was more than 10 points different than the benchmark. If a rating was “much higher” or “much lower,” then Kitsap County’s average rating was more than 20 points different when compared to the benchmark.

In addition to these national benchmarks, comparisons were also made to a smaller cohort of communities. This cohort included 25 other Washington state communities who have completed a recent quality of life survey of their residents. Comparisons to these communities can be found throughout the report and in the Custom Benchmarks tab.

Methods

Selecting Survey Recipients

All households within Kitsap County were eligible to participate in the survey. A list of all households within the zip codes serving Kitsap County was purchased from Polco's mailing vendor, based on updated listings from the United States Postal Service.

Since some of the zip codes that serve Kitsap County households may also serve addresses that lie outside of the community, the exact geographic location of each housing unit was compared to community boundaries using the most current municipal boundary file. Addresses located outside of Kitsap County boundaries were removed from the list of potential households to survey. Each address identified as being within County boundaries was further identified as being within one of the three County Board districts. From that list, addresses were randomly selected as survey recipients, with multi-family housing units sampled at a rate of 5:3 compared to single family housing units.

Conducting the Random Sample Survey

The 4,000 randomly selected households received mailings beginning on July 28, 2025 and data collection for the survey remained open for six weeks. The first mailing was a postcard inviting the household to participate in the survey online. The next mailing contained a cover letter with instructions, the survey questionnaire, and a postage-paid return envelope. The final mailing was a reminder postcard giving the household one last opportunity to participate in the survey. All mailings included a web link to give residents the opportunity to respond to the survey online, as well as QR codes to further encourage participation.

About 3% of the 4,000 mailed invitations were returned because the household address was vacant or the postal service was unable to deliver the survey as addressed. Of the remaining 3,871 households that received the invitations to participate, 719 completed the survey, providing an overall response rate of 19%. The response rate was calculated using AAPOR's response rate #2 for mailed surveys of unnamed persons.¹

It is customary to describe the precision of estimates by a "level of confidence" and accompanying "confidence interval" (or margin of error). A traditional level of confidence, and the one used here, is 95%. The 95% confidence interval quantifies the sampling error or imprecision of the survey results based on the total number of responses received. This is because *some* residents' opinions are relied on to estimate *all* residents' opinions. The margin of error for the Kitsap County survey is no greater than plus or minus 3.9 percentage points around any given percent reported for all respondents (719 completed surveys).

Conducting the Open Participation Survey

In addition to the randomly selected "probability sample" of households, a link to an online open-participation survey was publicized by Kitsap County. The open-participation survey was identical to the random sample survey, with two small updates; it asked a question to confirm the respondent was a resident of Kitsap County and also a question about where they heard about the survey.

The open-participation survey was open to all county residents and became available on August 19, 2025. The survey remained open for three weeks and 3,524 responses were received. The data presented in the following report excludes the open participation survey data, but the online report includes a tab which provides the complete open participation results.

Analyzing the Data

Responses from mailed surveys were entered into an electronic dataset using a “key and verify” method, where all responses are entered twice and compared to each other. Any discrepancies were resolved in comparison to the original survey form. Range checks as well as other forms of quality control were also performed. Responses from surveys completed on Polco were downloaded and merged with the mailed survey responses.

The survey datasets were analyzed using all or some of a combination of the Statistical Package for the Social Sciences (SPSS), R, Python, and Tableau.

The demographics of the survey respondents were compared to those found in the 2020 Census and 2023 American Community Survey estimates for adults in Kitsap County. The primary objective of weighting survey data is to make the survey respondents reflective of the larger population of the community. The characteristics used for weighting were age, sex, race, Hispanic origin, housing type, housing tenure, and area. No adjustments were made for design effects. Weights were calculated using an iterative, multiplicative raking model known as the ANES Weighting Algorithm.² The results of the weighting scheme for the probability sample are presented in the following table.

Polco aligns demographic labels with those used by the U.S. Census for reporting purposes, when possible. Some categories (age, race/Hispanic origin, housing type, and length of residency) are combined into smaller subgroups.

Study Limitations

All public opinion research is subject to unmeasured error. While the methodologies employed for this survey were designed to minimize this error as much as possible, these other sources of potential error should be acknowledged, and can include non-response error, coverage error, recall bias and social desirability bias.

Non-response error arises when those who were selected to participate in the survey did not do so, and may have different opinions or experiences than survey responders. For general resident surveys, where the results are meant to be generalized to the entire adult population living in households, the mailing lists based on the Delivery Sequence File from the United States Post Office may exclude certain types of housing units, such as those in multi-family buildings where mail is addressed to a named resident at the address rather than to a specific unit or where residents only receive their mail at a post office box and the geographic location of a residence cannot be determined, there may be a *coverage error*, although for most locations, this is minimal. Respondents may not perfectly remember their experiences in the past year (such as participation in social or civic events, for example), and for some survey items, they may answer in ways they think cast their responses in a more favorable light (*recall bias* and *social desirability bias*).

Key Findings

Highest-performing areas:

- Kitsap County residents rated nearly all items related to their overall quality of life in line with national and custom averages, including:
 - Kitsap County as a place to live (75% excellent or good)
 - The overall quality of life in Kitsap County (75%)
 - Kitsap County as a place to raise children (68%)
 - Kitsap County as a place to retire (58%)
 - Sense of community (55%)
- Safety-related items received support from a vast majority of residents, with more than two-thirds of respondents saying they felt very or somewhat safe:
 - In your neighborhood during the day (90%)
 - In your local downtown/commercial area during the day (82%)
 - From violent crime (77%)
 - From fire, flood, or other natural disaster (74%)
 - From property crime (68%)
- Residents reported both a higher usage rate for public transportation and a higher quality rating for bus or transit services than other communities from around the nation:
 - Used bus, rail, ferry, or other public transportation instead of driving (77% yes)
 - [Quality of] bus or transit services (55% excellent or good)
- Over half of all respondents gave excellent or good reviews when asked about their opportunity to participate in various aspects of the community; each of these items scored in line with national and custom comparison groups:
 - Opportunities to volunteer (63%)
 - Opportunities to attend special events and festivals (61%)
 - Opportunities to participate in community matters (54%)
 - Opportunities to participate in social events and activities (52%)
 - Opportunities to attend cultural/arts/music activities (51%)

Lowest-performing areas:

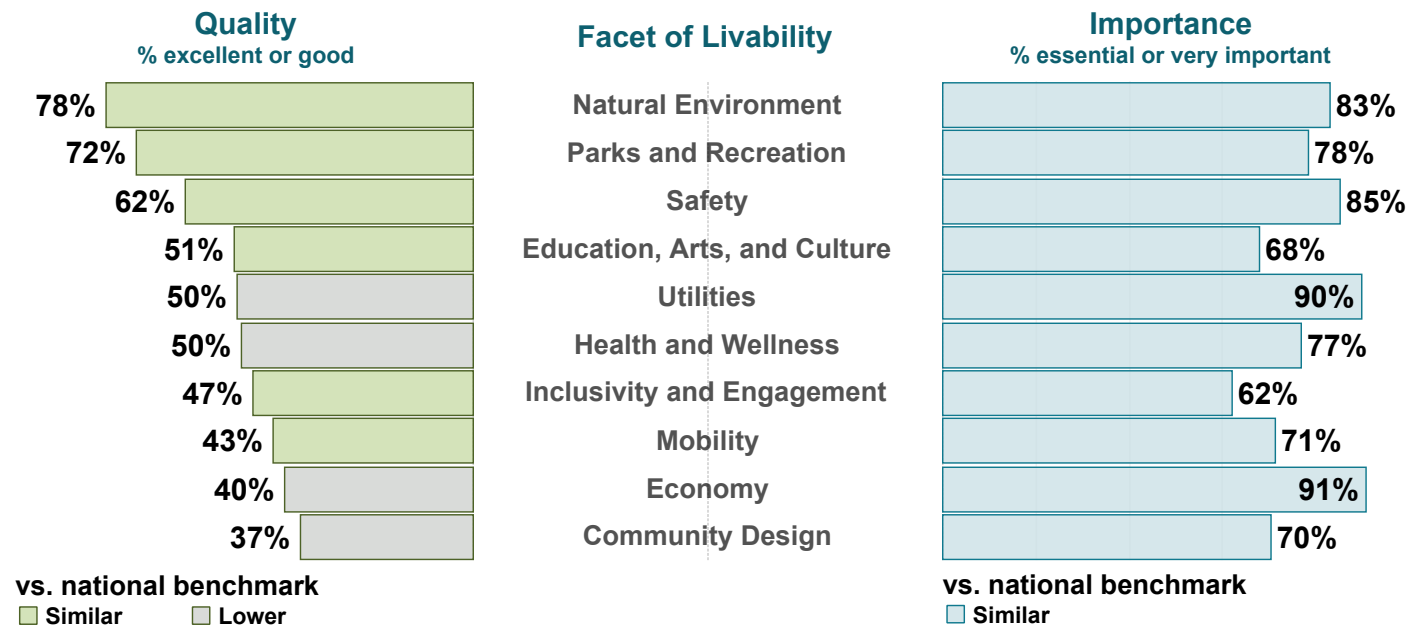
- Most economic ratings for Kitsap County were similar to benchmark comparisons; however, residents identified some concerns with economic development and cost of living measures, with each of the following scoring below national benchmark comparisons:
 - Economic development (32% excellent or good)
 - Availability of affordable quality health care (30%)
 - Availability of affordable quality mental health care (23%)
 - Cost of living in Kitsap County (20%)
 - Availability of affordable quality childcare/preschool (19%)
 - Availability of affordable quality housing (7%)
- Residents rated many aspects of Kitsap County's community design lower than national and custom comparison groups, including:
 - Overall design or layout of Kitsap County's residential and commercial areas (homes, buildings, streets, parks) (37% excellent or good)
 - Well-designed neighborhoods (31%)
 - Overall quality of new development in Kitsap County (29%)
 - Code enforcement (weeds, abandoned buildings, etc.) (27%)
 - Land use, planning, and zoning (23%)
 - Variety of housing options (23%)
 - Well-planned residential growth (23%)
 - Well-planned commercial growth (22%)

Facets of Livability

Every jurisdiction must balance limited resources while meeting resident needs and striving to optimize community livability. To this end, it is helpful to know what aspects of the community are most important to residents and which they perceive as being of higher or lower quality. It is especially helpful to know when a facet of livability is considered of high importance but rated as lower quality, as this should be a top priority to address.

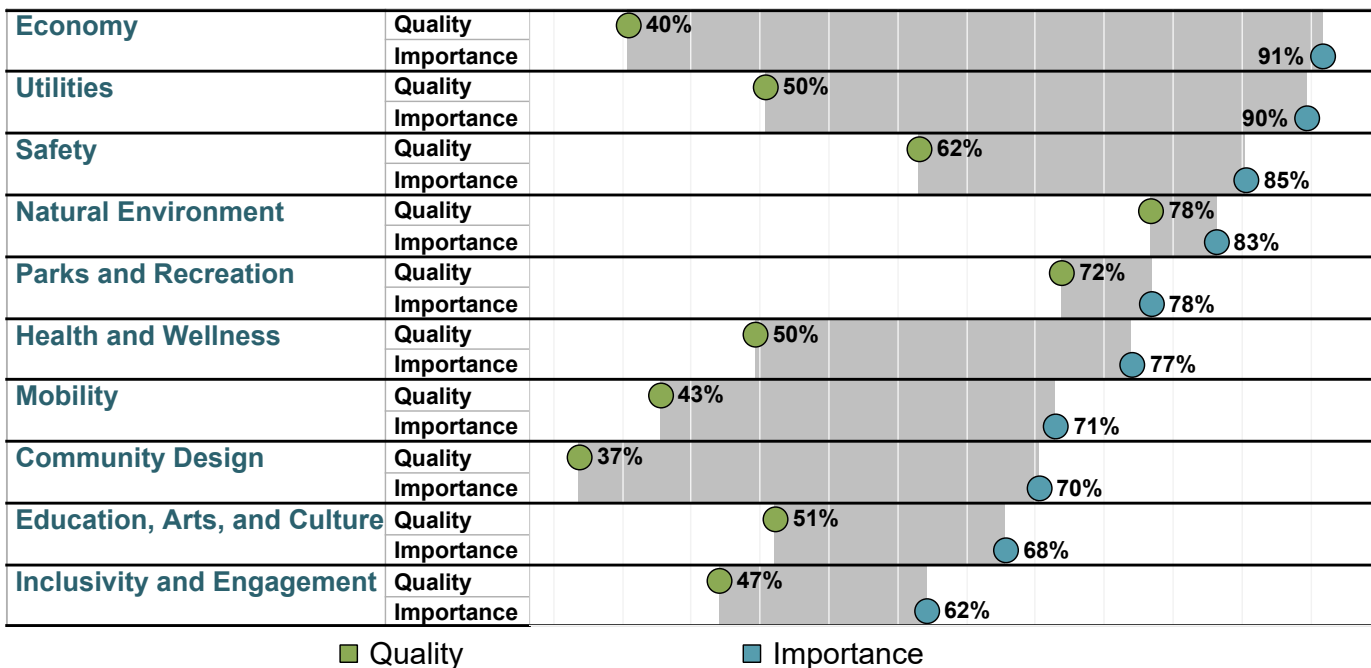
Quality and Importance by the Numbers

Quality/Importance Gap Analysis

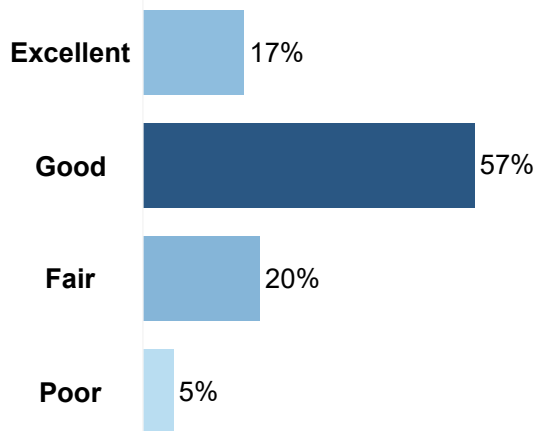

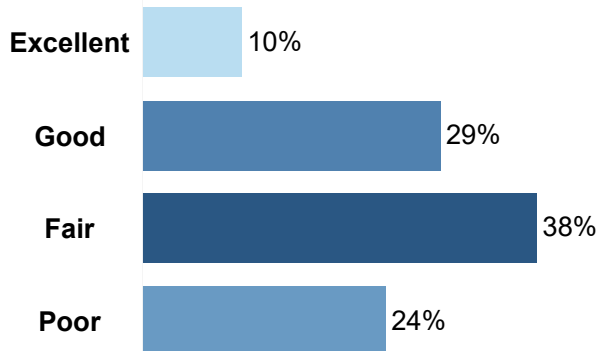

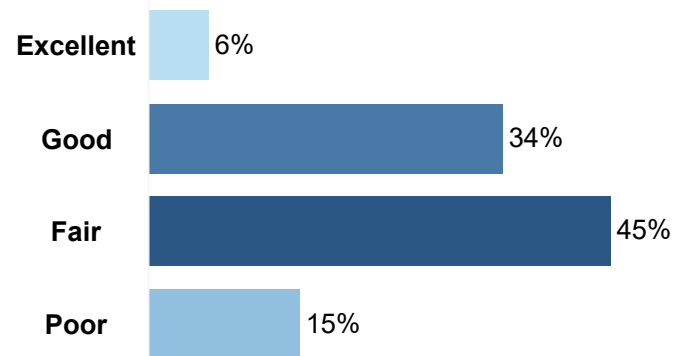

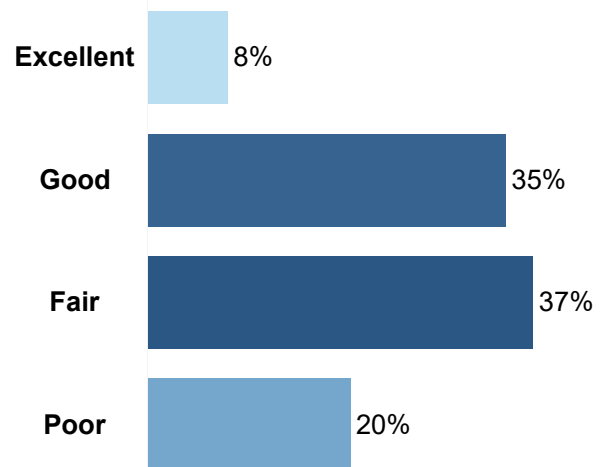

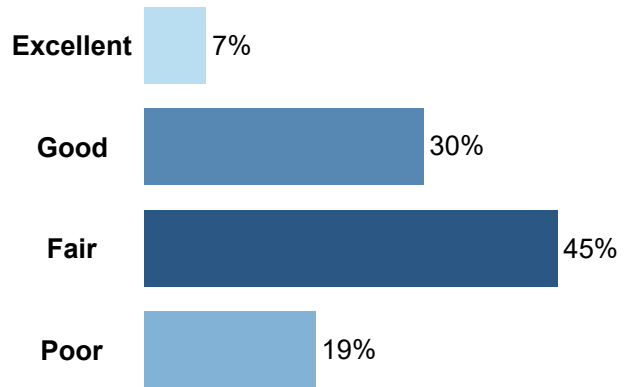

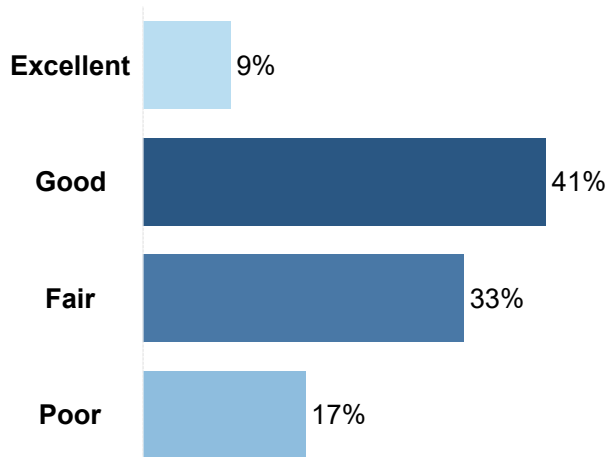

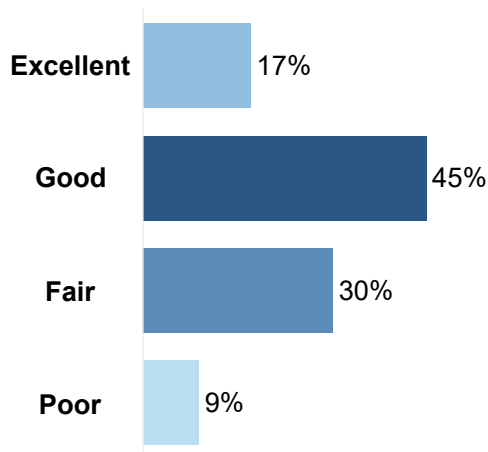

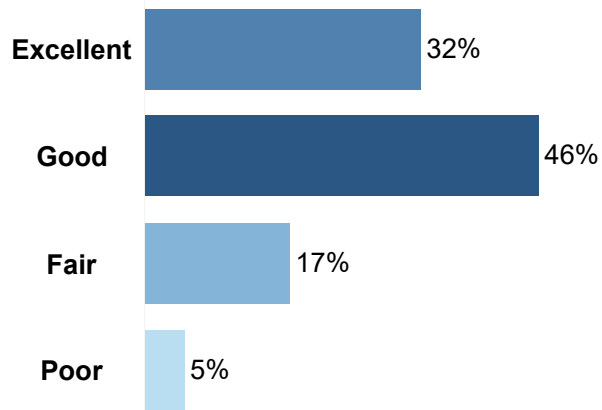

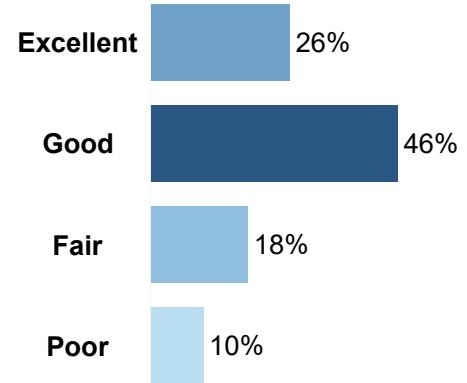

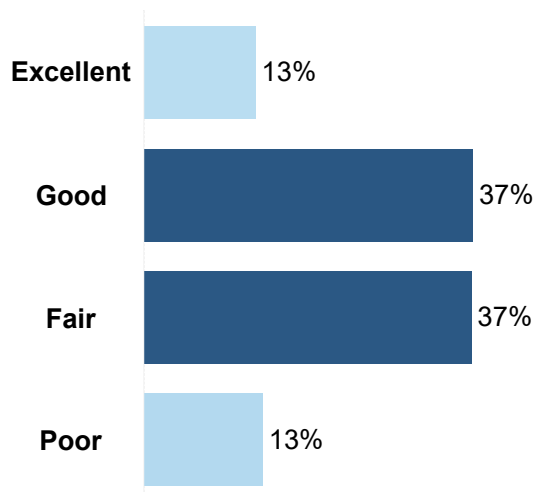

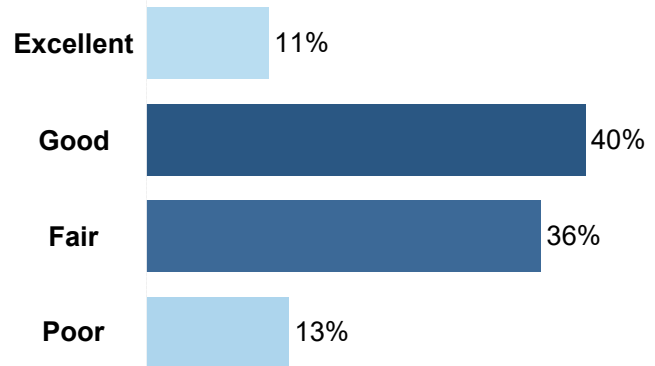

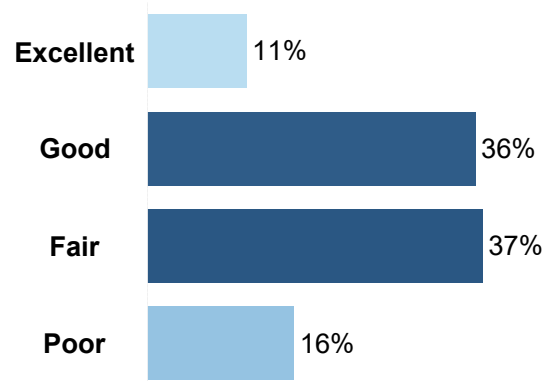
