

This proposition would provide stable funding for the continued operation of public libraries and library services in Kitsap County. The proposition authorizes an increase to the District's regular property tax levy, currently \$0.35 per \$1,000 of assessed valuation, to \$0.43 per \$1,000 of assessed valuation, to be collected in 2018. This levy amount would be used to compute the limitations for subsequent levies as provided by chapter 84.55 RCW.
