


Voter Information

State Measures

This year there are no state measures, and no judicial candidates in Kitsap County. The Secretary of State's Office will publish an informational voters' pamphlet. The state pamphlet will be delivered by the U.S. Post Office to all households in Kitsap County and is also available online at: www.votewa.gov.

General Election Ballot

This year local offices appear first on the ballot, followed in one jurisdiction by a measure.

If a Primary was held, the two candidates who received the most votes in the Primary and received at least 1 percent of the votes cast for that office appear on the General Election ballot. The candidate who received the most votes in the Primary is listed first. Candidates who did not appear in the Primary are listed in the order determined by lottery draw.

Military, Overseas and Early Ballots

If you are a military or overseas voter, or if you believe your ballot will not arrive in time to vote, you may request to receive your ballot by email or request an early ballot up to 90 days before an election. Early ballots list only contests known at the time of the request. To request an email ballot or early ballot, visit:

kitsap.gov/elections or contact Kitsap County Elections. Additional information for military and overseas voters is available from the Federal Voting Assistance Program at: www.fvap.gov.

Questions or Need a Replacement Ballot? If you have not received your ballot by October 26, or if your ballot is damaged or lost, you may request a replacement ballot by contacting Kitsap County Elections.

Your Right to Privacy

Every voter has the right to vote his or her ballot in secret.

Attempting to vote when not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

Write-Ins – Which Votes Can Be Counted General Election write-in votes can only be

General Election write-in votes can only be counted if:

- The candidate filed a Declaration of Write-in Candidacy, and;
- If there are enough write-in votes for a candidate to win.

The Local Voters' Pamphlet includes statements submitted by candidates running for offices and committees supporting or opposing ballot measures. Statements are the opinions of the authors. Kitsap County Elections is not responsible for the content of statements or their factual and grammatical accuracy.

Register to Vote

Who May Vote

To be eligible to vote, one must register and be:

- · A citizen of the United States.
- A legal Washington resident at the registration address for at least 30 days prior to the election day.
- · At least 18 years old.
- Not currently serving a sentence of total confinement in prison for a Washington felony conviction.
- Not currently incarcerated for a federal or out-of-state felony conviction.
- Not disqualified from voting due to a court order.

Options for Registering

- Online at <u>www.VoteWA.gov.</u>
- Complete a paper registration form, available at libraries, city halls, public schools, fire district offices and at the County Auditor's Office.
- · When you renew your driver's license.

To Cancel Your Voter Registration

You may sign a form requesting to cancel your registration. In the case of a deceased voter, a family member may sign a form authorizing a cancellation. The form is available by contacting the Kitsap County Auditor's Office or online at https://www.kitsap.gov/auditor/Documents/ CancellationForm.pdf.

Update Your Voter Record if You Move

If you are already registered to vote in Kitsap County, update your voter record:

- online at: www.VoteWA.gov,
- by emailing the Kitsap County Auditor Elections Division at auditor@kitsap.gov,
- by phone at 360-337-7128.

Address changes can be made in person until 8 p.m. on Election Day at the Kitsap County Auditor's Office and at the Vote Centers. A new voter registration card will be mailed after your address change is processed.

When to Register

Individuals may register to vote at any time. To vote in the November 7 General Election, the deadlines are:

- October 30: Deadline for mail and online voter registrations, updates and changes.
- November 7: In-person deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at the County Auditor's Office. Registration will also be available the Saturday and Monday before Election Day and on Election Day at the Vote Centers listed on page 4.

Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.

Vote Centers and Accessible Voting

Federal law requires jurisdictions to provide vote centers with certified accessible voting devices, which enable voters with disabilities to cast their ballots independently and in private.

Accessible Voting Units provide all contests in audio and high-contrast text formats and are available beginning 18 days prior to the General Election.

Online Ballot Access

The State of Washington provides an accessible online ballot and a Local Voters' Pamphlet.

This online access is compatible with commonly used accessibility software such as screen readers and screen magnifiers, and allows for navigation without the use of a mouse and without having to see the cursor on the screen. All candidate video statements are close captioned.

Through Online Ballot Access, you may verify that Kitsap County Elections has received your ballot using the Ballot Tracker feature.

Online Ballot Access is available beginning 18 days prior to the General Election at: VoteWA.gov.

Candidate and Political Committee Information

Contributions to Candidates and Political Committees

- Contribution Limits State law sets contribution limits on donations to legislative, judicial and county candidates as well as bona fide political party and caucus political committees.
- Anyone who donates more than \$25 in monetary and in-kind contributions must be identified by name and full address. For donations of more than \$100, occupation, employer name, city and state of his/her employer are also required.
- For a list of the people and organizations that donated to state and local candidates and ballot measure campaigns, visit Public Disclosure Commission for Washington State at www.pdc.wa.gov, or call (360) 753-1111. The PDC also explains filing requirements and contribution limits, laws and rules.

Duties and Qualifications of Elected Officials

Cities of Bainbridge Island and Bremerton

Qualifications

Elected Mayor and Council candidates must be registered voters of the city at the time of filing and have been residents of the city for a period of at least one year preceding the election. City Council candidates must reside within the defined council districts or wards at the time of filing. RCW 42.04.020, RCW 35A.12.030, RCW 35A.13.020

Duties

In Bremerton, the Mayor is the city's chief executive and administrative officer. The Council members serve as the legislative body. In Bainbridge Island the Council is the legislative authority, and Council members choose a council chair who has the title of "mayor" of the city. The Council hires a City Manager who is the chief executive and administrative officer. Functions of these offices are further defined in state law by the specific jurisdiction:

City of Bainbridge Island – RCW 35A City of Bremerton – RCW 35A and City Charter

Cities of Port Orchard and Poulsbo

Qualifications

Candidates must be registered voters of the city at the time of filing and must also have been residents of the city for a period of at least one year preceding the election. Mayor and City Council candidates may reside anywhere within the city. RCW 35A.12.030

Duties

The Mayor is the city's chief executive and administrative officer and presides over council meetings. The Council members serve as the legislative body of the city. Functions of these offices are further defined in state law by the specific jurisdiction. RCW 35A

School, Fire, Port, Sewer, Utility, Water, Metropolitan Park and Recreation Districts

Qualifications

At the time of filing for office, a candidate must be registered to vote in the district represented by the office they seek. For jurisdictions that have defined internal districts, a candidate must reside and be a registered voter within the defined area of the jurisdiction. RCW 29A.24.075

Duties

The function of each jurisdiction is described by Washington state law.

School – <u>RCW 28A</u>
Fire – <u>RCW 52</u>
Port – <u>RCW 53</u>
Utility – <u>RCW 54</u>

Sewer/Water – RCW 57

Metropolitan Park and Recreation - RCW 35.61

Mark Your Ballot

How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice.

Do not use pencil.

Mark one choice in each contest.

If you mark more than one choice, no votes will be counted for that contest.



Place the voted ballot in the secrecy sleeve.


Place the secrecy sleeve inside the lavender envelope.



Read, sign and date the Voter Declaration on the lavender return envelope.

- You must sign the lavender return envelope in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.
- Return by mail or ballot drop box (locations on page 7.)

Sign and date: You are signing that you have read the declaration. Power of attorney cannot be used to sign a ballot for someone else.



If multiple ballots are mailed to your residence, be sure the only declaration you sign is the one we sent to you, specifically.

Election Audits

In every election the county's ballot tabulation system undergoes testing and two mandatory audits to ensure that our ballot tabulators are counting your ballots as you intended. The first test is called a Logic and Accuracy Test and is conducted before the election. The second is a Random Batch Audit, conducted the day after Election Day. Recounts can also be required.

At Kitsap County Elections we also voluntarily conduct up to two other tests to further ensure that Kitsap County voters have their ballots tabulated correctly.



When an election tabulation system is certified by the Federal Hash Government's Election Assistance Commission, it carries with it a digital signature. Before each election we run a hash test to make digital signature. Before each election we run a hash test to make sure the signature matches what the EAC certified, which means the system has not changed.

The first required audit is a Logic and Accuracy Test where we mark ballots according to a template mandated by state law. The marked ballots are scanned and the results from the tabulators are compared with what the template dictated to make sure the results match. Once they do, we're ready to start an election.



The second required audit is a random batch audit, where we randomly select a few **RANDOM** batches totaling about 800 ballots. We have already machine-counted those ballots **BATCH** and kept the results hidden. Two elections staff members then each hand count those AUDIT ballots. Once they agree on the results, those results are compared to the machine count. We perform this audit the day after Election Day during every election.

An audit that isn't mandatory yet, but could be in the near future, is the risk-limiting RISK audit. An official from the Washington Secretary of State's Office selects specific LIMITING ballots for us to check to make sure those were tabulated correctly. AUDIT

L&A AUDIT

A voluntary audit we do is one we invented. Before the General Election of 2022 **VOTERS'** we invited representatives from both major parties to mark up to 100 ballots each, keeping their intended results to themselves. We scanned those ballots and they compared our results with theirs. In each case the results matched 100 percent. For this year's General Election we plan to invite Kitsap residents beyond the political parties, since no partisan races appear on ballots this year.

If a race is close enough, within a half percentage point, state law requires a recount. If there is less than a quarter percentage point difference between two candidates, that race must be recounted by hand. Outside those margins, a candidate can request and pay for a recount.

Presidential Primary - March 12

Every four years Washington voters are able to participate in the presidential nomination process by telling a party which candidate they prefer as the party's nominee. Because this is a party process, you must declare which party you prefer for your vote to count.

This is unusual in Washington. Voters in every other election are allowed to vote for whichever candidate they choose. The Presidential Primary here has been the exception since 1989. The Washington Presidential Primary is essentially two elections: one for the Democratic Party and one for the Republican Party. You decide in which election you will participate.





Primary - August 6

Candidates for Congress, State Legislature, County positions and Judges appear on the ballot. In each race the top-two vote getters move on to the General Election. Local Districts may put funding measures on the ballot as well.







General Election - November 5

Americans choose a president.





General Election 2023 FAQ

Q. What happens if I vote for more than one candidate in a race?

A. Your vote in that race will be considered an "overvote" and no candidates will be credited with a vote. If you vote for more than one candidate accidentally, follow the instructions on your ballot to correct it.

Q. If I decide not to vote on one race, will that affect my votes in other races?

A. No. How you vote in one race has no impact on your votes in other races. When neither candidate or option in a ballot measure receives a vote, it is considered an "undervote."

Q. What happens if I write in a candidate not on the ballot?

A. Per state law (RCW 29A.60.021) votes for write-in candidates are not tallied in the General Election, except for write-in candidates who file a declaration of write-in candidacy AND when there are enough write-in votes that a write-in candidate could win the election.

A list of candidates who filed a declaration of write-in candidacy, if any, is available on our website at kitsap.gov/elections

Q. Why is there no information about which party a candidate belongs to?

A. Most elections in odd-numbered years are considered nonpartisan races and candidates are not asked to name a party preference. They can state a preference within a statement, but there is no official recognition elsewhere, like there would be in even-numbered years. The exception is when someone in a partisan position resigns on time for an election to be held to fill the remainder of the term. There are no exceptions in Kitsap County elections this year.

Board of Directors of South Kitsap School District No. 402 adopted Resolution No. 1367 concerning a proposition to finance capital improvements for student safety and educational facilities. This proposition would authorize the District to: construct a new Cedar Heights Middle School; construct a new Olalla Elementary School; construct a new South Colby Elementary School; construct a new Explorer Academy and Discovery High School; renovate South Kitsap High School; and make District-wide safety, security, HVAC, parking and technology improvements; issue no more than \$271,000,000 of general obligation bonds maturing within 21 years; and levy annual excess property tax levies to pay such bonds, as provided in Resolution No. 1367.

Explanatory Statement

(Prepared by the attorney for the district as prescribed by law.)

Approval of Proposition No. 1 will allow South Kitsap School District No. 402 to finance critical facility needs by issuing bonds. If voters approve this proposition, the District will use the bond proceeds to construct a new Cedar Heights Middle School, a new Olalla Elementary School, a new South Colby Elementary School, and a new Explorer Academy and Discovery High School. The District will also use bond proceeds to renovate South Kitsap High School and make Districtwide safety, security, parking and technology improvements, including upgrades to emergency communication systems, improved traffic access, accessibility upgrades, new heating and cooling systems, improved parking lot lighting, and renovations to interior and exterior building finishes.

The District has determined these projects are necessary to replace aging and educationally outdated infrastructure and school facilities, to improve educational opportunities, and to enhance student safety and security.

The bonds will be repaid from annual property taxes over a period not to exceed 21 years. Please consult the District's website for the anticipated tax implications associated with Proposition No. 1. Exemptions from taxes may be available, call the Kitsap County Assessor at (360) 337-7160.

South Kitsap School District No. 402

Argument For the Measure

To give our students the best opportunity to succeed, South Kitsap School District asks for your vote to "Approve" this bond. Since school districts do not receive state funding for construction, your support is necessary to fix our schools. The last successful bond passed 35 years ago – now is the time to reinvest in our students and community.

This bond addresses immediate rebuilding needs.

Argument Against the Measure

No one disputes the need for school upgrades. The question is which solution. The second HS was the district focus for years. Now, the plan includes fixing the three oldest schools in limited growth areas, new Discovery/ Explorer building, and improvements at the SKHS. What about the continuing westward growth and the second HS? Was renovation and school consolidation considered to cut costs? Of bigger concern is the bond clause states that the board can spend as they wish, not necessarily what you vote for. Newspaper articles detailed district audit report compliance irregularities.

Building codes and environmental concerns have dramatically changed in the last 35 years. The plan appears simple; costly new construction. Has due diligence been completed ensuring a feasible plan? The district provided no research/emails/studies indicating any contact with city, county, and state agencies despite assurances from the board president that this plan will work. The real plan is just give us your money and we'll figure it out. Costly design issues and permit delays will arise.

This 22 year \$271M bond will actually cost \$459M+ due to interest. Taxes on a \$500K home will start at \$500/ yr., rising quickly to over \$800. Renters and apartment dwellers pay taxes too, and will quickly see big rent increases. SKFR levy passage increases our tax pain.

And, other District Facilities over the next 22 years- still neglected? No comprehensive plan exists for future improvements/bonds that will end future bonds/levy tax increases? Vote no-pending detailed plans addressing feasibility, consolidation, and growth.

Rebuttal to the Argument For

How are schools currently operating if they aren't safe and don't meet health/safety standards? One paragraph says the state provides no construction funds; but another states they provide \$40M- which is it? Many projects are actually deferred maintenance projects due to excessive personnel spending. Less than 5% might qualify for slightly reduced property taxes. The district uses impact fees to pay for the SKHS HVAC projects versus for infrastructure improvements. Just who do you trust?
