# General Election Local Voters' Pamphlet - November 4, 2025

Dear Kitsap Voter:

In this General Election, one item on some ballots shows why your vote matters in real, visible ways. Poulsbo is asking residents whether the city should ban fireworks. Fireworks are something we all know—and most of us have an opinion about them.

National elections draw most of the attention. In a presidential year, about four out of five registered voters in Kitsap County typically return a ballot. By comparison, August's Primary drew 35 percent turnout—our highest in 20 years for that type of election.

It's easy to understand why presidential elections dominate the headlines; candidates offer sharply different visions for the country. Those views are debated on television and social media. Even friends and family who live far from each other can weigh in on the same subject.

But decisions made in local elections often affect your day-to-day life when you drive to the store, to work and to school. On a future July 4, for example, Poulsbo residents could see results from their November 4, 2025 vote.

Every two years we remind you that local elections shape your communities: your cities, schools, utilities, marinas, and parks. Who you elect and the measures you decide shape the services you use, the costs you pay, and the neighborhoods you live in.

We encourage you to read the candidate statements and the arguments for and against measures in this pamphlet. Your vote is your chance to shape what you see, what you hear, and the services that matter most to you.

# Election Information

## State Candidates and Measures

The Secretary of State's Office will publish a voters' pamphlet with information about a state ballot measure and the Legislative District 26 State Senate race. The state pamphlet will be delivered by the U.S. Post Office to all households in Kitsap County and is also available online at: [www.votewa.gov](http://www.votewa.gov).



## General Election Ballot

This year a state measure will be first on the ballot, followed by the State Senate contest in Legislative District 26. Local offices appear next, followed by local measures in Bainbridge Island, Poulsbo and for residents who live in the North Mason School District boundaries.

If a Primary was held, the two candidates who received the most votes in the Primary and received at least 1 percent of the votes cast for that office appear on the General Election ballot. The candidate who received the most votes in the Primary is listed first. Candidates who did not appear in the Primary are listed in the order determined by lottery draw.



## Military, Overseas and Early Ballots

If you are a military or overseas voter, or if you believe your ballot will not arrive in time to vote, you may request to receive your ballot by email or request an early ballot up to 90 days before an election. Early ballots list only contests known at the time of the request. To request an email ballot or early ballot, visit: [KitsapVotes.gov](http://KitsapVotes.gov) or contact Kitsap County Elections.

## Your Right to Privacy

Every voter has the right to vote his or her ballot in secret.

Attempting to vote when not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

General Election write-in votes can only be counted if:

- The candidate filed a Declaration of Write-in Candidacy, and;
- If there are enough write-in votes for a candidate to win.




# Voter Registration

## Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A resident of Washington state.
- At least 18 years old. In the August Primary a 17-year-old who will be 18 by the November General Election can vote in candidate races, except for PCO races.
- Not disqualified from voting due to a court order.
- Not currently serving a sentence of total confinement in prison under the jurisdiction of the Department of Corrections for a Washington felony conviction.
- Not currently incarcerated for a federal or out-of-state felony conviction.



## When to Register

Individuals may register to vote at any time. To vote in the November 4 General Election, the deadlines are:

- **October 27:** Deadline for **mail and online** voter registrations, updates and changes.
- **November 4:** **In-person** deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at one of the Vote Centers or at the Auditor's Office. Registration will also be available the Saturday and Monday before Election Day and on Election Day at the Vote Centers at the Marvin Williams Recreation Center, the Poulsbo Fire Station and the Kitsap County Auditor's Office.

## **Vote Centers and Accessible Voting**



Federal law requires jurisdictions to provide a vote center with certified accessible voting devices that enable voters with disabilities to cast their ballots independently and in private.

Accessible Voting Units provide all contests in audio and high-contrast text formats and are available beginning 18 days prior to the General Election.

# Candidate and Political Committee Information

## Candidates for Partisan Office

A candidate may state on the ballot a political party that he or she prefers. A candidate may choose to not state a party preference.

A candidate's party preference does not imply that the candidate is nominated or endorsed by the party or that the party approves of or associates with that candidate.



## Contributions to Candidates and Political Committees

- **Contribution Limits** – State law sets contribution limits on donations to legislative, judicial and county candidates as well as bona fide political party and caucus political committees.
- Anyone who donates more than \$100 in monetary and in-kind contributions must be identified by name and full address. For donations of more than \$250, occupation, employer name, city and state of his/her employer are also required.

The PDC also explains filing requirements and contribution limits, laws and rules.

# Duties and Qualifications of Elected Officials

## Cities of Bainbridge Island and Bremerton

### Qualifications

Elected Mayor and Council candidates must be registered voters of the city at the time of filing and have been residents of the city for a period of at least one year preceding the election. City Council candidates must reside within the defined council districts or wards at the time of filing. [RCW 42.04.020](#), [RCW 35A.12.030](#), [RCW 35A.13.020](#)

### Duties

In Bremerton, the Mayor is the city's chief executive and administrative officer. The Council members serve as the legislative body. In Bainbridge Island the Council is the legislative authority, and Council members choose a council chair who has the title of "mayor" of the city. The Council hires a City Manager who is the chief executive and administrative officer. Functions of these offices are further defined in state law by the specific jurisdiction:

## Cities of Port Orchard and Poulsbo

### Qualifications

Candidates must be registered voters of the city at the time of filing and must also have been residents of the city for a period of at least one year preceding the election. Mayor and City Council candidates may reside anywhere within the city. [RCW 35A.12.030](#)

### Duties

The Port Orchard Mayor is the city's chief executive and administrative officer and presides over council meetings. The Poulsbo Mayor is the city's chief executive and hires the city's administrative officer. The Council members in each city serve as the legislative body of the city. Functions of these offices are further defined in state law by the specific jurisdiction. [RCW 35A](#)

# Duties and Qualifications of Elected Officials

## School, Fire, Port, Sewer, Utility, Water, Metropolitan Park and Recreation Districts

### Qualifications

At the time of filing for office, a candidate must be registered to vote in the district represented by the office they seek. For jurisdictions that have defined internal districts, a candidate must reside and be a registered voter within the defined area of the jurisdiction. [RCW 29A.24.075](#)

### Duties

The function of each jurisdiction is described by Washington state law.

School – [RCW 28A](#)



A School Board's pivotal responsibilities are establishing district policy, adopting budgets as well as the legal fiduciary responsibility for the school district. These responsibilities are further divided into four major areas: quality of instruction, district planning, policy development, and communications. Within state and federal guidelines, the Board can, in effect, establish what will be taught, how it will be taught, when and where it will be taught, to whom it will be taught, and with what materials it will be taught. With voter approval, the Board may issue bonds and impose excess levies for specific purposes. [RCW 28A](#)



## What's the difference between a district and a position?

A candidate running for a seat listed as a "district" must live within a specific subsection of the overall district. For example, in Bremerton, the city is divided into seven districts. A resident living within District 2 of the city cannot run for a District 7 seat. In Poulsbo, however, a candidate can run for one of seven positions and can be from anywhere within city limits.



Proposed Constitutional Amendment

**Senate Joint Resolution No. 8201**

The legislature has proposed a constitutional amendment on allowing money in Washington's long-term care fund to be invested. This amendment would allow the state fund dedicated to providing long-term care benefits for eligible seniors and people with disabilities to be invested as authorized by law.








Washington voters do not register by party affiliation. Vote for any candidate regardless of their party preference.





# Election Security in Washington

## Before an Election

### Voting systems certification and testing



Ballot counting equipment is tested and certified by an independent testing authority and the State of Washington.

Voting systems are not connected to the internet.

### Pre-election audit: logic & accuracy tests

Before every election, counties test their voting systems to make sure the machines are correctly set up and accurately counting votes.

### Voter registration database

Washington's statewide voter registration database is constantly maintained and updated as voters become registered, move, change their name, pass away, or are no longer eligible to vote.

All eligible voters are automatically mailed ballots. Only one ballot per voter is accepted.



## During an Election

### Paper ballots



Voting on paper ballots allows election officials to audit results of an election after votes are counted.

### Signature verification

Trained election officials compare your signature to your voter registration file to confirm your identity and eligibility.

If your signature is missing or doesn't match, your ballot is "Challenged" and you are notified. Once your signature is verified, your ballot status will update to "Accepted".

### VoteWA

Check the status of your ballot at [VoteWA.gov](http://VoteWA.gov). Once your ballot status is updated to "Accepted," your ballot will be opened and scanned. Only one ballot per voter is accepted.

### Chain of custody

Ballots are sealed in secure, tamper-evident containers and at least two staff are present whenever your ballot is handled.

### Scanning and tabulation

Ballot scanners and vote counting machines are physically secured in locked rooms. Election staff sign in and out each time the room is opened, and always in groups of two or more.

## After an Election

### Random batch audits



Your local election officials hand count randomly selected precincts or ballot batches and compare those numbers to the voting system totals to make sure the vote counting machines counted correctly.

### Random ballot audits

Your local election officials examine a statistically significant, randomly selected sample of ballots to help ensure the reported outcome is correct.

### Full ballot reconciliation

Your local election officials keep detailed records of the steps taken to process each ballot or group of ballots, creating an audit trail.

A final report at the end of the process includes a summary of the ballots received and counted.

### 2 Your signature is verified

Your signature is important and we need it to accept your ballot. The signature on your return envelope is compared to the signature on your voter registration record. If the signature matches, your ballot is accepted and you are credited for voting to ensure **only one** ballot is counted for you.

### 3 Envelopes and sleeves are separated

The return envelope is opened and the secrecy sleeve containing your ballot is removed. They are separated to ensure the secrecy of your vote.




### 4 Your ballot is reviewed and scanned

The ballot is removed from the secrecy sleeve and election staff verify that it can be successfully scanned. Each voting system is certified and tested before every election.

### 5 Your ballot is counted

After 8 p.m. on Election Day all scanned ballots are tallied. Ballots will be scanned and tallied over the next several days until all the votes are counted. Every county conducts a post-election audit.



### Advisory Proposition No. 1

#### Sale, Possession, and Discharge of Consumer Fireworks in the City of Poulsbo

##### Official Ballot Title

The Poulsbo City Council is calling for an advisory election to determine whether the sale, possession, and discharge of consumer fireworks should be prohibited in the City of Poulsbo. The prohibition of the sale, possession or discharge of consumer fireworks would not affect properly licensed and permitted public displays of fireworks. Should the sale, possession, and discharge of consumer fireworks be prohibited in the City of Poulsbo?

### Explanatory Statement

*(Prepared by the attorney for the district as prescribed by law.)*

Under the Poulsbo Municipal Code Chapter 8.20, the City of Poulsbo currently allows the sale, possession, and discharge of consumer fireworks within the city. Proposition 1 is a non-binding advisory vote that allows residents to inform the Poulsbo City Council whether they believe the sale, possession, and discharge of consumer fireworks should be prohibited in the City of Poulsbo. A “Yes” vote means the voter is in favor of prohibiting the sale, possession, and discharge of consumer fireworks in the City of Poulsbo. A “No” vote means the voter is in favor of continuing to allow the sale, possession, and discharge of consumer fireworks as described in the Poulsbo Municipal Code. The result of this advisory vote will provide input to the Poulsbo City Council when determining what action, if any, the Council should take to regulate the sale, possession, and discharge of consumer fireworks within the City of Poulsbo.

# City of Poulsbo

## Argument For the Measure

We all love a good celebration for New Year's and the 4th of July. Being good neighbors includes being thoughtful about how our activities affect others, so we need to consider the full impact of fireworks use. Here are four reasons to seek better ways to celebrate than with fireworks displays.

### Veterans

Fireworks recreate the shocking explosions of a battlefield. For many of us veterans, this can trigger PTSD, painful memories, or fear.

### Animals

Domestic pets are often terrified by sudden and repeated booming in their neighborhood. Further from view, fireworks terrorize local wildlife who lack compassionate owners to reassure them. Our deer and raccoon families panic and flee into roadways.

### Environment

Besides emitting unnecessary air pollutants, firework remains litter our sidewalks, parking lots, and streets. Our celebrations should demonstrate more personal responsibility for our waste.

### Negligence

Irresponsible personal fireworks use can injure individuals, damage property, and initiate structure fires or wildfires, especially during drought years. In 2024, fireworks injuries across the United States more than doubled from the previous year, and fireworks ignited 271 fires here in Washington. There are better ways to celebrate than by recreating a dangerous and frightening warzone around our peaceful bay community.

## Rebuttal to the Argument Against

Free expression doesn't entail a right to heckle, and our freedom to celebrate culture doesn't include a right to set off explosives. There is no constitutional right to fireworks. Firework use is a privilege that must be balanced with the common good. Biannual fireworks sales hardly provide reliable income for our indigenous community. Let's instead invest in year round tribe-operated enterprises. We don't need to terrorize animals, traumatize veterans, or endanger homes and forests.

## Argument Against the Measure

Arguments advocating for consumer fireworks on private property center around three key points:

### Constitutional Rights

Banning fireworks on private property is seen as infringing upon constitutional rights to personal liberty and property, as well as the First Amendment's protection of cultural traditions like celebrating Independence Day.

### Tribal Sovereignty

A ban would severely impact the economies of local Indian tribes, such as the Suquamish and Port Gamble S'Klallam. Fireworks sales are a vital source of income, supporting families and community programs, and a ban could be perceived as undermining tribal sovereignty and economic self-sufficiency.

### Regulations & Responsible Use

Current regulations, restricting fireworks to July 4th with specific hours and penalties, are viewed as effective in ensuring safety. Examples like Bremerton suggest that regulation is more successful than prohibition, which saw a reduction in complaints after adopting similar measures & a ban might lead to increased risks by driving fireworks use underground. Responsible use, with measures like having water ready and preventing children from handling them, is emphasized

## Rebuttal to the Argument For

While acknowledging veterans' PTSD, animals' distress, environmental concerns, and negligence risks, banning fireworks overlooks first amendment protections, undermines local tribal sovereignty and severely impacts the economies of local Indian tribes. Responsible use, designated areas, can mitigate issues. Fireworks injuries and fires, though concerning, are preventable through education and regulation, not outright bans. Let's balance celebration with safety, preserving traditions while addressing valid concerns in our community.

## Explanatory Statement

*(Prepared by the attorney for the district as prescribed by law.)*

Passage of Proposition 1 would authorize Bainbridge Island School District to supplement its existing enrichment and operations levy to pay for school operations and educational programs not fully funded by the state. This proposition, if approved by voters, enables the District to take advantage of a change in state law, effective July 27, 2025, that increases the District's allowable enrichment levy amount. The District would use the supplemental levy funds to pay for teaching, instructional support, school supplies, athletics and extracurricular activities, operational support, transportation, and other school programs.

The proposed levy would authorize collection of supplemental annual excess property taxes of \$1,103,828 in 2026, \$1,572,896 in 2027, and \$2,002,902 in 2028. Based on projected assessed valuation information, the District estimates supplemental excess property tax rates of \$0.08 per \$1,000 of assessed value in 2026, \$0.11 per \$1,000 of assessed value in 2027, and \$0.13 per \$1,000 of assessed value in 2028.

A property tax exemption may be available to certain senior or disabled homeowners who meet specified income limits. For information regarding exemptions, call the Kitsap County Assessor at (360) 337-5777.

## Argument For the Measure

### Trust

Back in 2023, our school district (BISD) was discussing closing schools and there was little trust in district financials. The school board chose a new Superintendent at the end of 2023, who immediately got to the bottom of our finances. The result? BISD balanced the budget this year and for next school year. It is now time to talk about what is possible with this levy.

### Lack of State funding

Since 2020, the lack of state funding has cost BISD \$20.25M that would have gone to vital services like special education, library services, and student curriculum - a yes vote will help avoid further reductions. These include, but are not limited to: teaching, security, instructional materials, special programs, activities and sports, technology systems operation, transportation costs, maintenance of facilities and other educational expenses. The levy will also fund security system upgrades at each school and facility repairs.

The proposed renewal levy will authorize the collection of up to \$5,577,446 in the years 2026 through 2029. The estimated levy rates per \$1,000 of assessed value are \$1.2833 in 2026, \$1.2462 in 2027, \$1.2101 in 2028 and \$1.1750 in 2029. ### Property Tax Levy Lid Lift for Fire Protection & Emergency Medical Services

To fund fire protection and emergency medical services for six years, this proposition authorizes a levy rate of \$0.72 per \$1,000 of assessed valuation for collection in 2026 and sets the limit factor for each subsequent year at 100% plus the annual percentage change in the Consumer Price Index (CPI-W, first-half to first-half), or the statutory limit factor, whichever is greater. The final year's levy amount would be used to compute limitations for subsequent levies.

Bainbridge Island Fire Department provides fire protection and emergency medical services to its residents.

If approved by the voters, this proposition authorizes the District to restore its regular real property tax levy rate to \$0.72 per \$1,000 of assessed valuation in 2025 for collection in 2026 and allows the District to keep up with inflation by authorizing annual increases of the greater of the statutory limit factor or 100% of the first-half to first-half Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for the Seattle-Tacoma-Bellevue metropolitan area as reported in the levy year for the five following years subject to otherwise applicable statutory limitations. Due to the statutory one percent limitation on property taxes, the Fire District's current levy rate is approximately \$0.57. The maximum regular levy rate for fire districts is \$1.50 per \$1,000 of assessed value.

Your Fire District Board of Commissioners has determined that this proposition is necessary to maintain an effective level of services, firefighter staffing, equipment and facilities in light of rising costs and increasing service demands.

Approval of this measure will maintain the level of emergency services currently provided. The dollar amount assessed in 2030 for collection in 2031 shall serve as the fire department's tax levy base and absent further voter approval, the tax levy will then be subject to the statutory one percent limit.

## Bainbridge Island Fire Department

### Argument For the Measure

The Bainbridge Island Fire Department is asking you to authorize a Levy Lid Lift to restore the General Fire Levy, a temporary measure to address budget shortfalls.

Personnel shortages have resulted in unsustainable overtime being worked by emergency responders to ensure department staffing 24/7. Since 2021, the Department has lost twelve firefighters and paramedics to other agencies, resulting in a 30% staff reduction. This measure will maintain the service level to provide Firefighter/EMT and Paramedic safety and stabilize the fire department budget to secure the current level of service.

The Fire Department is facing additional rising costs due to the recent Federal bill cutting Medicaid reimbursement for GEMT (Ground Emergency Medical Transport). Inflation has also resulted in significant cost increases for equipment, apparatus, etc.

Demand for fire department services is growing. Calls have increased by 1100 between 2020 to 2024, the majority being medical emergencies, many of which occur off-island as mutual aid calls.

BIFD provides excellent emergency services to the community, and they are committed to doing so as efficiently as possible. Authorization of the Levy Lid Lift will provide your fire department with the resources needed to continue protecting our community.



## Why is my signature important?


### Your signature is needed to make sure your ballot gets counted.

The signature on your return envelope is compared to the signature on your voter registration record. Trained election officials are responsible for verifying each and every signature.

If your signature is missing or does not match your voter registration record, the county elections office will contact you by mail **before results are certified**. They may call or email if you gave them this info.

If you registered to vote online or through Department of Licensing, the signature from your driver's license, permit, or state ID will be on your voter registration record.

Voters can track and check their ballot status at **VoteWA.gov**.

# Ballot Drop Box

Our 27 ballot drop boxes are a safe way to return your ballots and to be sure they are received on time. If the box is open, you are on time. Boxes open by October 17 and remain open until 8 p.m. on Election Day, November 4, 2025.

## By Mail

Ballots returned by mail must be postmarked by Election Day. The United States Postal Service recommends voters using the mail return their ballots at least a week before Election Day, November 4, 2025 to make sure your ballot is postmarked on time.

You can return your ballot in person at the Auditor's Office (619 Division Street, Port Orchard, WA 98366) through 8 p.m. on Election Day or at one of our three vote centers, open 8:30 a.m. - 4:30 p.m. Saturday and Monday before Election Day and 7 a.m. - 8 p.m. on Election Day. # General Election 2025 FAQ

## Q. What happens if I vote for more than one candidate in a race?

A. Your vote in that race will be considered an “overvote” and no candidates will be credited with a vote. If you vote for more than one candidate accidentally, follow the instructions on your ballot to correct it.

## Q. If I decide not to vote on one race, will that affect my votes in other races?

A. No. How you vote in one race has no impact on your votes in other races. When neither candidate or option in a ballot measure receives a vote, it is considered an “undervote.”

## Q. What happens if I write in a candidate not on the ballot?

A. Per state law (RCW 29A.60.021) votes for write-in candidates are not tallied in the General Election, except for write-in candidates who file a declaration of write-in candidacy AND when there are enough write-in votes that a write-in candidate could win the election.

## Q. Why is there no information about which party a candidate belongs to?

A. Most elections in odd-numbered years are considered nonpartisan races and candidates are not asked to name a party preference. They can state a preference within a statement, but there is no official recognition elsewhere, like there would be in even-numbered years. The exception is when someone in a partisan position resigns on time for an election to be held to fill the remainder of the term, which is why there is an election for the State Senate seat in Legislative District 26.

# What does this mean?

### **Certification Day**

The date when election results are finalized by state or county officials.

### **Logic and Accuracy Test**

A test completed before each election to ensure the accuracy of voting equipment.

### **Nonpartisan Office**

An elected position in which candidates do not state a political party preference and candidates for the office are not officially associated with a political group. Office appears on the ballot as “Nonpartisan.”

### **Partisan Office**

An elected position in which candidates may state their preferred political party. A candidate may also choose “States No Party Preference.” Their preference is printed on the ballot.

### **Postmark**

A postmark indicates the location and date the Postal Service accepted custody of a ballot. Ballots must be postmarked by Election Day to be accepted. Placing your ballot in a mailbox on Election Day does not guarantee a postmark of the same day.

### **Post-election Audit**

A test completed before the certification of results to ensure the security and accuracy of the voting system. Counties perform a post-election audit each election.

### **Term Type**

How much of a term a candidate will be serving for an office. It is split into regular, unexpired, and short-and-full.

### **Voter Registration Database**

The official list of registered voters maintained in every state to conduct safe and secure elections. Our database in Washington is known as VoteWA.

### **Voting Center**

A county-run facility where you can receive voting assistance from trained elections staff. Some services include registering or updating voter information, requesting and returning a ballot, or finding an accessible voting unit.

### **Voting System**


Ballot counting equipment that must be tested by an independent testing authority and certified by the state of Washington before it can be used.
