To assist you in preparing for the November 8, 2022 General Election, we offer this pamphlet. Inside you'll find statements from 17 candidates and information about three ballot measures.

The State of Washington is sending you a separate pamphlet with information about candidates for federal and state offices and about statewide ballot issues.

On our website you will find even more ways to stay in-the-know about the election and about your ballot. At <u>Kitsap.gov/elections</u> you will find:

- An online version of this pamphlet and a link to the state pamphlet.
- A link that shows you where your ballot is in the process, whether it was sent, received by us and accepted.
- Ballot return statistics that show the turnout for each jurisdiction in the election.
- A webcam that shows our main ballot processing room, allowing you to see election workers processing ballots in real time.
- Links to past election results, information for military and overseas voters, and information about voter registration.

General Election ballots will be mailed soon after this pamphlet hits Kitsap County mailboxes, so this is a good time for you to begin studying the statements candidates have written for this Local Voters' Pamphlet.

Voter Information

State and Federal Candidates/Measures

The Secretary of State's Office publishes a voters' pamphlet with federal, state and judicial candidates, and statewide measures. That pamphlet will be delivered by the post office to all Kitsap County households and is online at: VoteWA.gov.

General Election Ballot

Statewide measures appear first on the ballot, followed by countywide measures, then federal, state, county, county judicial, and public utility district candidates. Local measures appear after offices for each district.

If a Primary Election was held, the two candidates that received the most votes and received at least 1 percent of the votes cast for that office appear on the General Election ballot. The candidate who received the most votes in the Primary is listed first. Candidates who did not appear in the Primary are listed in the order determined by lottery draw.

Department), North Kitsap Fire & Rescue and
South Kitsap Fire and Rescue.

Your Right to Privacy

Every voter has the right to vote his or her ballot in secret. Attempting to vote when not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

Questions or Need a Replacement Ballot?

If you have not received your ballot by **October 27**, or if your ballot is damaged or lost, you may request a replacement ballot by contacting Kitsap County Elections.

Military, Overseas and Early Ballots

If you are a military or overseas voter or if you believe your ballot will not be received in time to vote, you may request to receive your ballot by email or request an early ballot up to 90 days before an election. Early ballots list only the contests known at the time of the request. To request an email ballot or early ballot, visit: kitsap.gov/elections or contact Kitsap County Elections.

Write-Ins - Which Votes Can Be Counted

General Election write-in votes can only be counted if:

- The candidate filed a Declaration of Write-in Candidacy, and;
- In a Primary there are enough write-in votes for a candidate to come in second, or in a General Election enough votes for a candidate to win.

Candidate and Committee Statements

The Local Voters' Pamphlet includes statements submitted by candidates running for offices and committees supporting or opposing ballot measures. Statements printed in this pamphlet are the opinions of the authors. Kitsap County Elections is not responsible for the content of statements or their factual and grammatical accuracy.

Register to Vote

Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal Washington resident at the registration address for at least 30 days prior to the election day.
- At least 18 years old. In the August Primary a 17-year-old who will be 18 by the November General Election can vote in candidate races, except for PCO races.
- Not currently serving a sentence of total confinement in prison for a Washington felony conviction.
- Not currently incarcerated for a federal or out-of-state felony conviction.
- Not disqualified from voting due to a court order.

Options for Registering

- Online at <u>www.VoteWA.gov</u>.
- Complete a paper registration form, available at libraries, city halls, public schools, fire district offices and at the County Auditor's Office.
- When you renew your driver's license.

Update Your Voter Record if You Move

If you are already registered to vote in Kitsap County, update your voter record:

- online at: <u>www.VoteWA.gov</u> through October 31,
- by emailing the Kitsap County Auditor Elections Division at <u>auditor@kitsap.gov</u>,
- by phone at 360-337-7128.

Address changes can be made in person until 8 p.m. on Election Day at the Kitsap County Auditor's Office and at the Vote Centers. Dates and locations follow. A new voter registration card will be mailed after your address change is processed.

When to Register

Individuals may register to vote at any time. To vote in the November 8 General Election, the deadlines are:

- October 31: Deadline for mail and online voter registrations, updates and changes.
- November 8: In-person deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at the County Auditor's Office. Registration will also be available the Saturday and Monday before Election Day and on Election Day at the Vote Centers at the Kitsap County Administration Building in Port Orchard, the Marvin Williams Recreation Center in Bremerton, and the Poulsbo Fire Station.

To Cancel Your Voter Registration

You may sign a form requesting to cancel your registration. In the case of a deceased voter, a family member may sign a form authorizing a cancellation. The form is available by contacting the Kitsap County Auditor's Office or online at https://www.kitsap.gov/auditor/Documents/ CancellationForm.pdf.

Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.

Vote Centers and Accessible Voting

Federal law requires jurisdictions to provide vote centers with certified accessible voting devices, which enable voters with disabilities to cast their ballots independently and in private.

Accessible Voting Units provide all contests in audio and high-contrast text formats and are available beginning 18 days prior to the General Election.

Online Ballot Access

The State of Washington provides an accessible online ballot and a Local Voters' Pamphlet.

The online access is compatible with commonly used accessibility software such as screen readers and screen magnifiers, and allows for navigation without the use of a mouse and without having to see the cursor on the screen. All candidate video statements are close captioned.

Through Online Ballot Access, you may verify that Kitsap County Elections has received your ballot using the Ballot Tracker feature.

Online Ballot Access is available beginning 18 days prior to the General Election at: VoteWA.gov.

Candidate and Political Committee Information

Candidates for Partisan Office

A candidate may state on the ballot a political party that he or she prefers. A candidate may choose to not state a party preference.

A candidate's party preference does not imply that the candidate is nominated or endorsed by the party or that the party approves of or associates with that candidate.

Major Political Parties

A political party qualifies as a "major" political party when it receives at least 5 percent of the total votes cast in the previous Presidential Election. In 2022 Washington state has two major political parties: Democratic and Republican.

Minor Political Parties

A "minor" political party is any political party in which no candidate for statewide office received at least 5 percent of the total votes cast at the preceding General Election during an even-numbered year.

Contributions to Candidates and Political Committees

- Contribution Limits State law sets contribution limits on donations to legislative, judicial and county candidates as well as bona fide political party and caucus political committees.
- Anyone who donates more than \$25 in monetary and in-kind contributions must be identified by name and full address. For donations of more than \$100, occupation, employer name, city and state of his/her employer are also required.


Mark Your Ballot

How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice.

Do not use pencil.

Mark one choice in each contest. If you mark more than one choice, no votes will be counted for that contest.



Secure

Place the voted ballot in the secrecy sleeve.

Place the secrecy sleeve inside the lavender return envelope.



Read, sign and date the Voter Declaration on the lavender return envelope.

- You must sign the lavender return envelope in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.

Redistricting

If you live in or near the darkened areas on this Kitsap map, you may be in a different Legislative District next year. If so, your ballot will reflect that. Every 10 years district boundaries are moved to reflect population figures reported in the Federal Census.

If you are wondering what district you are in now and which one you will be in beginning next year, we have a short 2-minute video on our Elections website that will show you how to find out. Go to kitsap.gov/elections to find it.

When do district boundaries change?

Federal, state, county commissioner and public utility district boundaries were approved this year and take effect in 2023.

City, port, school district and utility district boundaries will be formally approved by 2023 and take effect in 2024.


Precinct boundaries are adjusted yearly based on state law limiting the number of registered voters living in a precinct to 1,500.

About Candidate and Measure Statements

Statements written by candidates and committees for and against ballot measures are not edited by the Auditor's Office for content, factual accuracy, grammar or punctuation.

Statements for candidates for federal or state offices are in a pamphlet provided by the State of Washington and mailed separately.

Felony Conviction and Voting Rights

New legislation went into effect January 1, 2022 regarding convicted felons and their right to vote.

If you were convicted of a felony, when can you vote again?

- If you were convicted of a felony in Washington, your right to vote is restored once you are no longer serving a sentence of total confinement in prison.
- If you were convicted of a felony in another state or federal court, your right to vote is restored once you are no longer serving a sentence of total confinement in prison.
- · You do not lose your right to vote for a misdemeanor conviction or a conviction in juvenile court.

Do you need to register?

Once your right to vote is restored, you must register to vote even if you were registered before your conviction. You do not need a certificate of discharge to register to vote.

All prospective voters can register:

- at the Kitsap County Elections Office at 619 Division Street, Port Orchard, WA 98366
- at one of three Vote Centers (Dates and times are on Page 4.)
- · where you get your driver's license
- online at VoteWa.gov

The online deadline for mail and electronic registration is October 31. In-person registration is available until 8 p.m. on Election Day at the elections office or the vote centers.

To fund fire protection and emergency medical services for six years, this proposition authorizes a maximum levy rate of \$1.50 per \$1,000.00 of assessed valuation for collection in 2023 (and supersedes the lid lift currently in effect for collection years 2023 and 2024) and sets the limit factor for each subsequent year at 100% plus the annual percentage change in the Consumer Price Index (as described in the Resolution) not to exceed 6%, or be less than 1%, whichever is greater. The final year's levy dollar amount would be used to compute limitations for subsequent levies.

Kitsap County Fire District #18 (Poulsbo Fire Department) provides emergency medical, rescue, and fire protection services to its citizens. This proposition authorizes the District to restore the regular property tax levy rate (which is currently \$1.33/\$1,000 of assessed valuation) back to the rate of \$1.50/\$1,000 of assessed valuation and will establish a limit factor for the following five years that shall be at 100% plus the annual percentage change in the consumer price index (as described in Resolution 20-05), or 1%, whichever is greater, but not to exceed 6%.

The Board of Commissioners of North Kitsap Fire and Rescue adopted Resolution No. 2022-13 proposing an increase in the fire district's regular property tax levy. To fund fire protection and emergency medical services for six years, this proposition authorizes a maximum levy rate of \$1.50 per \$1,000.00 of assessed valuation for collection in 2023 and authorizes annual adjustments for the five succeeding years based on the greater of the statutory 1% or the annual percentage change in the Consumer Price Index referenced in the Resolution, not to exceed 6%. The final year's levy dollar amount would be used to compute limitations for subsequent levies.

Explanatory Statement

North Kitsap Fire & Rescue provides emergency fire protection and medical services to its citizens. The District's Board of Commissioners has determined that this proposition is necessary to maintain an effective level of service, fire fighter staffing, equipment and facilities in light of rising costs and increasing service demands. The taxes levied pursuant to this measure will allow the District to maintain the level of fire protection and emergency medical services provided to its citizens.

If approved by the voters, this proposition will authorize the District to restore its regular real property tax levy rate to \$1.50 per \$1,000 of assessed valuation in 2022 for collection in 2023 (the current levy is approximately \$.97 per \$1,000 of assessed valuation). For the five subsequent years, the proposition authorizes annual adjustments of the greater of one percent or the annual CPI-W for Seattle-Tacoma-Bellevue for the period from August to August as reported in the levy year, not to exceed six percent. The amount levied in 2027 and collected in 2028 shall serve as the District's tax levy base and, in 2028, absent further voter approval, the tax levy will be subject to the statutory one percent limit.

This lid lift will replace the District's \$.35 per thousand of assessed valuation maintenance and operation levy which expires in 2022. When combined in the statutory reduction of the EMS levy rate (estimated to be \$.07 per thousand) this will result in a net change to the overall levy rate of \$.11 cents per thousand of assessed valuation.

Exemptions from taxes may be available to homeowners who are 61 or older, or disabled, and who meet certain income requirements.

North Kitsap Fire & Rescue

Proposition 1 replaces funding from an expiring special levy.

Replacement funding is needed to maintain North Kitsap Fire & Rescue's current levels of service, help the district meet the demands of coming growth and more.

Proposition 1 provides the resources necessary to rebuild an outdated fire station.

Constructed more than 60 years ago, the Suguamish station is the oldest of NKF&R's four staffed stations and the only one that doesn't meet current earthquake and safety standards. No matter where you live or travel in the district, every station is an integral part of an interdependent system that provides emergency medical, fire and rescue service for the entire North Kitsap area. The final year's levy dollar amount would be used to compute limitations for subsequent levies.

Explanatory Statement

South Kitsap Fire and Rescue provides emergency medical, rescue and fire protection services to its citizens. This proposition authorizes the District to renew its levy and restore the District's property tax levy rate (which is currently approximately \$1.21 per \$1,000.00 of assessed valuation) to a levy rate of \$1.50 per \$1,000.00 of assessed valuation and will establish a limit factor for the following five years that shall be 100% of the first-half to first-half Consumer Price Index for the Seattle-Tacoma-Bellevue area. This results in an approximate \$0.29 increase in the levy with an impact of approximately \$130.00 increase-peryear on a median assessed valued home within the District in 2023.

The District's Board of Commissioners has determined that this proposition is necessary to maintain an effective level of services, firefighter staffing, equipment and facilities. South Kitsap Fire and Rescue

The South Kitsap community continues to experience significant growth, evidenced, in part, by the incredible call volume growth experienced by South Kitsap Fire and Rescue (SKFR). The growth of the South Kitsap community has caused 911 calls to increase 47.5% in the last 10 years, and 10.7% in the last year alone! SKFR serves over 79,000 citizens in the 117 square mile jurisdiction. In 2011, SKFR responded to 7,795 incidents. That number has increased to 12,005 calls in 2021, an average of 32 calls per day, 1.3 calls every hour, making SKFR the busiest fire district in Kitsap County.

SKFR is seeking to restore this levy lid to \$1.50. The Fire Levy accounts for nearly 60% of the fire district's budget. The fire district does not receive any funding from the county, sales tax, state or federal taxes. In Washington, levies are the primary source of revenue for fire districts and support the overall operations of the agency. The funds generated by agreeing to support SKFR's lid lift will allow SKFR to increase firefighter staffing and buy the necessary equipment to meet its increased demands while improving its level of service for the citizens it serves. SKFR will be able to increase daily staffing levels and add an additional twenty-four hour staffed fire engine and ambulance.

SKFR states 12,000 calls which equates to 2 calls per hour. Neighbors in our area haven't seen or heard a Fire/Paramedic vehicle in months. The SKFR always mentions this just before they ask for a levy lift. The 24% increase is indeed a tax increase for 10 years, not 4 years.

Tired of "Burn is your Beds" scare tactic due to response times? Response times are constantly cited yet fire vehicles can't speed though roundabouts, fly over speed bumps, speed down narrow winding roads or even manage most dirt roads. More stations and employees won't change the physics. South Kitsap has one sheriff, but the three-fire district has never consolidated so three fire chiefs make hundreds of thousands in salaries. SKFR firefighters and paramedics make more than \$100K.

SKFR purchased five properties all above market value in cash; costing taxpayers over \$1.5 M.
