

General Election Local Voters' Pamphlet – November 5, 2019



Dear Kitsap County Voters:

During the weeks leading up to the Primary in August, our office received several calls asking when the presidential race would be on the ballot. It's no wonder. There is a lot of elections-related news and small talk now and most of it is focused on next year. However, I agree with those who have occupied this seat before me. Elections like this one potentially have more direct impact on residents of Kitsap County than the elections that draw all the press.

Your neighbors running for office in this election will have a direct impact on your cities, schools, fire districts, ports, utilities and parks. Please read their statements in this Local Voters' Pamphlet to get a sense for which candidates you prefer, and to learn about any of the three emergency medical services ballot measures.

In 2020, besides the election, you will also hear a lot about the U.S. Census. In this pamphlet you will find a page dedicated to providing you information that will help you prepare for what's ahead. This pamphlet also has information about election-day vote centers, mobile voting, ballot drop box locations and instructions on filling out your ballot.

On a final note, there has been some attention on the state's upgrade of its voter registration and processing programs. Based on our experience with the new program in the 2019 Primary, we are confident we are well prepared for upcoming elections. We are upgrading our internal systems as well. And as a way to increase transparency, we have installed a camera into the ballot processing room. During elections you will be able to get a live view of that room from your computer or phone. Find the camera and all elections information at kcowa.us/elections.

Thank you for your interest in democracy and specifically in the candidates and measures that will appear on your ballot.

Voter Information

State Measures

The Secretary of State's Office will publish a voters' pamphlet that includes all statewide measures. The state pamphlet will be delivered by the U.S. Post Office to all households in Kitsap County and is also available online at: www.votewa.gov.

General Election Ballot

State measures will appear on the ballot followed by local offices and measures.

If a Primary was held, the two candidates that received the most votes in the Primary and received at least 1 percent of the votes cast for that office appear on the General Election ballot. The candidate that received the most votes in the Primary is listed first. Candidates that did not appear in the Primary are listed in the order determined by lottery draw.

Questions or Need a Replacement Ballot?

If you have not received your ballot by Oct. 25 or if your ballot is damaged or lost, a replacement may be obtained by calling the Kitsap County Auditor – Elections Division at (360) 337-7128.

Military, Overseas and Early Ballots

If you are a military or overseas voter or if you believe your ballot will not be received in time to vote, you may request your ballot be sent by email or request an early ballot up to 90 days before an election. Early ballots list only contests known at the time of the request. To request an email ballot or early ballot, visit: kcowa.us/earlyvote or call the Kitsap County Auditor – Elections Division at (360) 337-7128.

Your Right to Privacy

Every voter has the right to vote his or her ballot in secret. A person voting when he or she is not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

Email or Faxed Ballots

You may request that a ballot be emailed or faxed to you by contacting the Kitsap County Auditor's Office. The ballot will contain instructions on how to vote and return the ballot.

Register to Vote

Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal resident of the state of Washington.
- 18 years of age by the next election.
- Not under the authority of the Department of Corrections for a Washington felony conviction.
- Not disqualified from voting due to a court order.

How to Register

- Online at www.votewa.gov.
- Complete a mail-in registration form available at libraries, city halls, public schools, fire district offices and at the County Auditor's Office.
- When you renew your driver's license.

Update Your Voter Record if You Move

If you are already registered to vote in Kitsap County, update your voter record online at: www.votewa.gov through October 28. You may also email the Kitsap County Auditor – Elections Division at auditor@co.kitsap.wa.us or call 360-337-7128.

Address changes can be made in person until 8 p.m. on Election Day at the Kitsap County Auditor's Office and at the Vote Center on the Olympic College Poulsbo Campus on Election Day only. A new voter registration card will be mailed after your address change is processed.

Write-Ins – Which Votes Can Be Counted

Write-in votes can only be counted if:

- The candidate filed a declaration of Write-in Candidacy, and;
- In a General Election there are enough write-in votes for a candidate to win, or in a Primary if there are enough votes for a candidate to come in second place.

When to Register

Individuals may register to vote at any time. To vote in the November 5 General Election, the deadlines are:

- **October 28:** Deadline for **mail and online** voter registrations, updates and changes.
- **November 5:** **In-person** deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at the County Auditor's Office. Registration will also be available on Election Day at the Vote Center on the Olympic College Poulsbo campus.

Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.


To Cancel Your Voter Registration

You may sign a form requesting to cancel your registration. In the case of a deceased voter, a registered voter with personal knowledge the voter is deceased may sign a form authorizing a cancellation. The form is available by contacting the Kitsap County Auditor's Office.

Mark and Return Your Ballot

How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice. **Do not use pencil.** Mark no more than one choice in any contest. If you mark more than one choice in a contest, no votes will be counted in that contest. If you mark no choices in a contest, your other choices in other contests on the ballot will still be counted.



Privacy

Place the voted ballot in the secrecy sleeve.

Place the secrecy sleeve inside the lavender return envelope.



Sign, Date and Seal

Read, sign and date the Voter Declaration on the lavender return envelope.

- The lavender return envelope must be signed by you in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.



Mail

Mail your ballot early enough to ensure it is postmarked no later than Election Day, November 5. No postage required.



Ballot Drop Boxes

Use one of our 24-hour ballot drop boxes listed on page 7. Ballot drop boxes close at 8 p.m. on Election Night.



Return your ballot early

- You may mail your voted ballot or deposit it in a ballot drop box as early as the day you receive it.
- Mail your ballot early enough to ensure it is postmarked by Election Day.
- Ballots received by Monday, November 4 will be included in the first count of ballots on Election Day, Tuesday, November 5.



How to vote this ballot

Use dark blue or black ink



Do not use pencil



Fill in the box to the left of your choice

Mark **one** choice for a contest. If you mark more than one choice, no votes will be counted for that contest.

If you make a mistake

- Option 1
- Option 2

Draw a line through the entire measure response or candidate's name, then you may make another choice.

To vote for a write-in candidate **not listed** on the ballot, write their name in the space provided and fill in the box.

State Measures

Referendum Measure

Referendum Measure No. 88

The legislature passed Initiative Measure No. 1000 concerning affirmative action and remedying discrimination, and voters have filed a sufficient referendum petition on this act. Initiative 1000 would allow the state to remedy discrimination for certain groups and to implement affirmative action, without the use of quotas or preferential treatment (as defined), in public education, employment, and contracting.

Initiative to the Legislature

Initiative Measure No. 976

Initiative Measure No. 976 concerns motor vehicle taxes and fees. This measure would repeal, reduce, or remove authority to impose certain vehicle taxes and fees; limit annual motor-vehicle-license fees to \$30, except voter-approved charges; and base vehicle taxes on Kelley Blue Book value.

Second Substitute House Bill 1087

The legislature imposed, without a vote of the people, an additional wage premium for long-term care services, costing an indeterminate amount in its first ten years, for government spending.

This tax increase should be:

Advisory Vote No. 21

Engrossed Third Substitute House Bill 1324

The legislature extended, without a vote of the people, the business and occupation tax for extracting, manufacturing, and selling timber and timber-related products, costing \$21,000,000 in its first ten years, for government spending.

This tax increase should be:

- Repealed
- Maintained

Advisory Vote No. 22

Substitute House Bill 1652

The legislature increased, without a vote of the people, retail sales tax on architectural paint by adding an assessment to the purchase price, costing \$6,000,000 in its first ten years, for government spending.

This tax increase should be:

Advisory Vote No. 23

Engrossed Second Substitute House Bill 1873

The legislature imposed, without a vote of the people, a tax on the sale, use, consumption, handling, possession, and distribution of vapor products costing \$178,000,000 in its first ten years, for government spending.

Advisory Vote No. 29

Engrossed Substitute Senate Bill 5998

The legislature increased, without a vote of the people, the real estate excise tax on certain sales of real property, costing \$1,747,000,000 in its first ten years, for government spending.

This tax increase should be:

Advisory Vote No. 30

Engrossed Substitute Senate Bill 6004

The legislature increased, without a vote of the people, the business and occupation tax on certain travel agents and tour operators, costing \$28,000,000 in its first ten years, for government spending.

This tax increase should be:

- Repealed
- Maintained

Advisory Vote No. 31

Engrossed Senate Bill 6016

The legislature increased, without a vote of the people, the business and occupation tax on certain international investment management services, costing \$367,000,000 in its first ten years, for government spending.

This tax increase should be:

- Repealed
- Maintained

Proposed Constitutional Amendment

Senate Joint Resolution No. 8200

The legislature has proposed a constitutional amendment concerning legislative powers in times of emergency. This measure would add "catastrophic incidents" to the specified times of emergency that the legislature may take certain immediate actions to ensure continuity of state and local governmental operations.

Proposition No. 1 Emergency Medical Care and Services Tax Levy

The City Council of the City of Bremerton adopted Resolution No. 3319 concerning a regular property tax levy under chapter 84.52 RCW. Will the City be authorized to impose regular property tax levies of \$0.50 or less per \$1,000 of assessed valuation for each of six consecutive years (2020-2025) to continue financing emergency medical care and services?

Explanatory Statement *(Prepared by the Attorney for the City of Bremerton as prescribed by law.)*

If approved by voters, passage of Proposition No. 1 would authorize the City of Bremerton to impose regular property tax levies of \$0.50 per \$1,000 of assessed value annually for six years commencing in 2019 through 2024 for collection beginning in 2020 through 2025. The tax levy would be used for emergency medical care and services, including related costs for personnel, training for such personnel, equipment, supplies, vehicles and structures. In 2014, the voters approved a six year EMS levy of \$0.50 per \$1,000 of assessed value, which expires in 2020. If Proposition No. 1 passes, the City will levy the tax to be collected in 2020 under this new proposition and not under the proposition approved in 2014.

Argument For the Measure

The City of Bremerton and the Bremerton Fire Department is seeking a continuation/renewal of the existing Emergency Medical Services (EMS) levy. This is not a new tax, but an established source of funding which has received the support of the citizens of Bremerton since its inception in 1980 and six subsequent renewals every six years.

Revenue from the initial EMS levy was used by the Bremerton Fire Department to create the "Medic One" program which included the purchase of a medic van and equipment. It also provided funding to send firefighters to paramedic training, providing the first paramedics in Kitsap County. In 1981, the department responded to 1,995 aid calls. In 2013, the Medic One program expanded to three paramedic units and in 2018 these units responded to 6,441 aid calls and an additional 2,692 requests for a total of 9113 requests for service.

This levy is the cornerstone of funding this essential system which trains EMS personnel, purchases medical equipment, supplies and vehicles necessary to provide advance life support medical services for the City. The department is grateful for the support of the citizens and has demonstrated good stewardship of these funds and hope to continue this service to its residents uninterrupted for the next six years.

In 2013 the voters approved a 6-year Emergency Medical Service "EMS" levy that was first levied in 2014. If approved by the voters this measure will replace the final year of the 2013 levy by renewing the District's six-year emergency medical services (EMS) property tax levy at a rate not to exceed \$0.50 per thousand dollars of assessed valuation to be levied beginning in 2019 and collected beginning in 2020.

Approval of the levy will enable the District to maintain the level of emergency medical services currently provided on a continuing basis including basic and advanced life support services by certified emergency medical technicians and paramedics.

The revenue from this levy will be used by the District exclusively for emergency medical services.

If the levy is approved, the EMS levy on a \$100,000 assessed valuation residence would not exceed \$50.00 each year or approximately \$4.17 per month for emergency medical services.
