Dear Kitsap County Voters:

A year ago, in this space, I expressed confidence that Washington was well positioned by years of experience to conduct a fair and comprehensive election. ## Ballots mailed by July 16

### Top 2 Primary

The purpose of the Primary is to reduce the number of candidates to two for the General Election.

- Voters may vote for any one candidate in each contest.
- Voters are voting for candidates, not choosing a political party's nominees.

The two candidates that receive the most votes in the August Primary advance to the General Election. Candidates must receive at least 1 percent of the total votes cast for their position in order to be placed on the General Election ballot

### Nonpartisan Offices – Primary

A Primary is held if three or more candidates file for a nonpartisan position. If no more than two candidates file, they appear only on the General Election ballot in the order determined by lot.

### Military, Overseas and Early Ballots

If you are a military or overseas voter or if you believe your ballot will not be received in time to vote, you may request to receive your ballot by email or request an early ballot up to 90 days before an election. Early ballots list only the contests known at the time of the request. To request an email ballot or early ballot, visit: [kcowa.us/elections](http://kcowa.us/elections) or contact Kitsap County Elections.

### Your Right to Privacy

Every voter has the right to vote his or her ballot in secret. A person voting when he or she is not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

### Questions or Need a Replacement Ballot?

If you have not received your ballot by **July 22**, or if your ballot is damaged or lost, you may request a replacement ballot by contacting Kitsap County Elections.

### Write-Ins – Which Votes Can Be Counted

Primary Election write-in votes can only be counted if:

- The candidate filed a Declaration of Write-in Candidacy, and;
- In a Primary there are enough write-in votes for a candidate to come in second, or in a General Election enough votes for a candidate to win.

### Candidate and Committee Statements

The Local Voters' Pamphlet includes statements submitted by candidates running for offices and committees supporting or opposing ballot measures. Statements printed in this pamphlet are the opinions of the authors. Kitsap County Elections is not responsible for the content of statements or their factual and grammatical accuracy.

## Register to Vote

### Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal resident of the state of Washington.
- 18 years of age by the next election.
- Not under the authority of the Department of Corrections for a Washington felony conviction.
- Not disqualified from voting due to a court order.

### How to Register

- Online at [www.votewa.gov](http://www.votewa.gov).
- Complete a mail-in registration form available at libraries, city halls, public schools, fire district offices and at the County Auditor's Office.
- When you renew your driver's license.

### Update Your Voter Record if You Move

If you are already registered to vote in Kitsap County, update your voter record online at: [www.votewa.gov](http://www.votewa.gov) through July 26. You may also email the Kitsap County Auditor – Elections Division at [auditor@co.kitsap.wa.us](mailto:auditor@co.kitsap.wa.us) or call 360-337-7128. Address changes can be made in person until 8 p.m. on Election Day at the Kitsap County Auditor's Office and at the Vote Centers. Dates and locations are on page 23. A new voter registration card will be mailed after your address change is processed.

### When to Register

Individuals may register to vote at any time. To vote in the August 3 Primary, the deadlines are:

- **July 26:** Deadline for **mail and online** voter registrations, updates and changes.
- **August 3: In-person** deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at the County Auditor's Office. Registration will also be available the Saturday (July 31) and Monday (August 2) before Election Day and on Election Day at the Vote Centers at the Marvin Williams Recreation Center and the Poulsbo Fire Station.

### Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.


### To Cancel Your Voter Registration

You must sign a form requesting to cancel your registration. In the case of a deceased voter, a family member may sign a form authorizing a cancellation. The form is available by contacting the Kitsap County Auditor's Office or at <https://www.kitsapgov.com/auditor/Documents/CancellationForm.pdf>.

# Mark and Return Your Ballot


## How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice. **Do not use pencil.** Mark one choice in each contest. If you mark more than one choice, no votes will be counted for that contest.



## Secure

Place the voted ballot in the secrecy sleeve. Place the secrecy sleeve inside the lavender return envelope.



## Sign, Date and Seal

Read, sign and date the Ballot Declaration on the lavender return envelope.

- The lavender return envelope must be signed by you in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.



## Ballot Drop Boxes

Use one of the Kitsap County 24-hour ballot drop boxes listed on page 23.

Ballot drop boxes close at 8 p.m. on Election Day.



## Mail

Mail your ballot early enough to be postmarked on time. We recommend you mail your ballot by July 27, one week before voting ends.



## Ballot Marking Tips and Reminders

Ballot marking errors and writing in fake names require additional staff review, which slows down ballot processing. Help us improve efficiency by **avoiding** these common errors:

### Proposition No. 1 Continuation of Emergency Medical Services Property Tax Levy

The Board of Fire Commissioners of Central Kitsap Fire and Rescue adopted Resolution No. 21-15 concerning continuing a property tax levy to fund emergency medical services. For the purpose of providing emergency medical services, will the district be authorized to continue to impose a regular property tax levy of \$0.50 or less per \$1,000.00 of assessed valuation for each of six consecutive years, with collection starting in 2022?

### Argument For the Measure

Central Kitsap Fire & Rescue is asking voters to renew our community levy for Emergency Medical Service. Please *vote yes* for this life-saving service that many in our community need at one point in their lives.

This levy would renew for the *same* amount and *same* time period. The amount is \$0.50 per \$1,000 of assessed property value, or \$200 per year for the owner of a \$400,000 home. The time period is for six years just like we voted on last time.

*This is not a new tax.* This simply continues the EMS levy to fund ambulances, maintenance and fuel, paramedics, medical equipment and supplies. The EMS levy will expire at the end of the year if it is not renewed by voters. EMS calls account for 64 percent of all emergency calls our fire district receives. EMS calls have increased 24 percent in our fire district since we approved the last EMS levy in 2015.

Our fire district provides the highest level of emergency medical care possible. Most fire districts just offer Basic life support. CKF&R offers *Advanced* life support, which improves your or a loved one's chances of surviving a medical emergency, like a heart attack or stroke.

No one wants to have to call 911, but it's reassuring to know that you are getting the best care possible if you have to. Please *vote yes* on Proposition 1 and mail your election ballots by August 3.

### Rebuttal to the Argument Against

Central Kitsap voters first approved an EMS levy in the late 1980s. The last EMS levy approval was in 2015, and it will expire if not renewed again by voters. All levies – including renewals or funding increases – must be approved by voters. Revenue can only increase by 1% per year for our fire district, which is a state law. We are fortunate in our community that people recognize the importance of EMS to saving lives.

### Explanatory Statement *(Prepared by the Attorney for Central Kitsap Fire & Rescue as prescribed by law.)*

The proposed measure would provide uninterrupted continuation of a six-year EMS levy for Central Kitsap Fire and Rescue, to provide emergency medical care and services, including related costs for personnel, training for such personnel, emergency apparatus, equipment, and supplies needed for the provision of emergency medical care or services in an amount up to, but not exceeding, fifty cents (\$.50) per thousand dollars (\$1,000) of assessed value of property in the taxing district per RCW 84.52.069.

**Effect of the proposed measure, if it becomes law:** Central Kitsap Fire and Rescue adopted Resolution No. 21-15, which contains a proposition to be submitted to the qualified voters of the District for approval or rejection of the continuation of a property tax EMS levy to fund emergency medical services. If approved, Central Kitsap Fire and Rescue will continue the levy in the amount of fifty cents (\$.50) per thousand dollars (\$1,000) of assessed property value beginning in 2022 and collected each year after for a period of six consecutive years. Revenue collected by this EMS levy may only be used for emergency medical care or services and related costs.

### Argument Against the Measure

There is no disputing CKFR EMS is essential. This argument is against rolling “temporary” extra levies as a loophole circumventing limits on property taxes proscribed by state law. This measure imposes additional taxes beyond the limits of the core budget to provide for public safety, a core government mission.

Prior to the first EMS levy in 2015, EMS was funded with core property taxes. It's misleading to say another “temporary” extra levy outside the limits of the core budget is not a new tax: it's a continuation of a new “temporary” tax first levied in 2015.

Kitsap government imposed total levies of \$394,371,000 in 2020. Its total tax revenue increased 26.4% between 2010 through 2019 on the back of 7.6% population growth. Kitsap households (including renters whose rent covers property taxes paid by landlords) must live within their means. It's bad enough that ballooning taxes disproportionately hurt residents on fixed incomes; it also demonstrates County government is not working to provide essential services within its means.

If tax loopholes for the rich are bad, so are revenue loopholes that increase property taxes. CKFD EMS is a core function and should be funded within the core budget, not outside the core budget, an approach that allows for funding non-core activities within the core budget. Kitsap County could return EMS funding to the core budget, but instead inappropriately prioritizes non-core spending within its core budget, resorting to this revenue raising loophole for core services. Vote “No.”

### Rebuttal to the Argument For

Voters have repeatedly rejected efforts to change constitutional property tax ceilings. In response, the State Legislature enacted levy lid lifts - for essential core services (schools, EMS) - to work around our protections; but each new/renewed lift requires us to agree. As a result, our taxes are increasing more than 3X faster than the County population. If it's \$200 per household, surely the County can find that among our ballooning taxes without a lid lift.

The proposed measure, for South Kitsap Fire and Rescue, is an uninterrupted continuation of a six-year EMS levy to provide for emergency medical care and services, including related costs for personnel, training for such personnel, emergency apparatus, equipment and supplies, needed for the provision of emergency medical care or services in an amount up to, but not exceeding, fifty cents (\$.50) per thousand dollars (\$1,000) of assessed value of property in the taxing district per RCW 84.52.069.

**Effect of the proposed measure, if it becomes law:** South Kitsap Fire and Rescue adopted Resolution No. 21-02, which contains a proposition to be submitted to the qualified voters of the District for approval or rejection of the continuation of a property tax EMS levy to fund emergency medical services. If approved, South Kitsap Fire and Rescue will continue its EMS levy for six additional consecutive years beginning in 2022 in the amount of fifty cents (\$.50) per thousand dollars (\$1,000) of assessed property value. Revenue collected by this EMS levy may only be used for emergency medical care or services and related costs.

**Argument For the Measure**

South Kitsap Fire and Rescue (SKFR) is seeking a renewal of the existing Emergency Medical Services (EMS) levy. This is not a new tax, but the continuation of an established funding source which has received the support of the citizens of South Kitsap since 1974 and has been renewed every six years. Establishment of the EMS levy has allowed SKFR to buy equipment and acquire personnel and training for its first paramedics. Today, the SKFR medic program delivers this critical service to the citizens of South Kitsap every day. SKFR responses totaled 10,845 in 2020 nearly 30 responses per day, and 70% of those responses were medical incidents. SKFR is the largest and busiest fire district in Kitsap County, serving over 72,000 citizens in the 117 square mile jurisdiction.

This levy will expire at the end of 2021, and if not renewed, would eliminate a significant source of revenue and cripple SKFR's ability to maintain the emergency medical services our community relies on. The EMS levy is the cornerstone of funding for a system that hires and trains EMS personnel, and purchases medical equipment, supplies, and vehicles necessary to provide these lifesaving services to the South Kitsap community. As citizens, it is vital to our emergency services to keep this funding for the fire district. The Fire District is grateful for the support of the citizens, has demonstrated good stewardship of these funds, and is asking to continue this service for its residents for the next six years.

**Rebuttal to the Argument Against**

Failure to renew the EMS levy will result in serious negative consequences to SKFR and the citizens it serves. The current EMS levy expires at the end of this year. If not renewed, SKFR won't collect any EMS dollars in 2022. EMS calls have increased by 21% since 2015. SKFR must pass the EMS levy in order meet the increasing EMS call demand and to fully fund SKFR's important life-saving mission. Vote "Yes" for EMS!

The Board of Commissioners of Bainbridge Island Metropolitan Park & Recreation District has adopted Resolution 2021-01 concerning restoring the regular property tax levy to its original rate.

If approved, this proposition would restore the 2022 levy rate to \$.75/\$1,000 to fund maintenance, repairs, renovations, operations, programming, and public use and access to District properties. For 2023-2027, the limit factor for calculating increases would equal inflation, measured by CPI-W. Qualifying low-income seniors and persons with disabilities would be exempt from the increases. Future levy limits would be based on the 2027 levy limit and such amounts would be available for any proper park district purpose.

**Explanatory Statement** *(Prepared by the Attorney for the Bainbridge Island Metropolitan Park & Recreation District as prescribed by law.)*

The Bainbridge Island Metropolitan Park & Recreation District is asking the voters to restore the District's regular property tax levy rate to the level of 75¢ per \$1,000 of assessed value, as originally approved by the voters when the District was created over ten years ago. Under the current levy lid, the levy rate declines as property values on Bainbridge Island increase, and as a result over time the levy rate has declined to approximately 59¢ per \$1,000 of assessed value. During this same time period the District's costs to operate and maintain its facilities, to build new trails and improve public access, and to provide the programs and recreational opportunities desired by the community have grown much faster than the 1% increase per year permitted under the current levy lid. Over the next several years existing revenues will not provide sufficient resources to support these costs. This projected shortfall is exacerbated by a dramatic reduction in programming revenue during the COVID-19 pandemic. The District's Board of Commissioners has determined that without restoration of this levy, the revenues available to the District in the future will not be sufficient to fund the level of services that the District provides and that the community has come to expect. Therefore, the Board deems it to be in the best interests of the District and the residents of Bainbridge Island to submit this levy lid lift proposition to the voters.

**Argument For the Measure**

It has never been more important for our community to ensure we have adequate space to gather, heal, play, preserve and learn. Voting Yes today creates a brighter tomorrow where generations can enjoy robust parks and recreation facilities which serve as the centerpiece of Island life.

Bainbridge Island Metropolitan Parks and Recreation District (BIMPRD) is a treasured island asset that engages residents of all ages and walks of life. Everyone benefits from programming spread across 40+ miles of trails; 25 parks; 76 acres of recreational shoreline; 104 acres of playground and athletic facilities; and 1400+ acres of natural areas.

Voting Yes assures the continued maintenance of existing facilities, trails, open space, and programming that enhances lives through social, physical, and emotional well-being. The last time BIMPRD asked the community for a Levy Lid Lift was 2008. Park land and programming has increased over 60% in 13 years despite a declining tax rate.
