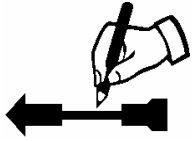


**SAMPLE BALLOT**  
Kitsap County, Washington  
Primary – September 20, 2005



**To vote:** Use a #2 pencil to connect the arrow by your choice with one dark single line.

**To make a correction:** Mark **X** through your error and re-mark your choice. Identifying marks will invalidate this ballot.

**To write-in a name NOT on the ballot:** Connect the arrow and write in the name of the candidate in the space provided.

**Political Party Abbreviations:** NP = Nonpartisan (not associated with any one political party).

**NOTE TO VOTERS:**

- This ballot contains all measures and races that will appear on the September 20, 2005 Primary ballot.
- Only the ballot issues that apply to the precinct where you are registered to vote will be counted.
- Polling locations will not be open. Your ballot must be post-marked no later than September 20, 2005 or taken to a ballot-drop location on Election Day between the hours of 7:00 a.m. and 8:00 p.m.

<b>Proposition No. 1</b> <b>0.15% Law &amp; Justice Sales Tax</b>	
This measure proposes a sales and use tax for law enforcement purposes. If approved, this proposition would authorize a countywide 0.15% sales and use tax, for a five-year period, to provide funds for law enforcement, crime prevention and law enforcement support activities in the County and the Cities of Bainbridge Island, Bremerton, Poulsbo and Port Orchard. Retail sales of motor vehicles and certain motor vehicle leases are exempt. Should this proposition be enacted into law?

Bainbridge Island Fire Department	
<b>Proposition No. 1</b> <b>Temporary Property Tax Limit Increase</b>	
This proposition concerns a temporary increase in the Bainbridge Island Fire Department's regular property tax levy. For the purpose of raising funds for apparatus, equipment, and facility repairs, this proposition would allow the Department to increase its current regular property tax levy up to a maximum of \$0.94 per thousand dollars of assessed value for the 2006 tax year and increase the levy subject to the limits of the chapter 84.55 RCW for each of the following five years or until this purpose has been accomplished, whichever occurs first. Should this proposition be enacted into law? (Pursuant to RCW 84.55.050 and Bainbridge Island Fire Department Resolution No. 26-2005)
