

# Primary Local Voters' Pamphlet – August 7, 2018



Dear Voter:

This year we are happy to tell you of three changes we think will make voting even easier for you.

1: **The Pamphlet is mailed earlier:** Around July 20, 2018, you should receive your ballot for the August 7 Primary. We mailed this Local Voters' Pamphlet in advance of that date to give you time to read the candidate statements well before you vote. That extra time is especially important during the summer months, when many of us have travel plans.

2: **Convenient locations:** We now have ballot drop boxes in every corner of the county. Ballot drop boxes allow voters to easily return ballots in secure locations dedicated to elections. Ballots are retrieved by elections workers hired by the county and returned directly to the Auditor's Office. This year we will have 22 drop boxes, an increase of 15 in just three years. To find the location closest to you, refer to the list on page 3 of this pamphlet.

3: **Free postage:** If you prefer mailing your ballot, this year you don't have to put a stamp on the envelope. Thanks to funding provided by the state for this year's elections, voters in all 39 counties will be able to return their ballots without paying for postage.

Because Washington is a Top 2 Primary state, your vote will help decide which two candidates in each race will appear on the November ballot. In addition to the 29 candidates for U.S. Senate, there are primary races for the U.S. House of Representatives, State Legislature, County Offices and the Kitsap County Public Utility District.

Your vote has a lot of influence, especially on local races. Thank you for making Kitsap County a great place to live and work!

## Voter Information

### Top 2 Primary

The purpose of the Primary is to reduce the number of candidates to two for the General Election.

- Voters may vote for any one candidate in each contest.
- Voters are voting for candidates, not choosing a political party's nominees.

The two candidates who receive the most votes in the August Primary advance to the General Election. Candidates must receive at least 1 percent of the total votes cast for their position in order to be placed on the General Election ballot. It is possible that the two candidates who advance to the General Election prefer the same party.

In partisan races a Primary is held if at least one candidate files. In nonpartisan races a Primary is held if three or more candidates file. If no more than two candidates file, they appear on the General Election ballot in the order determined by lot.

### Military, Overseas and Early Ballots

If you are a military or overseas voter, or if you believe your ballot will not be received in time for you to vote, you may request to receive your ballot by email or request an early ballot up to 90 days before an election. Early ballots list only the contests known at the time of the request. ### Write-Ins – Which Votes Can Be Counted

Primary Election write-in votes can only be counted if:

- The candidate filed a declaration of Write-in Candidacy, and;
- In a Primary there are enough write-in votes for a candidate to come in second, or in a General Election enough votes for a candidate to win.

### Candidate and Committee Statements

The Local Voters' Pamphlet includes statements submitted by candidates running for offices. Statements printed in this pamphlet are the opinions of the authors. Kitsap County Elections is not responsible for the content of statements or their factual and grammatical accuracy.

### Your Right to Privacy

Every voter has the right to vote in secret. Voting when not qualified, or falsely signing the Voter Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both.

### Participating Jurisdictions

Districts participating in this Local Voters' Pamphlet are: Washington State, Kitsap County, Kitsap Public Utility District No. 1.

### Questions or Need a Replacement Ballot?

If you have not received your ballot by **July 26**, or if your ballot is damaged or lost, you may request a replacement ballot by contacting Kitsap County Elections.

## Political Party Information

### Major Political Parties

A political party qualifies as a "major" political party when it receives at least 5 percent of the total votes cast in any statewide office contest at the preceding state General Election in an even-numbered year. In 2018 Washington State has two major political parties: Democratic and Republican.

### Minor Political Parties

A "minor" political party is any political party in which no candidate for statewide office received at least 5 percent of the total votes cast at the preceding General Election during an even-numbered year.

### Candidates for Partisan Office

A candidate may state on the ballot a political party that he or she prefers. A candidate may choose to not state a party preference. A candidate's party preference does not imply that the candidate is nominated or endorsed by the party or that the party approves of or associates with that candidate.

### Contributions to Candidates and Political Committees

- **Contribution Limits** – State law sets contribution limits on donations to legislative, judicial and county candidates as well as bona fide political party and caucus political committees.
- Anyone who donates more than \$25 in monetary and in-kind contributions must be identified by name and full address. For donations of more than \$100 – occupation, employer name, city and state of his/her employer are also required.

### Precinct Committee Officer

A Precinct Committee Officer is a partisan office that is an elected or appointed member of a major political party. Precinct Committee Officers elect a chair and vice-chair of their party's county and legislative district central committees.

At the time of filing for office, candidates must be registered to vote in the precinct represented by the office they seek. Precinct Committee Officers are elected in the Primary.

Precinct Committee Officer contests only appear on the ballot if two or more candidates from the same party file for that office.

**For this office only:** In order to vote for precinct committee officer you must affirm that you are a Democrat or a Republican and may vote for only one candidate from the party you select. Your vote for a candidate affirms your affiliation with the same party as the candidate. This preference is private and will not be matched to your name or shared.

## Register to Vote

### Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal resident of Washington State at least 30 days before Election Day.
- At least 18 years old by Election Day.
- Not disqualified from voting due to a court order.
- Not under Department of Corrections supervision for a Washington felony conviction.

### Voter Registration Rule Changes

In 2018 new legislation passed in Washington State that will not be in place during elections this year, but will take effect on July 1, 2019.

- New Washington State voters may register to vote in person at the county auditor's office or at a designated Vote Center until 8 p.m. on Election Day.
- Voters already registered in Washington State will be able to update their voter address until 8 p.m. on Election Day.
- Washington State residents age 16 and 17 will be able to pre-register to vote. Those registrations will remain in pending status until the resident turns 18 years old.

### How to Register

- Online at [www.myvote.wa.gov](http://www.myvote.wa.gov).
- Complete a mail-in registration form available at libraries, city halls, public schools, fire district offices and at the County Auditor's Office.
- When you renew your driver's license.

### When to Register

Individuals may register to vote at any time. The deadlines to vote in the August 7 Primary are:

- **July 9:** Deadline for **mail and online** voter registrations, updates and changes.
- **July 30:** **In-person** voter registration deadline. Citizens not currently registered in Washington State may register until eight days prior to an election by appearing in person at the County Auditor's Office.

### Update Your Voter Record if You Move

If you are already registered to vote in Kitsap County, you may update your voter record online at [www.myvote.wa.gov](http://www.myvote.wa.gov), or by contacting Kitsap County Elections.

A new voter registration card will be mailed after your address change is processed. New address changes cannot be processed during an election cycle, which begins 29 days before Election Day and ends upon certification.

### Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.

### To Cancel Your Voter Registration

You may provide a signed request to cancel your registration. In the case of a deceased voter, a family member may provide written and signed authorization to request cancellation.

## 24-Hour Ballot Drop Boxes

A voter who does not wish to return a ballot by mail may use a ballot drop box. Ballot drop boxes provide a safe, secure way for voters to deposit their ballots.

Ballot drop boxes are available 24 hours a day beginning July 20, until 8 p.m. on Election Day.

## Vote Centers and Accessible Voting

Federal law requires jurisdictions to provide vote centers with certified accessible voting devices that enable voters with disabilities to cast their ballots independently and in private.

Accessible Voting Units provide all contests in audio and high-contrast text formats and are available beginning 18 days prior to the Primary Election.

### Online Ballot Access

Kitsap County Elections provides an accessible online ballot and Local Voters' Pamphlet, allowing voters to access their specific ballot using the internet.

The online ballot is compatible with commonly used accessibility software, such as screen readers and screen magnifiers. All candidate video statements are close captioned.

Through Online Ballot Access, any voter may verify that Kitsap County Elections has received their ballot using the Ballot Tracker feature.

## Mobile Voting Locations

Kitsap County Elections transports Accessible Voting Units and ballot drop boxes to locations throughout the county.

Locations are chosen where voters with disabilities, senior citizens and others will benefit from the use of an on-site Accessible Voting Unit, printable ballot, or ballot drop box.



# Mark and Return Your Ballot

## How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice. **Do not use pencil.** Mark one choice in each contest. If you mark more than one choice, no votes will be counted for that contest.



## Secure

Place the voted ballot in the white secrecy sleeve.


Place the white secrecy sleeve inside the lavender return envelope.



## Sign, Date and Seal

Read, sign and date the Voter Declaration on the lavender return envelope.

- The lavender return envelope must be signed by you in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.



## Mail

Mail your ballot early enough to ensure it is postmarked no later than Election Day, August 7. For the 2018 Primary and General Election, no postage is required.

Ballot drop boxes close at 8 p.m. on Election Day.







Finally, we need to ensure that social programs are supported at the local level so that parents and families can have confidence in a future that is guaranteed to have predictable challenges.

*Faith:* we need to create dialogue so that people do not feel alone. We need to be able to step into the unknown with confidence that answers will come. Married 32 years, we have raised a family of 10 children (5-boys/ 5 girls) teaching them to move forward in Faith. We worked to become debt free, only to see our fortunes lost as conditions beyond our control wiped out what we once enjoyed. We are aware of the discussion that needs to occur regarding Mental Health and support within our communities.




