The purpose of this addendum is to answer questions regarding the RFP.

1. For **Adult Drug Court**:
 - a. What percentage of tests are *billed to/paid by insurance or MCOs*? (“Third Party Billing”) – **The majority (as a very broad estimate, 2/3’s).**
 - b. What percentage of tests are *billed to/paid by the County*? (“Direct Bill”) – **0%**
 - c. What percentage of tests are *billed to/paid by Salish Behavioral Health Administrative Services Organization (SBHASO)*? – **Whatever is not covered by insurance or MCO (again, very broad estimate, 1/3).**
 - d. What percentage of participants are **non-Medicaid-eligible**? – **Very few, maybe as few as 5%. Efforts are made at program entry to get drug court participants enrolled for Medicaid.**
 - e. What percentage of participants are **Medicaid-eligible**? – **The vast majority, maybe as much as 95+%**
2. For **Veterans Treatment Court**:
 - a. What percentage of tests are *billed to/paid by insurance or MCOs*? (“Third Party Billing”) – **0%**
 - b. What percentage of tests are *billed to/paid by the County*? (“Direct Bill”) – **Right now, 100% w/ CJTA funding, but under terms of CJTA contracts, this will change with a new bid contract (see “c” below).**
 - c. What percentage of tests are *billed to/paid by Salish Behavioral Health Administrative Services Organization (SBHASO)*? - **Right now, 0%, but going forward 100% w/ CJTA funding under terms of State CJTA contract.**
 - d. What percentage of participants are **non-Medicaid-eligible**? - **100%**
 - e. What percentage of participants are **Medicaid-eligible**? – **0%**
3. Can the County please provide a **comprehensive** list of all payers and MCOs that **may** be billed for services under the resulting contract? **In its first year, it is the Court’ expectation that the vast majority of costs will be paid via MCO’s and, where Medicaid ineligible, supplemented by the SBHASO using CJTA funding. Based on 1st year cost activity, the Court will determine whether a 3rd funding source (the County via the Court) is necessary.**
