The Kitsap County Board of Commissioners will receive sealed bids for the construction of the **Silverdale Conveyance System and Pump Station 4 Upgrades** until the time and date indicated above. Bids will be received, publicly opened, and read aloud at the location described above. Instructions for the delivery of bids are contained in the Special Provisions for the Project. Prospective Bidders are hereby notified that they are solely responsible for ensuring timely delivery of their bid to the Kitsap County Purchasing Office on or before the bid submission date and time indicated above.

Principal items or elements of construction include:

- Installing cleanouts on existing sanitary side sewers.
- Installing approximately 500 feet of 15-inch gravity sewer main appurtenances.
- Installing approximately 2,050 feet of 12-inch and 20-inch sewer force main appurtenances.
- Upgrading sewer Pump Station 4. The upgrades include:
 - o Constructing a new wet well to house 3 new submersible pumps,
 - Converting and extending the existing dry well to accommodate the new piping, isolation valves, check valves, flow meter, and pig launch,
 - o Converting the existing wet well into overflow storage,
 - Replacing the existing control building with a new control building to contain the power, control, and telemetry systems,
 - Site work including grading, new retaining walls, new access driveway, new sidewalk stormwater conveyance facilities, odor control facilities, and a backup diesel generator.
 - Installing, maintaining, and removing temporary sewer bypass pumping system(s) during construction.
- Street restoration.
- Traffic control.

A mandatory pre-bid meeting will be held at the location described above and will include a tour of Pump Station 4. This will be the only tour of the site.

Each bid proposal shall be completely sealed in a separate envelope, properly addressed as stated above, with the name and address of the bidder and the name of the project plainly written on the outside of the envelope. All bids shall be accompanied by:

- County Bid Proposal as published in Invitation to Bid.
- Signed acknowledgment of receipt of all addenda.
- Surety company Bid Bond on an approved form, certified check, or cashier's check payable to Kitsap County in an amount not less than five percent (5%) of the basic Bid.
- Subcontractor's List.
- Bidder Information.
- Bidder Responsibility Checklist.
- Subcontractor Responsibility Checklist.
- Non-Collusion Affidavit.
- Certification of Compliance with Wage Payment Statutes.

Should the successful bidder fail to enter into such contract in accordance with the Bid and furnish all documents and bonds required within the time frames stated in the specifications, the bid proposal deposit or bond shall be forfeited to Kitsap County.

Bids are likely to be rejected if the lowest, responsible, responsive Bid received exceeds the Engineer's estimate by an unreasonable amount.
