INTERLOCAL COOPERATIVE PURCHASING AGREEMENT **BETWEEN** KITSAP COUNTY & THE CITY OF SEATTLE

This Cooperative Purchasing Agreement (Agreement) is entered into by Kitsap County, a municipal corporation, having its principal offices at 614 Division Street, Port Orchard, Washington, 98366 (County) and the City of Seattle, a Washington municipal corporation, having its principal offices at 600 4th Ave, Seattle, Washington (City).

SECTION 1. **PURPOSE**

In accordance with Chapter 39.34 RCW, the parties wish to establish a cooperative governmental purchasing agreement for various supplies, materials, equipment and services whereby one party may use the other party's competitively awarded contracts.
