INTERSTATE COMPACT BENCHCARD

1. Travel Restrictions

- ICAOS. A defendant being supervised on a suspended sentence due to a conviction for any "qualifying offense" is prohibited from residing or relocating outside the state of Washington without prior approval of Kitsap County District Court and the Interstate Compact for Adult Offender Supervision Commission. RCW 3.66.140; RCW 9.94A.745.
- <u>Definition</u>. A "qualifying offense" is defined by ICAOS Rule 2.105 as
 - Harm. An offense in which a person has incurred direct or threatened physical or psychological harm; or
 - Firearm. An offense that involves the use or possession of a firearm; or
 - <u>DUI 2+</u>. A second or subsequent conviction for driving while impaired by alcohol or drugs [Note A travel restriction <u>does not apply</u> to a conviction for physical control; or conviction of an offense amended from DUI; or a deferred prosecution]; <u>or</u>
 - <u>Sex Offense</u>. A sexual offense that requires the defendant to register as a sex offender in Washington.
