18-05021: Pregartner and Miller, Conditional Use Permit - Accessory Dwelling Unit (CUP-ADU)

Project Description: Conditional use permit to build an 875 square foot Accessory Dwelling Unit (ADU). The ADU is accessory to an existing 2,082 square foot single family residence. The proposed ADU will be designed to maintain the same appearance as the residence in siding, roof pitch, materials, and color as the primary residence. In addition to the conditional use permit for the ADU, other associated development permits will be required, including a building permit.

AGENDA ITEM (B) 18-01521: Suquamish Tribe (Suquamish Seafood Enterprises), Shoreline Substantial Development Permit (SSDP)

Project Description: Applicant proposes to replace and expand an existing salt-water intake to improve wet storage reliability and capacity for the expanding business. Intake pipes will be mostly located on state-owned aquatic lands. The two 8" diameter PVC will be laid in the same trench as the existing, 4" single intake pipe, with an estimated 70 cubic yards of fill. Intake lines will be 610 feet in length, of which 460 feet will be buried in a trench across the tidelands. The remaining 150 feet will be below extreme low tide

on the sea floor and anchored to the screened intake. The pump for the intake will be above Ordinary High Water Mark and on Tribal Trust Lands (not under the jurisdiction of the Shoreline Management Act).
