17-02233: Bakker's Hillside Estates - Preliminary Plat Amendment Major

Project Description: The Hearing Examiner approved the Bakker's Hillside Estates preliminary plat April 17, 2007. This revised amendment encompasses the entire original area except for the lot segregated out through a boundary line adjustment; there is no distinction between Division 1 and Division 2 and the reference to divisions have been eliminated. The revised amendment changes access from 1 access point to 3 access points now, reduces the overall number of lots from 75 to 60, all lots to be developed with a detached single-family residence, and changes the lot layout/configuration and open space/recreational facility location. The project would be served by public water and sewer.
