Program Technician Proposal

Assumptions:

Term: October 2024 - December 2026

Hourly Rate = \$31.95 (Step 12)

1.0 FTE = \$66,456

Fully loaded = \$96,433 (Includes salaries, benefits, and indirect; 6% annual increase - steps, wage adj, benefits, etc.)

Noxious Weed Control Program Duties at 0.25 - 0.30 FTE

- Support outreach and education
- Develop brochures and pamphlets
- Update project website
- Monitor and track phone calls, emails, See Click Fix reports
- Research information (with confirmation from NW Coordinator) and provide response to landowners
- Support meeting scheduling, note taking, and hybrid meeting management

Rapid Assessment and Monitoring Proposal

Proposal: Request additional funds from program surplus to conduct rapid assessment of noxious weeds in 2025 and continue monitoring through 2026.

Options: 1-2 full-time positions (Botanist, Program Tech) or contract out to third party.

The Botanist position would likely be more expensive than what is detailed here. Waiting on HR to get back to us.

City of Bainbridge Island Compliance & Policy

- Ordinance 2003-15 restricts use of pesticides by city employees and on city property
- Exceptions made on occasion to tackle priority projects
- Public Works cites this as their largest barrier to controlling noxious weeds on city property
- Letter penned by Dylan was sent to Director of Bainbridge Island Public Works
- July City Council meeting heard request to allow use of certain herbicides Triclopyr & Imazapyr
- City Council tabled the discussion, requesting more information before making decision

Integrated Pest Management Policy

- Met in early July with IPM working group (Wendy and Jess) to kick-off process
- Discussed goals for document:
 - Clear prioritization of species, land types, control strategies with detail on how these priorities are determined
 - Clear process for board/coordinator to deal with weeds in each defined setting (private property, county land, cities, state land, tribal land, rights-of-way, etc.)
 - Clear enforcement process
- Reworked "Goal Statement" and elements of the policy at high level, following state IPM law –
 RCW 17.15
- Working group to meet again later this month to begin fleshing out elements
- Coordinator continuing to review IPM examples from other jurisdictions (City of Bremerton, Thurston County, WSDA, etc.)

Education and Outreach

- Met in early July with Outreach working group (Courtney and Dylan) to kick-off process
- Outlined some high-level outreach goals
- Plan to attend at least one farmer's market in each board member's district by end of season
- Working on new outreach material Species Spotlight flyer

Mapping

- Brief overview of latest map developed by our GIS analyst
- Hand off to Dylan to discuss his mapping slides





Discussions with County Roads Department and City of Port Orchard

- Roads department does not have the equipment or capacity to stay on top of weeds beyond annual broadcast spray
- City of Port Orchard in midst of Public Works restructure, but similarly notes it does not have the people, equipment, or capacity to treat majority of noxious weeds
- On-call contract likely best option to deal with weeds on county lands, rights-of-way, and adjacent private properties
- Could potentially include other jurisdictions without capacity
- County departments and other jurisdictions could pay for services through interlocal agreements
