## PROGRAMMATIC DETERMINATION OF NONSIGNIFICANCE

Description of Proposal: 2025 Kitsap County Public Works Sewer Utility Sanitary Sewer Construction Standards Update under Kitsap County Code Title 13. Kitsap County Public Works Sewer Utility Division Standards identify construction standards for future sanitary sewer extensions or replacements in Kitsap County, which will be reviewed separately under SEPA authority for any proposed project. Kitsap County, with the help of their consultant, BHC Consultants, is updating their Sewer Construction Standards to make them consistent with current construction techniques, operations and maintenance processes, and administrative practices. The Sewer Standards have been made consistent with:

- Washington State Department of Ecology "Criteria for Sewage Works Design"
- Washington State Department of Health Requirements
- WSDOT Standard Specifications
- Kitsap Public Health Department Requirements
- Kitsap County Road Standards
- Kitsap County Department of Community Development (DCD) processes

The Sewer Standards set forth minimum standards for the planning, design, and construction of sanitary sewer facilities in Kitsap County, which have also been updated to streamline the review and inspection process for new developments connecting to the Sewer Utility's sewer system.

**Location of proposal:** The Sewer Standards set forth minimum standards for the planning, design, and construction of sanitary sewer facilities within the Kitsap County operating area. The Sewer Standards do not propose development of any specific site; any future development proposed in alignment with these Standards will be reviewed separately under SEPA project review.
