 - HPA Permit covered under DNR's blanket permit



Vessel Tracking Database

- Identified user/access needs
 - Authorized Public Entities, DNR
 - Considering Public Disclosure Requirements & Confidential Information
 - Working with County prosecutor's office
 - Considering different access level for law enforcement
 - Mobile app is needed

Vessel Tracking Database

- Identified data/information needs
 - Hull number, tab number, Hull ID Number, description: type, color, material, length, motor, identifying characteristics.
 - Lat/Long
 - Records of contact / interaction

Vessel Tracking Database

- Reporting Tool- use DNR's tool (DART), See-Click Fix, and Kitsap1
- DNR offer to share their reporting tool with Kitsap County
 - Access would be provided to APEs
 - Potential for different access levels (ie law enforcement)
 - Kitsap County would host; DNR would send updates
 - Currently exploring access / information sharing needs/rules

Legislative, Policy, & Enforcement

Members: Brittany Gordon (DCD), Kirvie Mesebeluu-Yobech (DCD), Daria Etchings (DCD), James Weaver (Port of Bremerton), TJ Quandt (Port of Kingston), Tim Schermetzler (CSD Law), Trey Holden (Port Orchard PD), Tami Griffey (DCD), Troy Wood (DNR), Robert Ballard (Port of Manchester), Jason Hedstrom (KSO), Ryan McGovern (KSO)

- Identified many legal challenges & barriers for enforcement and ADV removal
- Identified need for engagement from Prosecutor's office
 - DCD Enforcement lacks legal representation
- Met with KSO legal representation
 - Scheduled for monthly coordination meetings with prosecutors

Legislative, Policy, & Enforcement

- Improve inter-agency coordination for enforcement:
 Discussed Interlocal Agreement (ILA) for Kitsap County APEs to recognize and enforce each other's notices.
 - Standardizing a process for mutual aid and authority sharing similar to fire districts.
 - Unifying tracking tools, such as a database for vessel movements and a seaworthiness checklist.
- Addressing live-aboard situations

Legislative, Policy, & Enforcement

- Legislative & Policy Changes
 - Consider local code/ordinances
 - Consider auction requirements- minimum bid, insurance, registration
 - For DNR reimbursement, we must remain in compliance with state statute
 - Expedited vessel seizure & removal
 - Consider changes to abandoned & derelict definitions in statute
 - Consider including vessels unregistered for >1 year and/or with no identifying markers
 - Consider seaworthiness
 - Once abandoned/derelict, require registration and identification to come into compliance

- Identified key partners & roles
- Identified facilities with boatyard NPDES permits
 - Linden Salvage (Mason County) & Yachtfish Marine
 - Coordinating with these potential options
- Learning from Port of Everett VTIP Event planning
- Planning for vessels <35 feet; larger vessels can still register and will be directed to DNR VTIP Program
- Planning for VTIP event spring 2026

Vessel Turn-In Program Event

- o Advertising, advanced registration & tracking
- o Coordinating vessel deliveries by land and water
- o Vessel staging
- o How many boats can realistically be processed per day?
- o Event timing & duration
- o Prioritization criteria
- o What procedures need to be in place for removing hazardous and household waste?
- o Contracting questions- boatyard, towing, hazardous waste, blackwater pump-out
- o Cost estimates
- o What kind of administrative burden or capacity will be required from the sponsoring organization?
- o How do we secure funding, and what are potential funding sources?
- o Inter-Agency Agreement with DNR
- o Communicating expectations
- o Measuring success
