3 main problems

- 1. Boats anchored on SOAL that overstay and break anchor and float away.
- 2. People abandoning boats on private docks.
- 3. Problem with derelict definition- you must know who owner is.

Goals:

Improve enforcement tools

Shorten timeline for vessel removal to prevent sinking, breaking loose, etc

Legislative, Policy, & Enforcement

Proposed statute change:

RCW 79.100.010

- (5) "Derelict vessel" means the vessel's owner is known and can be located, and exerts control of a vessel that is a vessel that:
- (a) Has been moored, anchored, or otherwise left in the waters of the state or on public property contrary to RCW <u>79.02.300</u> or rules adopted by an authorized public entity;
 - (b) Has been left on private property without authorization of the owner; or
 - (c) Has not been registered for a period of at least two years; or
 - (de) Has been left for a period of seven consecutive days, and:
 - (i) Is sunk or in danger of sinking;
 - (ii) Is obstructing a waterway; or
 - (iii) Is endangering life or property.

Legislative, Policy, & Enforcement

Under this change, more vessels will qualify as derelict, rather than abandoned, which is beneficial because:

- Reduces ambiguity
- Quicker vessel seizure reduces risks to safety or environment
- Note: Both abandoned and derelict vessels can be made safe in an emergency.
- For abandoned: 30-day observation (within 1 anchorage within 5 miles), vessel is posted, 15-day notice (custody process, which includes time for owner to come into compliance).
- Under derelict, vessel can be declared derelict immediately if it meets the listed criteria. and it is a 2-week custody process.
- Often, owner on report of sale with DOL is not accurate; however, if there is a report of sale DNR does not hold last registered owner accountable.
