 Project updates: County updates will focus on informing community members about project status, the process with the Planning Commission and the Board of County Commissioners, how you can participate at key project milestones, and briefly review the staff report released on July 30, 2021 and the Final Draft Ordinance released on January 12, 2022.

• Community Q&A: County staff will respond to community questions about the process, timeline and available documents for the Zoning Use Table Update, as well as upcoming public comment opportunities. Please note, to be included in the record for consideration by the Kitsap County Board of County Commissioners, comments on the Department's Final Draft Ordinance (released on January 12, 2022) need to be submitted to the County through the formal public comment process. The first comment period for consideration by the Board of County Commissioners is from January 24, 2022 through the Board of County Commissioner's public hearing scheduled on February 14, 2022.

Please note that participants will be able to see and hear the presenters when they are speaking but will not have video or audio capabilities during their presentation. There will be an opportunity during the Q&A portion of your meeting to submit and ask your questions verbally.

What you will need

To join the meeting by computer

- 1. At the start time of your meeting, enter the link to join via computer. Please note, you may be instructed to download the Zoom application if you haven't used Zoom before. You may also join a meeting without the link by going to join.zoom.us on any browser and entering the Webinar ID provided above.
- 2. You have an opportunity to test your audio at this point by clicking on "Test Computer Audio." Once you are satisfied that your audio works, click on "Join audio by computer."
