<b>Recommended Action:</b> 1) Adopt the zoning use table ordinance and amendments identified in change matrix dated 3/14/2022.			
<b>Summary:</b>	<p>The Department of Community Development proposes an amendment to Kitsap County Code Title 17 'Zoning'. The primary goal of the Zoning Use Table Update is to reduce barriers to investment in Urban Growth Areas (UGA), Limited Areas of More Intense Rural Development (LAMIRD), and the rural commercial and rural industrial zones. The Kitsap County Planning Commission recommended adoption of the proposal to the Department on December 21, 2021. The Department invited interested parties to submit written comments beginning January 24, 2022 and attend a public hearing on February 14, 2022, where the Board held the public comment period open until February 21, 2022.
