**CONTRACT AMENDMENT**  
**B**

This Contract Amendment ("Amendment") is between Kitsap County, a Washington state political subdivision, having its principal offices at 614 Division Street, Port Orchard, Washington 98366 ("County") and Kitsap County Superior Court Juvenile Department, having its principal office at 1338 SW Old Clifton Road, Port Orchard, Washington, 98367 ("Contractor").

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-117-22 ("Contract") executed on March 14, 2022, and amended on January 23, 2023 is amended as follows:

1. SECTION 1. EFFECTIVE DATE OF CONTRACT: Is amended as follows:  
January 1, 2022 – December 31, 2024.
2. ATTACHMENT C: BUDGET SUMMARY: Is deleted entirely and replaced with the attached.

Terms Unchanged. Except as expressly provided in this Amendment, all other terms and conditions of the original Agreement, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.




