

CONTRACT AMENDMENT
A

This CONTRACT AMENDMENT is made and entered into between KITSAP COUNTY, a municipal corporation, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "COUNTY", and Gather Together Grow Together, hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-121-21, executed on 02/10/2021, shall be amended as follows:

1. Section 1. Term and Effective Date shall be revised as follows:

Contract is extended from 12/31/2021 to 12/31/2022 for a new contract term of 02/08/2021 through 12/31/2022.

2. Attachment A: Scope of Work shall be revised as follows:

Fee for service, not to exceed \$50,000 for the period of 01/01/2022 through 12/31/2022

3. Attachment B: Compensation shall be replaced in its entirety:

Pricing for Transportation for Severe Weather Shelter and for Quarantine and Isolation Meals are updated as indicated in attachment.

4. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

This amendment shall be effective upon execution by the parties.


