

**CONTRACT AMENDMENT
B**

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBH-ASO", and Serenity House of Clallam County hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-133-20, executed on April 13, 2020, and amended on August 24, 2020 shall be amended as follows:

1. Page 1 shall be amended as follows:

- **Contract Amount** remains the same at \$255,590.
- **Contract end date** for SABG support funding is extended from September 30, 2020 to June 30, 2021. New contract period for SABG support funding is July 1, 2020 to June 30, 2021.
- **Attachment B-5:** HARPS SABG Statement of Work is deleted and replaced as attached.
- **Attachment C: Budget** is deleted entirely and replaced as attached.

SABG Support Funds

7/1/20-6/30/21 funding remains the same at \$2,500

2. If this Contract Amendment extends the expiration date of the Contract, then the Contractor shall provide an updated certificate of insurance evidencing that any required insurance coverages are in effect through the new contract expiration date. The Contractor shall submit the certificate of insurance to:

Upon receipt, the Human Services Department will ensure submission of all insurance documentation to the Risk Management Division, Kitsap County Department of Administrative Services.

3. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

This amendment shall be effective July 1, 2020.





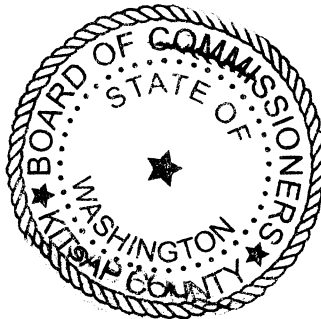

SOW Services for HARPS Substance Abuse Block Grant

Revised March 3, 2021

1. **Statement of Work.** The Contractor must provide recovery supports to individuals who meet HARPS eligibility and have a substance use disorder. Recovery supports are provided to support access to treatment services. Contractors will consider priority populations listed in 2 below. Recovery supports will be provided as listed in items 3 and 4 below.

2. **HARPS Priority Populations**
 - a. Pregnant women and women with dependent children
 - b. Intravenous drug users
 - c. Tuberculosis services
 - d. Early intervention services for HIV/AIDS
 - e. Primary prevention services

3. **Basic Needs**
 - a. Food – gift cards in small amounts for use before/after treatment appointments or prevention activities
 - b. Minutes on phones - if being used for telehealth appointments related to treatment or prevention activities

4. **Transportation**
 - a. Bus Passes, Ferry Passes, Light Rail Passes, ORCA Cards in order to attend treatment or prevention activities
 - b. Gas voucher – small amounts only in order to attend treatment or prevention activities
