

## **CONTRACT AMENDMENT B**

This CONTRACT AMENDMENT is made and entered into between **OLYMPIC CONSORTIUM, through Kitsap County, its administrative entity**, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "**CONSORTIUM**", and Olympic Educational Service District 114, hereinafter "**CONTRACTOR**."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-341-24, and executed on June 24, 2024 , shall be amended as follows:

1. Attachment A-Special Terms and Conditions: Updates Section B, 2 – Audit Requirement, increasing the audit threshold from \$750,000 to \$1,000,000.
2. Attachment B-Statement of Work: Updates Section B - Additional Requirements, 2 – to align with the federal waiver, allowing a minimum expenditure of 50% of PY24 and PY25 WIOA Youth formula funds on out-of-school youth.
3. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.
