
This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

A. Maximum consideration is increased by \$92,080 for Senior Farmers Market Nutrition Program (SFMNP) voucher allocation—AAA non-expenditure, for a new maximum consideration of \$5,156,004.
