CONTRACT AMENDMENT

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBHASO", and Kitsap Recovery Center, hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-491-20, and executed on January 11, 2021, shall be amended as follows:

1. Page 1: Contract Term is amended as follows:

January 1, 2021 – December 31, 2022.

2. Page 1: Amount is amended as follows:

\$209,475

3. Attachment A: Special Terms and Conditions as follows:

The following term is added as to Section 6. Federal Block Grant:

- f. FBG funds may not be used, directly or indirectly, to purchase, prescribe, or provide marijuana or treatment using marijuana. Treatment in this context includes the treatment of opioid use disorder. FBG funds also cannot be provided to any individual or organization that permits marijuana use for the purposes of treating substance use or mental disorders. See, e.g., 45 C.F.R. § 75.300(a), 21 U.S.C. §§ 812(c)(10) and 841 (prohibiting the possession, manufacture, sale, purchase or distribution of marijuana). This prohibition does not apply to those providing such treatment in the context of clinical research permitted by the DEA and under the Federal Drug Administration (FDA)-approved investigational new drug application where the article being evaluated is marijuana or a constituent thereof that is otherwise a banned substance under federal law.
- 4. Attachment B1: Statement of Work- Substance Use Disorder Residential is added.
- 5. **Attachment B2: Statement of Work-** Substance Use Disorder Withdrawal Management is added.
- 6. Attachment C: Budget is deleted entirely and replaced as attached.

7. If this Contract Amendment extends the expiration date of the Contract, then the Contractor shall provide an updated certificate of insurance evidencing that any required insurance coverages are in effect through the new contract expiration date. The Contractor shall submit the certificate of insurance to:

Upon receipt, the Human Services Department will ensure the submission of all insurance documentation to the Risk Management Division, Kitsap County Department of Administrative Services.

8. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

This amendment shall be effective January 1, 2022.

ATTACHMENT B1: STATEMENT OF WORK- Substance Use Disorder (SUD) Residential

I. PROGRAM DESCRIPTION

A. Eligibility

Persons eligible for SUD residential placement are those individuals who:

- Individual is not enrolled or eligible for Medicaid.
- Meet medical necessity based on ASAM placement criteria. The Salish BH-ASO will reimburse Subcontractor for services to eligible individuals who reside in the SBH-ASO.

B. Program-Specific Requirements

1. Licensing

- a. The Subcontractor is licensed by the Washington State Department of Health (DOH).
- The Subcontractor must maintain credentialing requirements set forth by SBH-ASO.

2. Residential Admissions:

- a. SBH-ASO is responsible SUD residential services for non-Medicaid, un/underinsured individuals residing in Clallam, Jefferson, or Kitsap Counties within available resources. Subcontractor shall work with other payors to determine their authorization standards. Individuals must meet the following criteria to be eligible for this level of care under the SBH-ASO.
 - i. Medical Necessity for SUD services is established.
 - ii. The specific ASAM criteria for placement.
 - iii. The individual's needs cannot be more appropriately met by any other formal or informal system or support.

3. Priority Populations

- a. SBH-ASO and the Subcontractor shall prioritize treatment admissions according to the following priority categories:
 - i. Women who are pregnant and injecting drugs;
 - ii. Women who are pregnant with SUDs and;
 - iii. Individuals who are injecting drugs.
- b. Washington state and Salish BHO defined priority populations:

- i. First priority: Parenting women;
- ii. All other populations are prioritized as follows:
- iii. Postpartum (up to one year, regardless of pregnancy outcome);
- iv. Parenting individuals involved with Child Protective Services;
- v. Youth;
- vi. Offenders (as defined in RCW 70.96A.350);
- vii. Other Medicaid Individuals: and

4. Access to Services

The Subcontractor shall provide access to services as follows:

- a. Opiate Substitution Clients: The Subcontractor shall accept and make the necessary adjustments to continue treatment for any clinically appropriate client actively taking an opiate substitution medication.
- b. The Subcontractor shall not have policies or procedures in place that deny treatment services to any individual solely on the basis that the client is taking prescribed medication(s).
- c. Nicotine: The Subcontractor shall ensure that access to treatment services is not denied solely on the basis that a client is using over the counter nicotine cessation medications or actively participating in a Nicotine Replacement Therapy regimen.
- d. Ensure that treatment services are not denied to any individual solely on the basis of that individual's drug(s) of choice.
- e. The Subcontractor reserves the right to deny admission to any individual when the Subcontractor determines that the individual is beyond the scope of the Subcontractor's ability to safely or adequately treat, or that the inclusion of the individual in the treatment setting may interfere with or detract from the treatment of other clients.

ATTACHMENT B2: STATEMENT OF WORK-Substance Use Disorder (SUD) Withdrawal Management

I. PROGRAM DESCRIPTION

A. Eligibility

Persons eligible for SUD residential placement are those individuals who:

- Individual is not enrolled or eligible for Medicaid.
- Meet medical necessity based on ASAM placement criteria. The Salish BH-ASO will reimburse Subcontractor for services to eligible individuals who reside in the SBH-ASO.

B. Program-Specific Requirements

Subcontractor shall work with other payors to determine their authorization standards. Individuals must meet the following criteria to be eligible for this level of care under the SBH-ASO.
 - i. Medical Necessity for SUD services is established.
 - ii. The specific ASAM criteria for placement.
 - iii. The individual's needs cannot be more appropriately met by any other formal or informal system or support.

3. Priority Populations

- a. SBH-ASO and the Subcontractor shall prioritize treatment admissions according to the following priority categories:
 - Women who are pregnant and injecting drugs;
 - ii. Women who are pregnant with SUDs and;
 - iii. Individuals who are injecting drugs.
