

2014 Program Highlights

- **Peninsula Community Health Center has screened over 11,000 adults in their primary care clinics since October 2014.**
 - 1,928 referred for a second screening
 - 65 referred to outside substance abuse treatment programs
- **Olympic Educational Service District has had 1,249 students referred for school based behavioral health services.**
 - 583 students have been enrolled in behavioral health services including individual, group, and case management services
 - 432 educators have been trained in areas related to behavioral health including dealing with depression and suicide prevention
- **Bremerton Police Department has coordinated training for 209 law enforcement officers county wide in Crisis Intervention Training.**
 - 27 new Officers certified as Crisis Intervention Specialist
 - Crisis Intervention Board established to coordinate county wide crisis intervention
