Prevention effort 'Teens in the Driver's seat' is underway and the coalition as agreed to support/promote.
- Coalition Assessment feedback results call us to engage/re-engaged underrepresented sectors and build community presence. As we work on 2023 reinvention of the coalition, we will be working in collaboration with all 12 sectors to support and partner in even more prevention efforts.
- KHS SAP serving ~20 youth and has groups up and running. #s of youth accessing restoration center down, not certain of why but this is being investigated. More info as available.

- Coffee Oasis is seeing a decrease in crisis outreach numbers. It has been observed that there is still a significant need, it is not apparent why this change. C.O. looking into this and details will be shared as news becomes available.
