- CALL TO ORDER Sandra LaCelle called the meeting to order at 5:01pm via Zoom.
- 2. **INTRODUCTIONS** Members and guests introduced themselves; attendance was taken.
- 3. APPROVAL OF THE April 1, 2025, MINUTES\*

#### 5. OLD BUSINESS

# A. Working Age Adult Policy Implementation

i. Partners for Work (PFW) mock interviews took place at the Bainbridge Island Rotary Club on May 5, 2025. Two job seekers practiced interviewing. After the event the Rotary reached out about hiring a Greeter.

#### **B.** Transition Student Update

- i. 2025 School to Work (STW) Two students are currently employed.
- ii. 2026 School to Work (STW) Job Foundation reports are nearly finished, students in this cohort will begin STW July 1<sup>st</sup>.
- iii. 2027 School to Work (STW) Kirsten is currently gathering student lists to start the process for STW 2027.

#### C. Accessible Communities Advisory Committee (ACAC)

 Justin was happy to share that ACAC members and select county staff will be meeting at Sea Discovery Center in Poulsbo on Friday, May 9, 2025, to celebrate the installation of the accessible front door.

#### D. KC Annual Resource Fair Update

 The Developmental Disabilities Resource Fair took place at Central Kitsap High School Gym in Silverdale on April 23, 2025. There were over 200 attendees along with 61 vendors that participated, it was a tremendous turnout. Heidi shared that there will be a debrief meeting with the planning committee to discuss next year's fair.

## **E.** Community Summit

i. The 2025 Community Summit is a virtual event, which takes place on June 4, 2025. Pierce and Kitsap County's have partnered together to create an in-person watch party, which will give people the opportunity to meet and network with other local community members, participate in live discussions, and to make your voice heard. #### 6. **COMMUNITY INPUT**

- **A.** Melia Hughes, Kitsap County Parent Coalition (KCPC) Coordinator shared details about upcoming KCPC May meetings, highlights included:
  - i. Sensory Strategies for Participating in the Community is scheduled for May 12, 2025, from 5:30pm-8:30pm, via Zoom. This training explores the five senses and additional sensory factors impacting community participation.

### 7. NEW BUSINESS

## A. <u>Heidi Jo Johnson – Developmental Disability Specialist & Liaison</u> Kitsap Mental Health

- Heidi shared an overview of her position at Kitsap Mental Health (KMH) and the processes she follows. Highlights included:
  - In order for a person to utilize Heidi's services they must be both a DDA and KMH client. Heidi is authorized to assist people in coordinating a Priority Intake at KMH but in order for a person to qualify as a KMH client, they must receive a mental health diagnosis at Intake.
  - Heidi provides direct services to KMH and DDA clients and their caregivers as 90% of her work is spent serving DDA clients with Authorizations from DDA called Stabilization Services. In order to qualify for these services, DDA and KMH clients must be at immense risk of losing their housing or at risk of a mental health crisis in order for these services to be authorized by the DDA.
  - When a client has a Stabilization Authorization Heidi can provide direct teaching skills that will assist them with reaching their goals along with teaching and training

- caregivers and families how to best care for a Client.
- Heidi provides consultation with DDA, family, and caregivers regarding the clients existing DDA Plan of Care and makes referrals and recommendations based upon her work with the client.

## B. Legislative and Budget Update

- Details about the Arc 2025 Bills of Interest for people with Intellectual/Developmental Disabilities (IDD) was discussed. Highlights included:
  - Senate Bill 5393 Closing the Rainier School has passed after over multiple amendments. No new long-term admissions will be allowed at the facility starting from the bill's effective date, with all admissions ceasing by June 30, 2027. The bill will allow current residents to stay at the facility indefinitely.
- ii. Details about the 2025 Budget Side By Side was discussed. Highlights included:
  - There is a 50 million dollar reduction line item for Employment and Day and Individual and Family services.
     More clarification is needed on the impact.
  - Senate Bill 5263: Eliminates the 16% enrollment cap on special education funding. This bill also increases the special education funding multiplier and adjusts the safety net threshold, aiming to provide more funding for districts to support students with disabilities.
  - House Bill 1272: Extending the Children in Crisis program to address complex cases by creating a Rapid Care Response Team. The rapid care response team will ensure that resources are effectively identified and mobilized for people who meet the definition of child in crisis and a youth or young adult leaving a publicly funded system of care.
- iii. Effective May 1, 2025, the Department of Social and Health Services (DSHS) consolidated key functions previously managed by the Behavioral Health, Developmental Disabilities and Aging and Long-Term Support Administrations into two core entities.
  - Behavioral Health and Habilitation Administration: This division will oversee state-operated settings and manage comprehensive behavioral health and habilitation services.
  - Home and Community Living Administration: This division focuses on coordinating home and community-based services to better support clients in their own environments.
