CAC Recommendation on Crisis Triage Center

The Citizens Advisory Committee Recommends:

- 1. Referral Back to Human Services Department Staff to work with Proposing Agency, Stakeholders, State and Local Partners on alternative funding opportunities for the ongoing support of the facility.
- 2. The Human Services Department shall report findings and recommendations back to the Citizens Advisory Committee and Board of County Commissioners by December 31, 2014. The report will include:
 - a. An overview of the funding and service delivery models of other Crisis Triage facilities in Pierce, King, Snohomish, Thurston/Mason and Yakima Counties.
 - b. Alternative funding sources for the on-going support of the facility.
 - c. A budget that details the sustainability of funding sources to support the facility.
 - d. Recommendations for alternative service models that are sustainable and costs/funding sources associated with each of the alternatives.
- 3. The year one request for \$693,059 should be held in reserve pending the identification of viable and sustainable alternative funding sources by December 31, 2014.
