<p>The Koinonia Inn provides a safe, stable, and supportive environment for pregnant, parenting, and postpartum women who are either in substance use disorder treatment or have completed a treatment program within the last year. The program is designed to help participants stabilize their lives and transition toward permanent housing and long-term recovery.</p> <p>Each resident receives individualized case management. These sessions focus on key areas such as housing stability, parenting support, personal development, and recovery planning. Daily on-site services are available to assist with life skills including parenting education, financial literacy, communication, and relapse prevention. The goals of Koinonia Inn are to help each participant achieve long-term sobriety, secure and maintain permanent housing, and prevent future homelessness.</p> <p>The 2026 Coordinated Grant funds requested will support Koinonia Inn’s operational and maintenance expenses. This includes coverage for utilities such as power, water, sewer, garbage, phone, and internet, essential for residents to search for and apply for jobs, housing, and benefits. Funding will also support costs for the mortgage, insurance, pest control, security, operational and maintenance supplies, licenses, fees, and taxes. Additionally, the grant will fund salary and benefits for a part-time 0.25 FTE Maintenance Staff (10 hours per week) to ensure timely repairs and maintain a safe, stable, and livable environment for the women and children residing at the Inn.</p> <p>All participants are extremely low-income households with incomes at or below fifty percent (50%) of the area median income.</p>

<p>The Sisyphus II housing program offers a clean and sober living environment for individuals and families who are homeless, chronically homeless, low to very low income, disabled, and/or affected by substance use disorders.</p> <p>The program aims to end future episodes of homelessness by promoting long-term stability in permanent housing. They equip participants with essential life skills to maintain a home, support them in addressing past challenges, and guide them toward achieving their full potential in employment, education, or other positive activities. Each participant collaborates with staff to create a personalized housing stability plan that identifies key problem areas and desired outcomes. Progress is reviewed monthly, with plans adjusted as needed to ensure continued growth. This individualized, goal-focused approach empowers participants to build a stable, independent future.</p>

<p>The goal of this program is to address the needs of the unsheltered and provide or remove barriers to obtaining emergency shelter as well as support the citizens that are impacted by encampments near their private properties.</p> <p>Commonstreet Consulting partners with the City of Bremerton and provides citywide street outreach to proactively locate and engage individuals experiencing homelessness, who otherwise are not accessing services. Commonstreet outreach includes provision of tailored services through case management to eliminate barriers for the purpose of meeting resource criteria, while connecting people to emergency shelter, housing, and/or other critical services to end their current episode of homelessness.</p>

<p>The mission of Housing Resources Bainbridge (HRB) is to preserve the diversity and vitality of Bainbridge Island by providing and maintaining permanently affordable housing in the community. 25 of the 55 rental units owned and managed by HRB are reserved for households at 50% AMI or below.</p> <p>The program provides rental assistance to adults earning 50% AMI or below so that no household pays more than 30% of its adjusted gross income on housing or a \$350 minimum, whichever is greater.</p>

<p>KARE developed the HOPE program in 2024 to manage the Pet Care Center within the Pacific Building providing services for shelter guests with pets and supportive staff training services to KRM as on-site human services providers. The KARE/HOPE program is responsible for maintaining/managing/cleaning inside Pet Care Center, kennel facility, and outside pet exercise/sanitation areas, and oversees janitorial/sanitation/security protocols for the interior and exterior areas of the shelter. KARE/HOPE program is responsible for staffing, scheduling, and supervising pets in the kennel area, and administrating all HOPE services and service contracts with veterinarians.</p> <p>KARE/HOPE pays for program administrative services, training classes, guest/pet transportation services, and direct client services as required on a case-by-case basis. Guests and pets are supported by HOPE staff beginning with the intake transition into the congregate shelter environment. Guests and pets receive training for behavior modification, socialization skills, house training, and basic training/obedience training classes. These services often require providing guests with equipment to maintain control of their pets.</p> <p>KARE/HOPE schedules veterinarian, vet techs, grooming services and pays for medications, special dietary foods, health and training certificates and supplies. KARE/HOPE provides in-house training to KRM staff as human services providers, to educate staff how to work safely in a co-shelter environment when animals are present. Also staff training on how to identify the specialized needs of pet owners interacting in the shelter environment. KARE/HOPE also provides emergency services for pets in distress and responds to after-hour emergencies calls from KRM shelter staff. KARE/HOPE arranges kennel stays, foster care, or adoption services when a pet owner is admitted to a hospital or an alcohol/drug rehabilitation center. KARE/HOPE staff support KRM staff, navigators, case managers, drug and alcohol counselors so guest &amp; pet achieve the goal of a more stable permanent housing solution.</p>

<p>The Kitsap Community Resources (KCR) Transitional Housing program Participants in the program come directly from unsheltered or sheltered homeless populations. Participants in the program pay 0 - 30% of their net income toward rent, making housing more affordable while they work toward stability. Participants have a maximum stay of 24 months, though extensions can be requested. Participants are assigned a case manager who will work with them for the length of the program.</p> <p>KCR will also receive referrals from other agencies when housing stability case management is necessary. These agencies could include Housing Kitsap, Bremerton Housing Authority, HEN, KMHS, or any others entered into partnership agency agreement. These referrals will be for progressive engagement case management services, including development of a housing stability plan, tenancy support, referrals to community resources, and quarterly assessments to verify progress on housing stability plans.</p>

<p>Kitsap Homes of Compassion leases homes from existing housing stock throughout Kitsap County and subleasing the individual rooms, creating affordable shared housing for those that have been unhoused or chronically housing vulnerable. They provide on-side house managers that work with individuals in the homes to assure compliance with shared living rules and to ensure that the home is safe and well taken care of.</p> <p>The Housing Coordinator screens applicants, assesses need and assists them with the leasing and move in process. 65 individuals/households per year minimum.</p> <p>Kitsap Homes of Compassion currently offers peer support services, housing navigation and access to our agency counseling services. Minimum of 75 individuals per year. The goal is to maintain 19 homes through 2025-26 calendar year, housing a minimum of 88 individuals in our housing and assisting 100 others in finding</p>		

housing in our homes or throughout the community. The case management goal is to assist 100 individuals in maintaining housing with a 80% retention rate in KHOC program houses and a 60% retention rate in KHOC recovery homes.

KMHS owns and operates eight shared houses, twenty single units, five family houses and manages 4 fourplexes owned by Housing Kitsap, providing housing for a total of 70 individuals/head of households with 30% AMI or less. All residents pay 30% of their income for rent and that includes basic utilities.

The program houses clients with the most severe mental health disabilities who are unable to secure housing on their own. The landlord works closely with the residents to make sure the homes are decent, safe, and affordable. Residents are on a lease with house rules giving them landlord/tenant rights. Our service team teaches residents basic skills so they can live in our housing and maintain all necessary activities of daily living.

The program works to eventually teach residents the skills they need to live independently in the community.

Fishline Homeless Supportive Services provides basic needs assistance, rental support, housing referrals, showers, Safe Park access, and navigation services (formerly case management) to individuals experiencing homelessness. By 2026, Fishline will expand its reach to overlooked and underserved areas—continuing to meet individuals where they are, with consistent presence, care, and navigation that fosters pathways out of homelessness.

Fishline Homeless Supportive Services is designed to meet the layered and urgent needs of individuals experiencing homelessness. We begin by addressing basic survival needs—providing food, showers, hygiene supplies, warm clothing, and a safe place to rest. These services help clients feel safe, warm, dry, and clean, creating a foundation for trust and engagement. Once stabilized, individuals are referred to the Housing Solutions Center to explore shelter options and begin the process of securing housing. From there, they can meet with Fishline’s case managers and social services staff, who help develop Housing Stability Plans, connect clients to rental assistance, and navigate systems like Section 8 enrollment.

Homeless Youth Services provides a comprehensive, trauma-informed continuum of care tailored to meet the unique and complex needs of youth experiencing homelessness in Kitsap County. The goal is to engage youth early, build trust, and support them in creating pathways out of homelessness and toward stability and self-sufficiency.

The program begins with street and school-based outreach, meeting youth where they are both physically and emotionally to build rapport, provide basic needs, and connect them with immediate resources. Crisis intervention services offer rapid response for youth in unsafe or unstable situations, helping to stabilize their environment and ensure safety.

Youth can access drop-in centers for food, showers, laundry, clothing, and a safe place to rest. These low-barrier, youth-friendly spaces are a critical entry point into deeper services. From there, youth are connected with a dedicated case manager who walks alongside them to develop personalized goal plans based on their strengths and needs. Coffee Oasis offers a range of housing options, including emergency shelter for minors and young adults, transitional housing, and assistance with family reunification or diversion when appropriate. Their housing first approach ensures that stable shelter is paired with supportive services.

To support long-term success, Coffee Oasis provides job training, employment readiness support, and mentorship. Youth gain skills, confidence, and real-world experience through internships, workshops, and connections to community employers. Ongoing mentoring and life-skills coaching help youth heal from trauma, navigate adulthood, and build a future of hope. All services are free, youth-centered, and designed to be inclusive and equitable.

The Salvation Army (TSA) Homeless Support Services (HSS) program is staffed by one social service aide with oversight by the social service director. The HSS program will provide bus tokens, gasoline vouchers, ID assistance, emergency hotel vouchers, taxi rides, tents, tarps, and sleeping bags. The HSS program also provides a hygiene center with free showers and laundry service.

<p>West Sound Treatment Center’s Unsheltered Housing &amp; Case Management Program provides trauma-informed transitional housing and wraparound support for individuals experiencing homelessness and active substance use disorders. The program operates two transitional housing facilities: one for men and one for women, both serving extremely low-income adults (≤50% AMI) transitioning directly from unsheltered or sheltered homelessness. Stays are limited to 24 months with ongoing case management support.</p> <p>Participants receive comprehensive housing stability case management, including individualized housing plans using the Kitsap County Housing Stability Planning and Progress Reports (HSPPR), assistance with legal documentation, and coordinated care with behavioral health, recovery support, and employment resources. All case management staff are trained in trauma-informed care, ACES/resiliency, racial equity, gender identity, and mental health first aid.</p> <p>In alignment with the Homeless Outreach and Survival category, the program distributes bus passes, gas cards, hygiene supplies, and move-in items such as blankets, pillows, towels, and food to increase engagement and remove barriers to stabilization. Participants also receive support with transportation to medical, court, and service-related appointments.</p> <p>Through Targeted Prevention, Diversion, and Rapid Rehousing, the program supports flexible problem-solving and housing navigation for clients not suited for immediate transitional housing, leveraging outreach and intake efforts to prevent chronic homelessness.</p>
