ACTION ITEMS

- 1. Call to Order 9:02am
- 2. Approval of April 18 meeting minutes. <u>MOTION</u>: Jessica Barr moved to approve meeting notes as presented. Elizabeth Court seconded the motion. **Motion carried unanimously**.

DISCUSSION ITEMS:

- 3. Recompete Update Una shared she's hired two new employees, Carol (communications and media) and Christy (analyst). Economic development has seen recent changes in DC and the 100% transition on who recompete is working with. Even with the change, work is continuing forward and rolling out governance. Currently working on developing a website and able to security the recompete.wa URL. Una's attended two recent events: Maritime and Juan de Fuca festivals. Able to capture information from job seekers and businesses that range from household size to business needs. Implementing a new CRM to create a database of all the feedback they are receiving from the events. Una will be getting to tour the Port Townsend Paper Mill next week, but Ben Fraiser, HR Director, already shared that they are getting 50-60 applications but still having issues with hiring. Finding that a successful candidate will ghost either before even starting or after working only a week.
- 4. Invisible Disabilities Survey Results received 15 responses from the survey which was based on April 18th coalition meeting where attendees provided feedback about best practices and implementation suggestions. Feedback was categorized into four groups Inclusive Hiring & Interview Practices, Workplace accessibility & Tools, Supportive & Safe Work Culture, and Onboarding & Employer Buy-in. Survey respondents were provided the feedback and asked if they organization currently practiced the suggestions or if they would like more information.

Lisa Wheeler shared most of the results are characteristics of the population DSB serves, and some they hadn't considered. (create/support an employee resource group). Lisa noted it would be interesting to carry this information forward and build into training.

Una is interested in adding this type of information to a concept they are implementing "Recompete University".

Danny Steiger, not present, emailed feedback previously and it was shared concerning employee compliance and the legal ramifications. He voiced concern about how small businesses navigate hiring individuals with invisible disabilities.

Kristal noted that the same EEO laws apply. She further noted that in her experience businesses needed to humanize the positions.

Mike offered DVR, Tessera and Ask Jan as resources.

Danessa offered that as someone with an invisible disability, her fear is the exact opposite of Danny's and agreed that business needed to humanize the positions, the stigma for individuals with disabilities applies to even those with invisible ones.

Molly suggested keeping open the survey for another week and then providing the results to the group. Brief discussion on a pamphlet or training.

- 5. Empowering Employers Event: Frank shared the two women's employing event last year led up to the decision and poll to move this years events to employer focused. The event in May was a success, with three speakers and resources tables at the Bay Club in Port Ludlow. 100% of attendees were either satisfied or very satisfied with the event!
 - Survey from the event provided and discussed.

Bringing the event to Kitsap in October, Frank requested volunteers for the planning team. Kristal, Danessa, and Elizabeth volunteered.
