Good afternoon,

Kitsap County's Office of Public Defense is currently seeking letters of interest from attorneys who may wish to contract with the County next year to provide client representation in any cases where the client has been found indigent and is facing a deprivation of liberty or deprivation of a liberty interest. Please find a copy of our 2025 compensation schedule attached for your reference as to the types of cases for which we contract and our existing compensation rates.

If you are interested in contracting with the County to provide representation in any of these categories, we ask that you provide the following information in your letter of interest: the type of representation you seek to provide, the specific attorney(s) you envision doing the representation work you seek to provide, and the experience of the attorney(s) to perform that type of representation work. For those who would like to contract with the County to provide these types of representation services but apprehend being unable to do so because of the existing compensation scheme, please submit a letter including the information above along with your desired compensation amount for the type of representation you are seeking to provide and the reasons why you believe that the compensation amount you are proposing is justified.

While we welcome and encourage all letters of interest, please note that currently our areas of greatest need in Kitsap County are in the categories of juvenile representation, misdemeanor and gross misdemeanor representation in District Court, and appellate representation in appeals taken from District Court to Superior Court (RALJ representation).

We wish to take this opportunity to thank all of you who have provided the public service in 2025 of representing indigent people here in Kitsap County who have faced the deprivation of liberty or a liberty interest. We hope you will continue to provide that public service to our community in 2026.

For those of you who may not have had either the occasion or circumstance necessary to provide this type of service before, we thank you in advance for considering anew this opportunity for public service for you or your law firm in 2026.

Any request for compensation based upon representation hours beyond those contemplated in the initial case compensation amounts must always include a complete accounting of ALL hours worked on the case from the time the attorney begins the representation specifying the date, time, and description of each representation task that has been completed or performed.

- 2. <u>Law Library and Legal Research Tools</u>. County will provide Contractor access to the County Law Library and online legal research tools as determined by the County.
- 3. Administrative/Overhead Expenses. Contractor will furnish all equipment, labor and materials necessary to perform all the Services required under this Contract and will be responsible for the payment of all administrative expenses of Contractor's office/firm not otherwise provide for in this Contract or as identified in chapter 2.23 KCC. Such expenses include personal law libraries, photocopies, postage, messenger, secretarial, supplies, mileage, and facsimile, which were contemplated in the Contract and incorporated into the compensation amount.

- 4. <u>Reimbursement Other Expenses</u>. County will reimburse Contractor for other reasonable expenses with the prior approval of the KCOPD Chief. Other reimbursable expenses shall be defined as charges reasonably incurred in providing legal representation as determined by the KCOPD Chief.
- 5. <u>Excess Compensation</u>. Contractor may request compensation beyond that described above. Such requests shall be submitted to KCOPD Chief for approval. County and Contractor agree to be bound by the decision of KCOPD Chief. The factors to be considered by KCOPD when making decisions on requests for excess compensation include:
  - Number of days spent in trial;
  - Extent of testimonial motion hearings and other contested hearings;
  - Interpreter-involved cases;
  - Cases involving mental health competency and other issues (RCW 10.77);
  - Cases involving extensive discovery;
  - Cases that involve a significant number of counts, alleged victims or witnesses;
  - Cases requiring consultation with experts, including, for example, immigration legal analysis and advice or DNA testing and analysis;
  - Overall complexity of the case;
  - Skill and experience required to provide adequate legal representation;
  - The exclusion of other work done by the attorney during the public defense representation; and
  - Any other factors deemed relevant by KCOPD.

2. <u>Co-counsel</u>. Co-counsel at public expense must be appointed by the Kitsap County Superior Court.

- 3. Accounting and Billing. When submitting an invoice to County for Service, Contractor will submit detailed records of time and expenses incurred in the representation of homicide defendants in the form of an Affidavit of Services Rendered. Affidavits shall state the amounts, dates, and type of time expended and be sufficiently detailed to allow County to determine the nature of the time expended. Any supporting material required providing sufficient documentation or documentation shall accompany the Affidavits.
- 4. <u>Reimbursement– Other Expenses</u>. County will reimburse Contractor for other reasonable expenses with the prior approval of the KCOPD Chief. Other reimbursable expenses shall be defined as charges reasonably incurred in providing legal representation as determined by the KCOPD Chief.
  - A. County will reimburse Contractor for mileage as set by the current "State of Washington Reimbursement for Rates for Lodging, Meals and Private Vehicle Mileage", RCW 10.90.20. County will NOT reimburse for travel time.
- 5. Administrative/Overhead Expenses. Contractor will furnish all equipment, labor and materials necessary to perform all the Services required under this Contract and will be responsible for the payment of all administrative expenses of Contractor's office/firm not otherwise provide for in this Contract or as identified in chapter 2.23 KCC. Such expenses include personal law libraries, photocopies, postage, messenger, secretarial, supplies, mileage, and facsimile, which were contemplated in the Contract and incorporated into the compensation amount.
- 6. <u>Excess Compensation.</u> Contractor may request compensation in excess of that described above. Such requests shall be submitted to KCOPD for approval. County and Contractor agree to be bound by the decision of KCOPD. Factors to be considered by KCOPD when making decisions on requests for excess compensation:
  - Number of days spent in trial;
  - Extent of testimonial motion hearings and other contested hearings:
  - Interpreter-involved cases;
  - Cases involving mental health competency and other issues (RCW 10.77);
  - Cases involving extensive discovery;
  - Cases that involve a significant number of counts, alleged victims or witnesses;
  - Cases requiring consultation with experts, including, for example, immigration legal analysis and advice or DNA testing and analysis;
  - Overall complexity of the case;
  - Skill and experience required to provide adequate legal representation;
  - The exclusion of other work done by the attorney during the public defense representation; and
  - Any other factors deemed relevant by KCOPD.
