RESOLUTION NO. 19 -2025

A RESOLUTION ADOPTING A SCHEDULE OF FEES FOR SEWER UTILITY DEVELOPMENT SERVICE FEES AND DCD/SEWER – DEVELOPER PLAN REVIEW SERVICE FEES

WHEREAS, County Ordinance #113 provides that a written schedule of fees for building sewer permit fees, plan review check fees, and inspection fees may be adopted from time to time; and

WHEREAS, Resolution 222-1996 amended those fees as a one time adjustment and represents the last time these fees were evaluated for reflection of true cost of service; and

WHEREAS, A review of actual costs for providing plan check, inspection, and other utility provided services has indicated a need to revise the schedule of fee to recover costs for performing those duties; and

WHEREAS, The Sewer Utility provides Plan review support services to the Department of Community Development (DCD) which have never been compensated creating an inequity of rate payer support of private development projects; and

WHEREAS, Kitsap County Code Titel 13.14.130(c) provides that "The director shall from time to time adopt a written fee schedule for building sewer permit fees, plan check fees and inspection fees; provided, such fees shall not exceed the cost to the county of performing the duties thereby required"; and

WHEREAS, Public Works Sewer has identified work efforts required to capture true costs of service rendered by the Sewer Utility and reduce ratepayer funds being used to support private development; and

WHEREAS, The Public Works Director and Department of Community Development (DCD) Director have worked collaboratively to review the new fee schedule "DCD/SEWER – Development Plan Review Services" and incorporate the new fees into an existing fee guides, designed to increase transparency of all fees, including other agency fees, associated with these permit applications; and

WHEREAS, a revised fee schedule has been produced to cover the true cost of service of services provided by Resolution 222-1996 and includes true costs of new services which were not originally provided when Resolution 222-1996 was passed; and

WHEREAS, The proposed "Sewer Utility Development Service Fees" and "DCD/SEWER – Development Plan Review Services" are considered conservatively low, and will be adjusted for inflation by increasing fees by 4%, or 100% of the Seattle-Tacoma-Bellevue CPI-U, June 2025 to June 2026, whichever is lower, on the first of each year, commencing on January 1 of 2027, through 2029; and

WHEREAS, Resolution 222-1996 is hereby repealed and replaced with Resolution 191-7025

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Kitsap County, Washington, that the attached Schedules of Fees for DCD/SEWER -Development Plan Review Services and Sewer Utility Development Service Fees shall be in effect as of January 1, 2026.
