APPROVAL OF THE MINUTES

November 1, 2023, minutes approved as presented.

Caitlin Newman from Solid Waste Division and Steve Brown from Kitsap Public Health District reviewed Chapter 13, Regulation and Enforcement of the Solid and Hazardous Waste Management Plan (SHWMP). Presentation attached.

Caitlin talked about removing items that do not pertain to the regulation part of chapter 13 (page 2 of presentation). These will be moved to other chapters. She also talked about items that need to be added to chapter 13, including: development design standards for solid waste collection, group collection sites, non-permitted hauler enforcement and the sign code (for temporary signs posted alongside the road).

Steve Brown discussed Kitsap Public Health Districts role in enforcement of solid waste issues. KPHD has a Kitsap Nuisance Abatement Team funded by tipping fees (\$2.49 per ton). Nuisance abatement activities are conducted by City and County Code Compliance agencies.

Elections held for 2024 SWAC officers. Motions made and unanimously approved to reelect Stephanie Bailey as Chairperson and Eric Linius as Vice Chairperson.

Chris Piercy Presented the 2024 SWAC Work Plan – Motion made and approved to accept the 2024 Work Plan with the meeting location address amended to 8600 SW Imperial Way, Bremerton, WA. and for Chris to amend the wording of tier 2 - section 2.

ROUND TABLE DISCUSSION

Chris Piercy – Chris introduced Audrey Taber from the Department of Ecology. There will be two new Solid Waste Division staff members, one each for the Clean Kitsap and Education & Outreach teams. Chris also extended congratulations and a warm thank you to Stephanie Bailey for her twenty years as a SWAC representative.

Caitlin Newman – She is in negotiations with vendors for upcoming collection events.

Diane Landry – City of Bainbridge received a grant from Ecology for the purchase of kitchen compost buckets for compost education and outreach.

Audrey Taber – Application period open! NextCycle Washington is seeking applicants for its accelerator program for both upstream and downstream projects that help the circular economy and associated environmental and equity goals. Eligible applicants: businesses, universities, non-profits, community-based organizations, or tribal governments. Application help session Jan. 11. Deadline: January 26, 2024. 



NEW - Charity Disposal Rates

Kitsap County Code 9.16

Discounted disposal rates to qualifying charities who self-haul to OVTS:

- Nonprofit
- Primary business is processing donated goods for resale
- Proceeds finance human services programs

50% discount up to first 100 tons annually

NEW - Disposal Vouchers

Kitsap County Code 9.16

Dump vouchers for municipalities and nonprofits for qualifying activities:

- Public land cleanup
- Private land open to free recreation (limit two per year)
- Conservation land acquisition cleanup (limit one)

What are Group Collection Sites?



Defined as:

Easements or public areas that are permitted to be used for the purpose of solid waste collection.


They are not intended for permanent storage of garbage or recyclable receptacles.

Group Collection Sites around Kitsap





Group Collection Site Problems



- 1. Illegal dumping
- 2. Litter or spillage at point of collection
- 3. Aesthetics
- 4. Abandoned cans

Who Creates Group Collection Sites?



Why?

WM creates GCS when roads are deemed as unsuitable or unsafe for the garbage trucks and the people that drive them.

Ex: no turn-around space



Who Regulates Group Collection Sites?

Regulatory Authority:

Kitsap County Board of Health Ordinance 2010-1 "Solid Waste Regulations," Section 300(2)(b)(vii):

"Containers of solid waste may be placed in the utility easements or corridors for the purpose of collection by a permitted route collection truck, not for storage of wastes."

NOTICE AND ORDER TO CORRECT A VIOLATION

RE: GARBAGE AND RECYCLING CONTAINERS STORED ON LINDVOG RD AND BERRY ST, KINSGTON WA

Dear Current Residents:

The Kitsap Public Health District has been contacted to assist with the nuisance that has been created at the intersection of Lindvog Road and Berry Street by the inappropriate Garbage and Recycling container management. Easements or public areas that are permitted to be used for the purpose of solid waste collection are not intended for permanent storage of garbage or trash and recyclable receptacles. They must be put out the night before or the day of pickup and removed within 24 hours of pickup. Once emptied by Waste Management, the containers need to be returned to your residence until the next collection day.

Besides the obvious visual nuisance that storing multiple containers in a remote location causes for the owners of the properties immediately adjacent to these areas, there are other reasons this practice is not allowed. First, these unattended groups of containers become magnets for illegal dumping. Second, when the trash in these containers is eventually spilled out, either by accident or by the animals, it causes a public nuisance and health risk.

The Kitsap County Board of Health Ordinance 2010-1 "Solid Waste Regulations" are clear on this subject.

- Section 300(2)(b)(v) On-site Storage, collection, and transportation standards States: "The owner, operator or occupant of any premises, business establishment or industry shall store all recyclable materials so as not to produce unsafe or unsanitary conditions. And;
- Section 300(2)(b)(vii) Onsite Storage, Collection and Transportation Standards states:
 "Containers of solid waste may be placed in the utility easements or corridors for the purpose of collection by a permitted route collection truck, not for storage of wastes."

The area was inspected by a Health District inspector on {Insert Date, and Time}. Containers associated with your address were observed to be stored in this area in violation of the above referenced Regulations.

The Health District hereby gives you notice to correct this violation within [1] days of receiving this notice by doing the following:

- Remove both garbage and recycling containers from the collection location on Lindvog at Berry Street and store them at your property.
- Containers are to be removed from the pick-up point weekly. Maximum storage time not to exceed 24 hours.
- Ensure that both recycling and garbage containers have a legible address on the front of the container. Containers not properly labeled are subject to removal from the collection location.

FAILURE TO COMPLY WITH THIS ORDER WILL RESULT IN THE ISSUANCE OF A CIVIL INFRACTION NOTICE TO YOU. THE CIVIL INFRACTION NOTICE MAY RESULT IN A FINE OF UP TO \$513.00 PER VIOLATION PER DAY TO BE ASSESSED TO YOU.

Please note that pursuant to Section 950 of the Solid Waste Regulations any person aggrieved by the contents of a notice and order to correct violation issued under this regulation may submit a completed written application for an appeal to the Health Officer. The request for an appeal must be submitted in writing, on Health District forms, be accompanied by the <u>applicable fee</u> (\$450), and within 10 (business) days of the action appealed.


