CORRESPONDENCE

Memo from Laura Moser of Waste Management was sent electronically to SWAC members. Memo attached.

KCPW

Officer Elections -

SWAC motioned to postpone officer elections, until the next meeting, when the new Commissioner Walters SWAC representative is appointed.

Chris Piercy – 2023 SWAC Work Plan

Motion was made and SWAC approved the 2023 Work Plan as presented by Chris Piercy. The meeting location and the chairperson elections will be amended after the next meeting. The 2023 Work Plan is attached.

Chris Piercy – Inter Local Agreement ILA

Chris is working to update the ILA. The last update was in 2008. The ILA delegates the sole planning authority for all jurisdictions in Kitsap County to the Kitsap County Public Works, Solid Waste Division. Cities can follow the county or go on their own. Chris asked for appointed SWAC members to refer the most current contact from their cities for him negotiate the ILA with.

Heather asked for Chris to give a history of the ILA. The ILA outlines who is responsible for what in Kitsap County. The current copy is in the back of the Solid and Hazardous Waste Management Plan.

Future Meetings –

The Kitsap County board of Commissioners has reassessed virtual advisory meetings and requiring a physical location for members and public to attend. Starting in April we will have a physical meeting place available with the option to attend remotely. Either at the Annex or the Bremerton Public Works building. Bill Rich also offered to check on a space at the Bremerton Conference Center.

Legislative Updates -

There are many bills in progress that may affect recycling in Washington State. SWAC discussed how they may affect hauling and customers of Kitsap.

Capital Project Updates -

North Kitsap Service Center –

Project is in 90% in design, but the conditional use permit process is backlogged at the Department of Community Development (DCD) a possible 8-12 months. We will need to host another HHW collection event for the north area.

Silverdale Recycle and Garbage Facility –

Cost have significantly increased since the project was started. Original budget was about \$4,000,000. And has now increased to \$14,500,000. We are working to get the costs down to about \$12,000,000. The process will also be slowed down by the DCD condition use permit process but hopefully start the end of this year.

Second Compactor at Olympic View Transfer Station –

The compactor project progress is in the final details and should be ready later this year.

ROUND TABLE DISCUSSION

Bill Rich – Kitsap Transit is working to purchase more electric buses. The goal is to have an all-electric fleet.

Chris Piercy – Caitlin Newman is currently working on a Community Litter Clean Up grant for \$107,400.00 for 2023-2025. Will cover Adopt a Spot, Therapeutic Court, and homeless encampment and other clean ups.

Heather Church – Her son Brett is job shadowing her for a year and will attend the SWAC meetings.

Diane Landry – Bainbridge Island Zero Waste is supplementing the annual September beach cleanup with an April roadside cleanup. They are working with the Solid Waste Division for funding to help with disposal after the cleanups. Would Adopt a Spot like a table at the Earth Day Celebration at Battle Point Park?

Steve Brown – Solid and Hazardous Waste at the Health District is pursuing more enforcement and clean ups of homeless encampments. It has helped working with the Kitsap Heart team. They finished the 2023 work Plan and will work on some Solid Waste regulations.

Tony Lang – City of Port Orchard is working on encampment clean ups and policy/procedures. The week of April 10-14 is spring clean-up for the city. Adding Tony to the SWAC email.
