Chris Piercy introduced Mary Sharks a representative of Herrera Environmental, the consultants for the review of the Solid and Hazardous Waste Comprehensive Plan.

Events:

The HHW Collection event, held at Poulsbo Public Works, collected household hazardous waste from 233 customers.

Tire and Scrap Metal Collection held in June collected 72 tons of tires and 11.4 tons of scrap metal (double the amount of metal collected at the last collection in 2022) from 532 customers. The tire collection is made possible by the funding of the Dept. of Ecology.

Secure Your Load campaign kick off was June 6, National Secure Your Load Day. The web page addresses how to best secure your load with a video and tips. Straps and nets have been handed out at two different events. Since June staff have been educating the public, the \$10.00 fee will be enforced at the facilities starting August 1. State law mandates having a fee for unsecured loads at all garbage collection facilities.

Capital Projects:

The North Service Center (home of the future North Household Hazardous Waste facility) is at one hundred percent design. We hope to have this facility open in 2025.

The Silverdale Recycle and Garbage Facility is near ninety percent design. We hope to see the facility started by the end of next year.

Olympic View Transfer Station improvements include a second compactor, and a backup generator system. The improvements are to help avoid closures, of the facility, from breakdowns and power outages. The generator system will be installed by the end of the year. The compactor is now being built and installed by January 2024.

The budget process is completed for the next year, the Solid Waste Division remains financially strong.

ROUND TABLE DISCUSSION

Diane Landry – The annual Rotary Auction/Rummage sale was a success, thank you to Bainbridge Disposal for their help cleaning up the leftover items. Thank you to Ashlyn and Colette (Solid Waste's summer help) for their help during the Bainbridge 4th of July parade.

Melinda Monroe – City of Bremerton saw an increase in compost diversion in 2022, and they are getting ready for the annual Beautify Bremerton event.

Shannon Woods – Thank you to the Solid Waste Division for the HHW Collection Event. The event went smoothly, and the shorter hours kept everyone busy.

Doug Chamberlain – The litter on the roadside of Hwy. 3 continues to look much better.

Heather Church – Bainbridge Disposal has stayed busy working the many summer events. They collected over two hundred non saleable sofas for disposal, before the Rotary Sale, with a coupon for drop-off program.

Olivia Carros – Shared the map for the Business Organics Management Act in the chat.
