Summary: The Silverdale community will hold its annual festival known as Whaling Days on July 25, 26, and 27, 2025. Whaling Days parade, fun run, and street fair will generate heavy pedestrian traffic. The through movement of vehicular traffic would seriously affect pedestrian traffic. The closure of certain streets will not impose an undue hardship on the traveling public.

The Public Works Traffic Maintenance Division allocates the necessary barricades and signage needed for the closures and delivers them to the organizer. On the day of the parade, Traffic Maintenance staff the barricades and close the roads to motorists alongside Sheriff's Deputies.

RESOLUTION _____-2025
2025 Silverdale Whaling Days Street Closures

WHEREAS, the community of Silverdale will hold its annual festival known as Whaling Days on July 25, 26, and 27, 2025; and

WHEREAS, it is the intention of Silverdale Whaling Days, a registered 501 (c)(3) non-profit organization, to hold a parade, fun run, and street fair that will generate heavy pedestrian traffic; and

WHEREAS, the through movement of vehicular traffic will seriously affect said pedestrian traffic; and

WHEREAS, the closure of certain streets will not impose an undue hardship on the traveling public; and

WHEREAS, the Kitsap County Board of Commissioners is authorized to impose parking restrictions by WAC 308-330-270 (5).

NOW, THEREFORE, BE IT, RESOLVED by the Board of Kitsap County Commissioners, in regular session assemble, that any office of Silverdale Whaling Days Inc. is hereby authorized to close the following described roads to all vehicular movement except for official and/or authorized emergency vehicles, and certain temporary parking restrictions shall be enacted.

Silverdale Whaling Days July 25-27, 2025 (Festival site)

The following roads will be closed and temporary parking restrictions enacted:

- **Port Property of the boat launch and parking lot adjacent will be closed at 12:00 AM midnight, Tuesday, July 22nd. (Carnival area)**
- **NW Byron Street**, the east side of Washington Avenue NW easterly through cul-de-sac, 12:01 AM, Friday, July 25th to midnight Sunday, July 27th.
- **Washington Avenue NW**, south of NW Byron Street to the dead end, 12:01 AM, Friday, July 25th to 9:00 PM, Sunday, July 27th.
- **Washington Avenue NW**, south of NW Lowell Street to the dead end, 12:00 PM noon, Friday, July 25th to 9:00 PM Sunday, July 27th.
- **NW Byron Street**, east side of Pacific Ave NW to dead end, 12:00 PM noon, Friday, July 25th to 9:00 PM, Sunday, July 27th.
- **NW Lowell Street**, east side of Washington Avenue NW to dead end, 12:00 PM noon, Friday, July 25th to 9:00 PM, Sunday, July 27th.
- **McConnell Avenue NW**, NW Lowell Street south to dead end, 3:00 PM, Friday, July 25th to 9:00 PM, Sunday, July 27th.

- **Designated handicapped parking only- west side of street. Washington Avenue NW**, south of NW Carlton Street to NW Lowell Street 12:00 PM noon, Friday, July 25th to 9:00 PM Sunday, July 27th.
- **Designated handicapped parking only - McConnell Avenue NW** south of NW Lowell Street, both sides of street, 12:00 PM noon, Friday, July 25th to 9:00 PM, Sunday, July 27th.
- **No Parking/Delivery Drop-off Only – Washington Avenue NW** north of NW Lowell St to NW Carlton Street, east side of street, 12:00 PM noon, Friday, July 25th to 9:00 PM, Sunday, July 27th

SATURDAY, July 26th, 2024 (Parade Route and Run) (7:00AM to 12:30 PM)

- **Kitsap Mall Boulevard NW**, south side of NW Randall Way to the west side of Silverdale Way, 7:00 AM to 12:30 PM.
- **Silverdale Way NW**, north side of Kitsap Mall Boulevard NW to the south side of NW Anderson Hill Road, 7:15 AM to 12:30 PM.
- **Linder Way NW**, Washington Avenue NW to Silverdale Way NW, 7:00 AM to 12:30 PM.
- **Anderson Hill Road**, NW Bucklin Hill Road to Silverdale Way NW, 7:00 AM to 12:30 PM.
- **Poplars Avenue NW**, Silverdale Way NW to Kitsap Mall Blvd NW, 7:00 AM to 12:30 PM.
- **Silverdale Community Center parking lots and driving lane**, no through traffic in said lot, 6:00 AM until end of parade.
- **NO PARKING** on NW Carlton Street from Silverdale Way NW to Washington Avenue NW, north side 6:00 AM to 10:00 AM.
- **NO PARKING** on Washington Avenue NW north of NW Carlton Street, both sides of the street, 6:00 AM to 10:00 AM.
