Ecology presentation - Recycling Reform Act by Dan Weston (*presentation attached below*)

Caitlin Newman presented Chapter 4 *Recyclables* of the Solid and Hazardous Waste Management Plan (SHWMP) for SWAC discussion and input.

Currently all Kitsap cities and the county have the same list of recyclables.

The recyclables list will be included in the SHWMP, the cities have the choice to adopt the list or not.

SWAC voted unanimously to accept the recyclable list as presented and remove the “draft” status.

Caitlin will continue to present the rest of the chapter at the October 1 meeting.

Caitlin will add a scientific explanation about recyclables.

SWAC comments and questions are welcome.

ROUND TABLE DISCUSSION

Diane Landry – There is a local movement for small scrap metal recycling at the farmers market and senior center on Bainbridge Island. The money collected is donated back to them.

Bob Gilby – In Tucson an individual collects non-recyclable plastic and makes building blocks for homes.

Caitlin – The OVTS compactor project is near completion.

Dan Weston – Dan will send info about glass recycling from Ecology.
