I began working on guardian ad litem cases under both Title 26 and Title 11 from approximately 1997 until I went to work for the Social Security Administration in 2009. I returned to practice in 2023. I did not track the numbers of cases I worked on for the years I practiced in Kitsap County, but I would guesstimate that I worked as a GAL or attorney in dozens of Title 11 cases.

Summary of my knowledge, training and experience in each of the following areas: Needs of impaired elderly people, physical disabilities, mental disabilities, developmental disabilities, substance use disorder; and other areas relevant to the needs of persons subject to guardianship or conservatorship, legal procedure, and the requirements of RCW 11.130.

I have worked with the disabled or poor population since I started practicing in 1992. I was a contract attorney for Evergreen Legal Services, Columbia Legal Services, and later, Northwest Justice Project. I worked on numerous entitlement issues, both state and federal. In my practice, I worked on Americans with Disability Act, Section 504 of the Rehab Act, Medicaid, Medicare, Social Security and Veterans benefits while working with disabled and poor individuals. I also represented individuals in housing evictions or overpayments in both private and subsidized housing settings.

In 2009, I went to work with the Social Security Administration as a program attorney at the Office of the Regional Chief Judge. My workload included being the program attorney covering Regions 8 and 10. I gave legal advice to the Regional Chief Judge, the Administrative Law Judges, hearing offices and others when complicated legal situations arose involving the social security act. I worked on numerous cases subject to federal court orders or remands and it was not uncommon for me to research and brief issues involving drug and alcohol use, mental disabilities and developmental challenges. I also briefed regulations that were at issue in these hearings and researched conflicts between the federal circuits to develop a regional response.


