

3. Number of years' experience as Court Visitor: Accepted to the Kitsap County and Mason County registry effective July 2017.
4. Number of prior appointments as Court Visitor (Guardian ad Litem): Ninety-three (93).
5. Criminal history (as defined in RCW 9.94.A.030): None
6. Knowledge or experience in needs of:

I was a social worker for 16 years. I have extensive experience working as a social worker in the medical field. As a medical social worker, I worked in a variety of settings to include skilled nursing facilities, assisted living, home health, and hospitals. The clients that I worked with were primarily elderly with physical disabilities or some form of dementia. I also have experience providing crisis intervention and assessment to clients with

mental illness. I have some limited experience as a social worker assessing and making referrals for persons with developmental disability.

7. Familiarity and experience with legal procedures involving Guardianships/Conservatorship: I have represented various parties as an attorney in Guardianship/Conservatorship cases and have reviewed and researched Guardianship/Conservatorship statutes.
8. Familiarity and experience in dealing with the provisions of Chapter(s) 11.130 RCW: I have represented Petitioner, Respondent, Guardian, and Notice Parties in Guardianship/Conservatorship cases and have reviewed and researched Court Visitor and Guardianship/ Conservatorship statutes.

I have never been removed as Guardian Ad Litem or Court Visitor. I have had one bar complaint for breach of fiduciary duty while acting as administrator of an estate. The complaint was dismissed on May 30, 2024. Per order of the court, April 15, 2024, no findings of breach of fiduciary duty, Kitsap County Superior Court cause no. 21-4-00145-18.

I successfully completed the model Guardian ad Litem training program on April 6 & 7, 2017, at Seattle, Washington. I completed recertification on April 27, 2018, May 23, 2019, May 25, 2021, May 25, 2022, and May 9, 2023. I completed the Title 11 Court Visitor Recertification Training on May 7, 2024. I will be taking the Title 11 Court Visitor Recertification Training on June 4, 2025.




